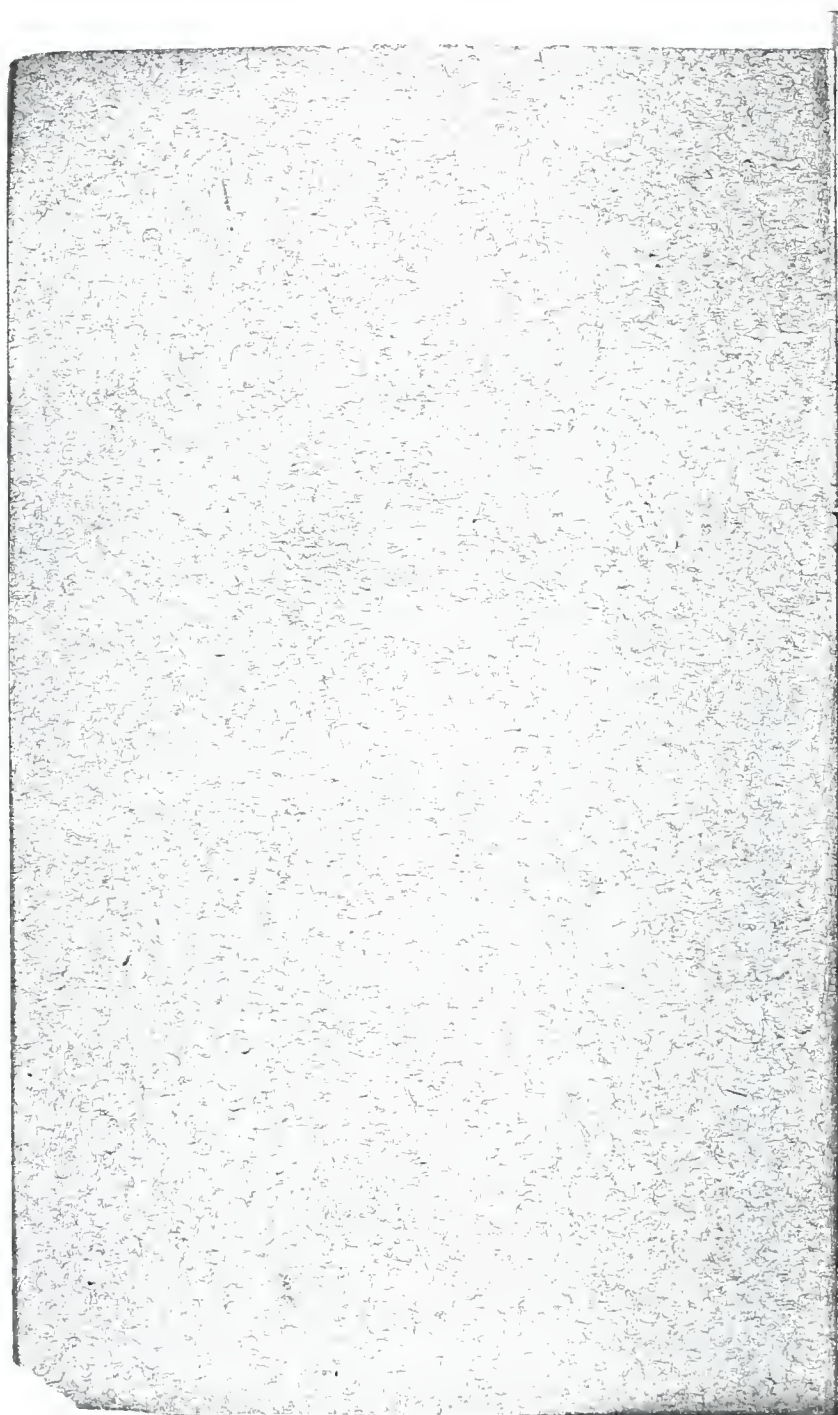

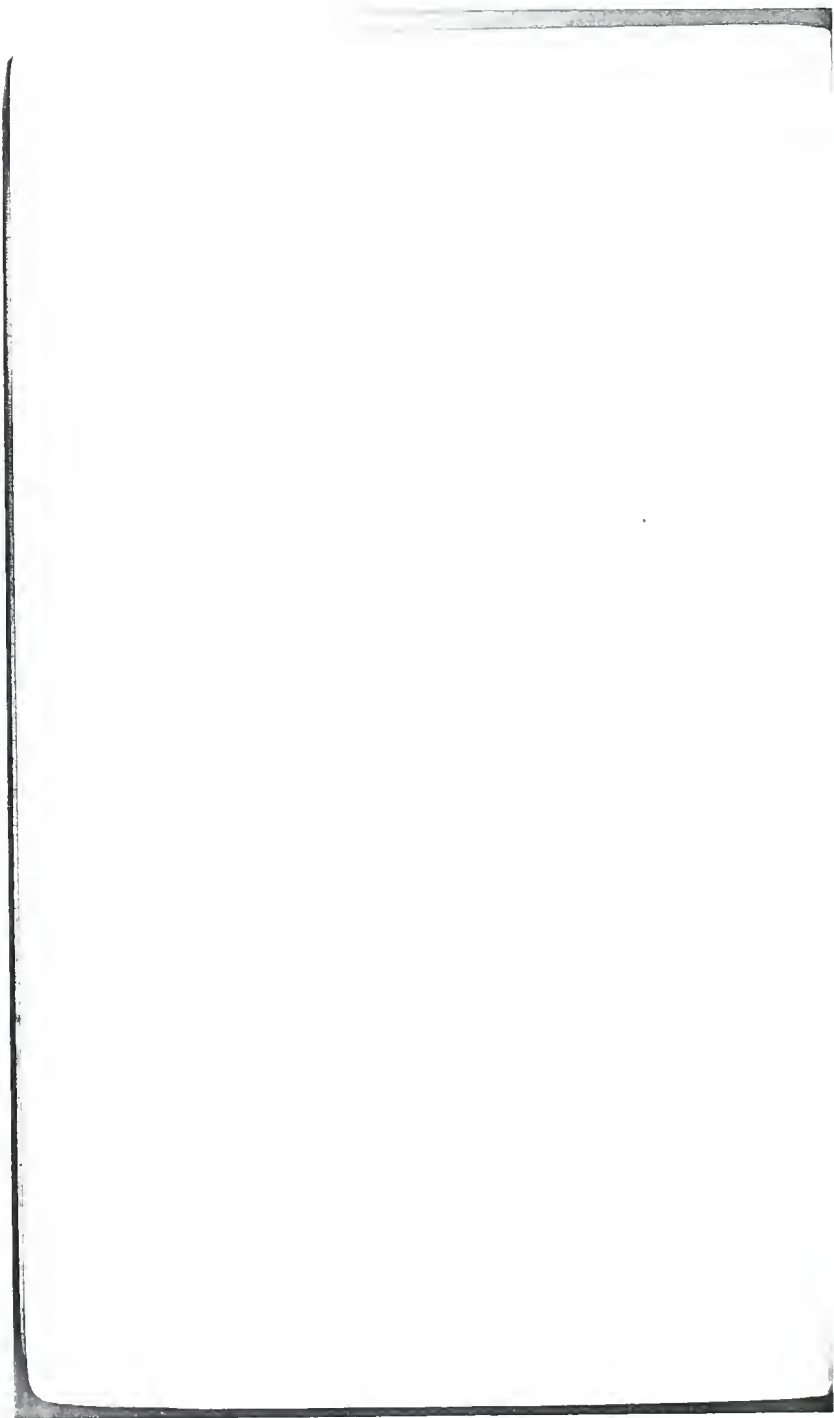

HENRY MOFFETT.

Lived in Lislea, Lisnadill, Co. Armagh, Ireland, married Jane Simpson near Armagh, Ireland.

Their children are William, James, John, Henry, Samuel. Mary, Robert, Elizabeth, Thomas and Agness.

WILLIAM MOFFETT.

William Moffett, first child of Henry and Jane Simpson Moffett, was born at Lislea, Lisnadill, Co. Armagh, Ireland. Went to America in 1785. Was a merchant and disbursing agent for United States Government near Rogersville, Hawkins Co., Tenn. He was a man of influence and means; was disbursing agent of the United States Government Troops stationed in East Tennessee from 1799 to 1802. One of his descendants, viz. John Thomas Moffett at Knoxville, Tenn., has two Bills of Exchange for money paid to William to reimburse him for money paid United States troops in East Tennessee. One is dated Oct. 4, 1799, and signed James McHenry(?) Sec. of War, Philadelphia, Penna. He has also among unpaid bills due William's estate the following:

He was never married. Was a member of the Masonic order and was buried by them at the Bent Creek Church Yard. He died in Jefferson Co., Tennessee, 8:30 p. m., September 3, 1802.

Letter to John Moffett in Ireland on Death of His Brother William in Tennessee.

Irwin Lodge, Sept. 12th, 1802.

Jefferson County, Tenn.

Dear Sir:

I have the Desegreeable News to Inform You of that Your Brother died the 3rd of Sept. Inst. at Half past Eight at night Mr. William Moffett after a short spell

of sickness. his property Cal Rodey, Mr. Charles I. Foster, Mr. Luke Lea, and myself took an Inventory of as soone as Possible. I attended on him in his last Moments as a Physician. I therefore request you to attend as soon as possible the property is very considerable. You will Require to come well prepared with Powers of Attorney from the other Legatees, and Likewise well prepared to prove you being his brother, as nothing can be done otherwise, and might put you to a great dale of unnecessary trouble.

I hav got a larg famely. Now I have 4 sons and 3 doters the ar groing a help to Me and We think iff we ware along with you and my other Two Brothers We think We Woud be Better, for this Contry is Not easy to live in, vitlin is very Deer and treading Bad. so Deear Brother Iff you think your Contry woud answer us Better I wish you Woud rt us soon as this Coms to hand upon a country.

That harvest is the Best time to Make up Mony for I Would kneed a Deal of it as the pasig is so very hie and i hav somany to Pay for, but I think that if you will help in Correg my Mother hir and the rest of the Famely the woud go two and that Wouls Answer Me best upon aCount the Hav a good farm to sell and I think I would not be left behind, fur Tommus got one 3 and when your Father Made his Will he left another 3 to Henry and the other 3 to your Mother and it falls

to Robert and Me at My Mothers Deth and Our sisters the all got Money.

Brother Hamilton and his famely is well, he has one fine sun he is neer 2 years old and I think befor this goes to hand the will hav a nother. I hav a great Deal of pleasur with him and sister Mary and the are in a great Noshing of goeing to your Contry. So Deer Brother Give me Such Derections as you think fit.

My oldest son John was in bad state Health for two years, hut he is deal beter And is fit to Work.

My Mother is Breav and Stout and the rest is well that Bety and Nancy and Henry is in his usel Health I Say.

My Mother is Jus Com in and shee wishes me to let Thomas know that his Mother in law is all right. Robert Maxel is Not Mared yet But is beheaving himself well. Let Samuel No tha his father in law famely is well as Brother Hamilton and me is so Resolved in going.

My Mother thinks the Will not part But Go a long if you think it will Auswer hir for it is hard to live here Now bee it was when you left this.

My famely joins Me in lov to you and Wif and Children and rember us to all My brothers famyles. No Mor at present But remains your loving Brother
James Maffet."

Letter Mrs. James Moffett to GWM; dated July 20, 1909 Lislea, Tallytrove(?), Tassagh, Co. Armagh, (Ireland).

"I would have written you before this only I was ill when I received yr last papers. My husband James Moffett is nine years dead 22nd March last.

I have six children; tw oeldest are left school. Eld-est girl is not at any business yet. second girl has two yrs served to millinery business and has another yr to serve yet. In this country they do not even get their food when serving their time. Four youngest are at school.

Oldest Anna Eliza aged 18 yrs; Ida Martha Moffett aged 16 yrs; Henry (Harry) aged 14 yrs; Euphemia (Effie) aged 13 years; William Watson aged 12 years; Sarah Mary Jane (Mabel) youngest child aged 10 yrs.

My husband's father's name was Henry and his grandfather's name was James Moffett and his mother's name was Martha Moore, maiden name.

My father's name, Wm. Rogers, and my mother's Elizabeth King. My own name Martha E. Rogers; my age 42 years 9th July last.

I had a great mind to go out to America and take all the children out with me. It is very hard to make any money farming in Ireland at present. Servants are very hard to pay and put up with now a days.

I am sorry I cannot tell you more about our forefathers.

Dear Cousin:

Thanks very much for such a lovely letter. It was very kind of you to return good for evil. Mother and us all likes to get a letter from you so much. We all like to hear from America as much as you like to hear from Ireland. Now Mother and all the rest of my Sisters and Brothers want you to pick up courage and come over to Ireland, **please do surely come.** Now this is what I want you to do for me next time you are writing to me, please tell me all about America, I expect we will be all their yet. Thanks very much for picture P. C. and kind invitation. Your Father seems to be quite a young man. I am going to ask you one question, why do you call yourself an old Batchellor of 40, they Batchellors around this country does not call themselves old until they are 70. So what do you think of that. So I think the best thing you can do is to pick up a Young Lady before you come over to this country the rule is here once a man comes up to 40 the are taxed and I would not like to hear of my Cousin coming over to Ireland and getting taxed. All they old Batchellors here are taxed from 40 to an 100. You mentioned George West Moffet and Simpson Moffet in your letter but you did not say in what way you are related to them. You seem to have an idea that none of us are very fond of Uncle Henry but his family seems to be much wiser than their parents were. I will not have the map for you this time but

Mother is on her look out for one but I hope to have one for you next letter I write to you. I would be very pleased if you would be so kind as to send me a copy of my great grand fathers letter. I am sending you Mothers photo. My Sisters and I got our photoes taken about a month ago but they were spoiled. We will get them taken soon again and I will surely send you one. Our Monkey is in very bad temper this last week, his temper troubles him very often. I am sure you know who I mean, our Servant man. Here my Sister Ida and I are writing when all the rest of they family are sound asleep. It is who of she or I will write you the longest letter to you but I doubt she will beat me this time. Now I will be watching for a letter from you soon again and that you have your mind made up to surely come over to Ireland. I am sure you would enjoy yourself well however we would try and make you enjoy your self. Many a time I wonder if it rains as much in America as here, we have had nothing but rain thi slast Fornight and a very severe snow storm before that we have had a very severe winter here anything you want to know about this country just write and ask me and I will be only too glad to write you all I know about this country please remember me to your Father and Sister and I Send both of them my love. My Dear Cousin:

I suppose you are beginning to think by this time that I'm not going to answer your nice long letter but you will see by this that I am. But I hope that you will not think that we don't want you to come over to Ireland for we would only be too pleased to have you and we are looking forward to your coming home.

Many thanks for the pictures which you sent me. it was very kind of you thinking of sending us some, they interest us very much and we are delighted to have them.

I am at Business in Morgan Bros., Scotch St., Armagh. I'm at the Millinery and Sales. I come home every week end. Armagh is our marketing town. It is three Irish miles from our place. We have another Cousin out there now. He will only be a year out in April. He is a Nephew of Mother's. His name is Robert King. He is in Lake Forest Academy, U. S. A. We hear from him pretty often. I wish we all lived a little nearer. But however when you come over to Ireland it will be grand. I would just love to see a Yankee. I am just after reading my sister's letter and see by it that you call yourself an old Batchellor of 40. But keep up your heart where there is life there is hope. In this country they marry away until they are 70. (What do you think of that?) I would like very much if you would send me a few P. Cards to the shop. I love to get either letters or Postcards from America. Do you get many out there? They are a great rage here. I like a good comic one. You will see a few real funny ones when you come over and please Goodness you'll get a few before you come. (That is if you write anyway often.)

Are the Moffett's over there tall. All in this family are very small, not much larger than faries so you may guess the size of us. I think you asked in my

sister's letter about our address. I'm sure you wonder what sort it is. I will explain it to us as best I can. There are three Lislea's. We live in Lislea but when our letters are addressed to Lislea we don't get them for two or three days later than we should get them. We have another farm in Tullybrone that is the reason we get them addressed to it. It is a Townland. Tassagh is a Post Office which our letters come through. Lislea is also a Townland and Armagh is a County and Town. I hope you will be able to understand this, although it will seem hard for you, not knowing the country. But I hope you will soon know it. When do you intend coming over? Is it in May? Please come as soon as ever you can.

I hope you will accept of this very small piece of Shamrock. It is all I could get at present. It is early for it yet. I am not sending you the root, as I always heard that the Shamrock would not grow in American soil, but if you think it would I will only be too glad to send it to you.

Now I think I must bring this letter to a close as it is time I was in Dreamland.

Mother, Harry, Effie, Bill and Mabel all join me in sending you their love.

My dear Cousin:

I feel ashamed of myself. I did not mean to keep you so long. In the first place I will ask you to forgive me this time and I will try and not be guilty again. Thanks very much for your nice letter. I prize it very

much. I would have written to you sooner only I was away a fortnight amongst my friends and had a very pleasant time.

Mother told me to tell you if you take a notion of coming home to Ireland for a holiday, that she and us all will make you hearty welcome. June is the most pleasant time for visitors with us as we have the least to do.

Father died 23rd of March 11 years very soon now. Mother is still living. She is only 42 years last July. Father was 48 when he was married so their was a good difference between Father and Mother. I am an old maid of 19 years. I am the eldest; Ida is 17; Harry is 15 past; Effie is 14 and William is 13, and the Baby will soon be 12, so we are a very happy family, all living together. We keep one servant man and a cross old monkey he is. It is 16 years since he came here first and many a time Mother and I wish we could do without him. He is a Roman Catholic. We go to the Presbyterian Church.

LETTER FROM JOHN T. MOFFETT, KNOXVILLE, TENNESSEE.

Knoxville, Feby. 23, 1910.

Dear Sir: Your kind letter of Feby. 15th to hand and read with much pleasure. Am glad to see you interested in the history of the Clan Moffett. Will assist you so far as I am pable. Wm. Moffett, my great uncle, came into E. Tenn. some where Autumn 1782 to 85, and located at Cheeks X Roads (Hawkins Co.) afterward Jefferson, now Hamblen Co. His home was one mile west at what is known as the Crouch Place (formerly the Shannon Place.) Cheeks X Roads was on the great thoroughfare leading from Virginia on the East and the Carolinas on the Southeast out into Kentucky, by way of Beans Station and Cumberland Gap. From Cheeks X Roads in Jefferson County

where he had his store house to Beans Station in Grainger Co. is about ten miles. The latter was a Great Camping and feeding place for Emigrants going West. Still to the Northwest lay Cumberland Gap the gateway to the dark and bloody ground, Kentucky—the same buffalo and Indian trail that Daniel Boone, the Pioneer, had followed into the Wilderness a few years before. Wm. Moffett no doubt did a large business, and made quite a little fortune. I am of the opinion he died at the Crouch Place. He and my Grandfather John sleep side by side in the long since deserted old graveyard at Bent Creek Church, about eight miles east of Cheeks X Roads. My Grandmother's second husband was Joseph Shannon. He bought out the heirs (my father and Uncle John Simpson) to the Moffett (now Crouch Place). Lived there all his life, raised a family, three sons and one daughter. Was a prominent man in the County, a staunch Presbyterian. A great friend of education. A strong believer in public improvements such as railroads, schools, good roads, etc. He and his wife sleep up on the hill back of the house in Bethesda Churchyard. Just beyond the hill, to the north about a mile, was the home of Samuel Moffett, known in after years as the Boaz place. If I read your letter correctly you are a descendant of Samuel Moffett and his wife Mary. The photo you sent me shows your father, sister and yourself. I infer that you have lost your mother. Is this so? What is your sister's age? I imagine about 19 from the photo.

You say my grandfather was in the French war. What war do you mean? Where did he serve? In what campaign? This information is very interesting to me. I was in the confed army from January 1862 to 1865. Was a member of Lynch's Battery. My Company's first service was at Corinth, Miss., following the battle of Shiloh. From there we fell back to Columbus and finally to Vicksburg, Miss., where we held the Post of honor (the Upper Water battery). We sunk the first Gunboat that attempted to run the gauntlet, and get below the city. The Battery after the surrender at Vicksburg was reorganized and did service in upper E. Tenn. and So. West Va.

under Breckenridge, Jones and Morgan. I left the Battery in 64. Was in Cavalry service with Vaughn Regiment. Was with Morgan at Greeneville, Sept. 4th. Was taken prisoner. Morgan was killed. Was taken to Camp Douglas, Chicago. Left there in March, 65 for exchange. Arrived at Pt. Lookout, Md., about the time Lee surrendered. This broke up the exchange. I remained there until June, when I was released. Went to Baltimore where I remained several months. From there I went to Winchester, Tenn., and opened a dry goods store. After a year moved to Rome, Ga., and went into Goods and Com-business. After a year or two went back to my old home, where I was in business with my father a few years. Came to Knoxville in '79 where I have been with the RailWay Co. for 30 years. I am growing old (75) have raised and educated a large family—My children are all grown. All but one live here. My wife died October 31, 1909. Lost two sons in infancy. Have seven sons and two daughters living. One son and two daughters married. My youngest daughter, Mrs. Mary Armistead, lives with me and is my housekeeper. My eldest daughter Jessie lives near me. I married Sallie C. McDowell of Greeneville, Tenn., December 22, 62. My father, Wm. H. Moffett, married Nancy M. Gillespie of Limestone, Tenn., December 22, 1832. I give you names of the two families.

I enjoyed the letter from our Irish cousin very much. I imagine her a stout rosy-cheeked maiden, with eyes as blue as Erin's skies and hair of auburn, with dimpled cheeks and Cupid lips, full of fun, jolly, warm-hearted, brimming over with native wit. Is there any way we can get her photo? Will send you mine soon. I have told you all I can think of this time—maybe have told too much. Hope to hear from you again.

Can you give me any information of the Moffetts of Armah, back of my Great Great Grandfather, Henry? Where did they come from? I am inclined to think they came from the Dells of Scotland back in the 16th Century, and yet earlier, 13th or 14th Century from France. It is very interesting to trace ones ancestors back into the dim and distant past.

Letter of John T. Moffett, of Knoxville, Tenn., to Lin-
den Byron Moffett, Sec'y Moffett Reunion Ass'n,
Muncie, Ind.; dated July 27, 1909.

"Dear Sir:—Your kind invitation to be present at the gathering of Clan Moffett, at West Side Park, Muncie, Ind., on July 29th to hand. It would afford me great pleasure to attend the Reunion, as I have never met any of my Indiana kin with one exception (Calvin Moffett of Connorsville); I remember a kindness he conferred upon me during the dark days of '61-'65, while I was a prisoner of war at Camp Douglas, Chicago.

I am a lineal descendant of Henry Moffett of Lislea, near Armagh, Ireland.

My grandfather, John, was called to this country in 1802 on account of the death of a brother, William, who had been here for a number of years and had acquired a snug fortune, having been a merchant and disbursing agent for the United States Government near Rogersville, Hawkins Co., Tennessee. A woman named Webster lay claim to the estate, saying she was his legal wife. After a litigation in the court at Rogersville, the estate was turned over to my grandfather (John). He (William) died and was buried at Bent Creek Church Yard, by the Masonic Order of which he was a member. He seems to have been a man of influence and means. He was disbursing agent of the United States Government troops, stationed in East Tennessee from 1799 to 1802. I have two Bills of Exchange for money paid over to William Moffett to reimburse him for money paid United States troops in East Tennessee. One of these Bills bears date Oct. 4,

1799—is signed James McHenry(?) Section of War, Philadelphia, Penna.

Among the unpaid accounts due his (William's) estate I have one reading as follows:

This bill has never been paid. Davy Crockett lived in the neighborhood, often worked for my grandfather. I have heard my grandmother speak of him as a slender, wiry, active young fellow, full of fun and deviltry, and fond of whiskey; he often broke or hackled flax for her.

My grandfather (John) bought a farm near Cheek's Cross Roads, where he lived and died. His widow married Joseph Shannon and lived at the original farm, where they are sleeping. The farm is owned by a man named Crouch, who married a lineal descendant (a daughter of my Uncle John Simpson Moffett).

I have a letter written by my g g father dated January, 1805, addressed to "Capt. John Moffett, Cheeks X Roads, Hawkins Co., Tenn." He writes among other news of the marriage of Robert to Mary Redmond; also writes of Betty and Nancy.

Can you tell me anything of my g. g. father's date of birth and death; can you give me any light on William Moffett, when did he come over? Did he come direct to Tennessee after landing? Would he be glad to have history of the family as far back as can be traced. Who were the brothers and sisters to come over after my grandfather?

My father W. H. Moffett, lived and died at New Market. His only brother, J. Simpson, died at Knoxville. I have two sisters living, Mrs. Emily G. McCorkle, a widow, with no living children, lives at the old home, New Market. My other sister, Mrs. Dr. John G. Earnest, family of one son and five daughters, living in Atlanta, Georgia.

I have lived in Knoxville for 32 years. Have been

agent for Southern Railway Company for 31 years. Am 75 years old. Was in Confederate army from '61 to '65. Was taken prisoner September 4, 1864 at Greeneville, Tenn., with General John H. Morgan, day he was killed. Served two and one-half years in artillery service. My battery captured Vicksburg.

I have a family of seven sons and two daughters.

Have bored you long enough. Hope to have a long letter from you after the Reunion. Tell me all about it. My hand is shaky, you may not be able to read it.

Was given power of attorney to settle the estate of his brother William who had come to America 1785, by his father, Henry Moffett, and the other children, April 19, 1803. This article was approved before David Morrison, Notary Public at New Castle, New Castle Co., Delaware June 14, 1803. After a litigation in the court at Rogersville, Hawkins County, Tenn., the estate of William was turned over to him. A woman named Webster had laid claim to the estate saying she was his legal wife.

DEATH CLAIMS JNO. T. MOFFETT

**End Came at Home on Vine Avenue Thursday Morning.
Was Confederate Veteran and One of the Oldest
Employees of Southern Railway.**

John T. Moffett, veteran ticket agent at the local Southern Railway passenger station, died Thursday morning at his home at 511 West Vine avenue, in his eighty-second year. Mr. Moffett's illness began the day before Christmas from an attack of grippe. For the past week his decline has been gradual, and hope for his recovery was abandoned several days ago. He had always enjoyed robust health, being a man of hardy constitution. Although he was in his eighty-second year, he appeared much younger and was actively engaged until his last illness.

The news that Mr. Moffett has passed away will be received with regret by friends in many parts of the country. Engaged in the passenger business, he came in contact personally with thousands who visited this city, and was probably the most widely known Southern Railway agent in the south. He was thoroughly familiar with the railroad maps of the country, and was always obliging and courteous to those who sought information at his office.

Funeral services will be conducted from the home at 511 West Vine avenue Saturday afternoon at 2:30 o'clock. Rev. Herbert Booth Smith, pastor of Second Presbyterian church, of which the deceased was a member, and Rev. LeRoy G. Henderson, pastor of Fifth avenue Presbyterian church, will officiate. Interment will be in Old Gray cemetery. The following gentlemen will be pall bearers: C. L. Dooley, Capt. S. D. Haun, Capt. R. B. Ragsdale, U. D. Beeler, A. B. Baumann and J. C. Todd.

Sketch of Life.

Mr. Moffett was born in New Market, Tenn., May 31, 1834, the son of Wm. H. and Nancy G. Moffett. His ancestors were among the early Scotch-Irish settlers of East Tennessee. He was in the merchandise business in New Market with his father at the outbreak

of the civil war, when he enlisted in the Confederate army, entering the artillery branch, and was assigned to Col. Vaughn's command. He saw service at Shiloh and Vicksburg and was on recruiting duty at Greeneville when Gen. John D. Morgan was killed. He was captured at Greeneville and brought to Knoxville, and was then taken to Camp Douglass, at Chicago, and later to Point Lookout near Baltimore.

After the war he entered business in Rome, Ga., and later returned to New Market. Mr. Moffett came to Knoxville about thirty-eight years ago, and entered the service of D. B. Loveman & Co., now of Chattanooga, but then located at the corner of Gay street and Church avenue, in the old Barton building. After remaining with Loveman & Co. for a few months, he resigned to enter the service of the E. T., V. & G. Ry. as ticket agent. He was the only man in the ticket office at that time, as only about four trains arrived and departed each day. He continued with the Southern, and has been agent over thirty-six years, and was probably the oldest ticket agent in the United States, in age and continuous service. He has seen service at three depots, the first being the old shed that stood in the middle of the present yards, just west of the Gay street viaduct, the second being the old station that stood on the southwest corner of Gay and Depot, which was the old Atkin hotel, and then at the present station.

He married Sallie C. McDowell, daughter of Col. and Mrs. Jos. P. McDowell, of Greeneville, Tenn., in 1862. His wife died October 1, 1906. The following sons and daughters survive him: John P. and James M. Moffett, of Washington, D. C.; William C., Charles R., Frank H., Hugh and Peter G. Moffett; Mrs. W. B. Whitlow and Mrs. E. D. Armistead, also two grandchildren and two sisters. Mrs. G. E. McCorkle, of New Market, and Mrs. J. G. Earnest, of Atlanta, Ga. He also leaves numerous relatives in Georgia, Alabama and Arkansas. He was a member of the Second Presbyterian church.

During his long service in the local passenger station ticket office, Mr. Moffett has kept his office in the most perfect condition, having everything so arranged as to be of advantage in dispatching the work with

ease. He has often been complimented by the officials on the keeping of his office in fine condition, and it is regarded as one of the best kept offices on the entire Southern system.

News of the death of Mr. Moffett was received in the Washington offices of the Southern Railway with regret yesterday morning, and messages were received by the family from officials in the passenger department.

James M. Moffett, a son, is connected with the general freight offices of the Southern at Washington. He spent several days with his father recently and returned to Washington Monday. He was notified of the death of his father yesterday, and left Washington last night for this city.

LETTER TO EVERETT MOFFETT, MUNCIE, IND.

"Annvale, Keady
Co. Armagh, Ireland.
8th February, 1909.

Dear Sir and Companion.

As Secretary of No. 78 -Masonic Lodge Keady (the only lodge in Keady) I opened your letter of January 8, addressed to Secretary of Chapter 463 R. A. M. Keady and beg to reply to it as follows:

Lislea, Lisnadill, is six miles distant from here, (Keady) and is within two miles of Armagh, not having personal knowledge of the Moffett family, I made inquiries from an old residenter in that neighborhood and learned that Wm. Henry Moffett of Lislea, Lisnadill, is dead over 25 years ago and was about 75 at his death. He left behind him two sons, one of whom, Henry Moffett, is living still at Lisnadill, Armagh, and has a pretty large family, the other son, James Moffett, is dead about nine or ten years. The widow and family of this James Moffett still lives at Lislea, Gissagh, Armagh, in the place that originally belonged to Henry Moffett, Senior. If you wish me to glean any further information, I shall be pleased to do so.

As regards Masonry, Lodge 78, (Craft Masonry) Keady is about 19 years established. We have heard rumors of a lodge in Keady about 100 years ago but have never been able to trace, who of our forefathers were members of it. It is very interesting to us to hear that you have a demit granted by Keady Chapter 463 under date June 12, 1811. If it would not be too much trouble to you, I would feel much obliged, if you would let me know the names of officers signed to it, or better still if in your power, to present to us, (Keady Lodge) this demit which we would frame and hang in our lodge room and prize as an Heir-loom. We have no Royal Arch Chapter in Keady, but several of us belong to one in Armagh, and are thinking of establishing a Chapter in Keady. I think we would .

apply for the old No. 463 which I see by the calendar is lying dormant at present.

Dear Sir:

In answer to your letter of this morning, I am pleased to let you know I am a direct relative of "Henry, the first Moffett of Lislea" who was my great grandfather (James his son) was my grandfather. William, Henry 2nd, John, Samuel, Mary, Robt., Elizabeth, Thomas, Agnes, children of "Henry first Moffett," whose wife's name was Simpson N'r Keady Co. Armagh.

William emigrated to America, also John some years later, after serving in the French war, he was a yeoman. Samuel emigrated also to America. Henry 2nd remained in the old home, died unmarried, leaving his property to his nephew (Henry 3rd) (my father) who also died in Lislea November 1884, at the age of 88. His wife's name was Martha Moore, died January 1889 age of 78. They had three sons. I. Henry, am the eldest, was born December, 1833. William born May 1836. Died from pneumonia August 1869. Also James, born Nov. 1838. Married July 1889. Died March, 1900,

leaving six children, four daughters and two sons, Henry and William Watson Moffett. The farm where I live is adjoining my father's farm in Lislea and is only about 100 perches between the two houses. I was married in 1871 to Jane Simms of Loughgilly Co., Armagh. There were eight children whose names are as follows: Minnie, Martha, Sara Jane, Emily, Lizzie, William Henry, James, John. Sara Jane died young. My wife died April 1908. Emily is married to Robert F. Mackey. Artist Newry. Martha is in business in Londonderry, a Charge cutter and fitter. My father Henry 3rd, had three brothers, namely, Samuel, John and James. John never married. Samuel's wife's name was Dodds, died Intestate. James' wife's name was Fullerton. He emigrated to America about 80 years ago taking two children with them, leaving one son behind with his unmarried brother, John. The child's name John, he is dead two years, died 28th June, 1907, leaving four children, two boys and two girls. One son and daughter live in the home, a Sister is married and has four children. The other son, James, emigrated to America and resides in Canada Watford, Ontario. He is a large farmer. He is married and has a family, I think six children. He comes over to Ireland once in a while. There is still other families of Moffett descendents of Robt., son of Henry 1st. One John Moffett has four children. His brother Robt. has six children, two boys and four girls, the two eldest girls are married.

There are a lot of Moffetts in Ireland. I will try and get some of their addresses and send to you. There was a Solicitor in Dublin, Arthur Moffett, a Professor Moffett, Galway. Moffett, Sligo Draper. I saw his name in the newspaper. There is a Robt. Moffett, in Dungamon, Draper, and near Ballybay I hear nearly every other house is Moffett. I have received letters and a Moffittanna Bulletin from George West Maffet. I have been so ungrateful as to never answer same. I still kept putting off so I just wrote you some things what I could remember. I heard my father talk about nearly all you have mentioned about the Lislea Moffetts. There was a John Moffett that went out to

America. He was married to my father's sister and he had two daughters. They had a Drapery establishment in Armagh. One of the girls died and the other went out to America. I suppose she went to her father. I just got in a hurry at the last moment hoping you will have this little information in time required. I often heard my father speak about his uncles. He says Thos., one of the ten children of Henry of Lislea, sold his farm. he had a small farm adjoining theirs; they bought the holding. I don't remember where Thos. went to. My father says he was a very tall fellow, about 6 ft. 3 inches. We have had a nice dry summer in Ireland for so far this year. We are delighted with same. I am troubled with Rhenmatism. Am 76 years old but save for that I feel as young as ever I did. My hearing is good and I can read the smallest print without glasses. I hope this little information will interest you.

SAMUEL MOFFETT.

Samuel Moffett, fifth child of Henry and Jane Simpson Moffett, was born in Lislea, Lisnadill, County Armagh, Ireland, October 3, 1773. He married Mary Donaldson, May 2, 1801. They went to America in 1803, and settled in Grainger County, Tennessee, near Bean Station, on the Holston River, where they were neighbors to the noted Davy Crockett, with whom they had dealings, as private family papers, in the possession of Simpson Moffett, of Greensboro, Ind., will show. The records show that Samuel Moffitt, (name also borne as Moffet,) served as a Private, of Captain Henry Hunter's Company, 3d, (Johnsons) Regiment, of east Tennessee Militia, war of 1812. His service commenced September 18, 1814, and terminated May 5, 1815. He was not with Jackson at the New Orleans fight, as a great many other Tennesseans were, on account of being quartered at Mobile, Alabama, at the time that battle took place. They lived in Grainger County, Tennessee, until December 7, 1826, when they sold their possessions, loaded their goods

into wagons, and went to Fayette County, Ind., and settled five miles north of Connersville, December 29, 1826, and there lived until his death, August 3, 1848. He was one of the farthest advanced Masons in Indiana, at the time of his going to that State, having joined that Order in the old country. He was often called on for instruction by different Masonic Lodges and gave his assistance in organizing and instructing in the higher work. He was buried on the farm now owned by Nelson Gronendyke, four miles north of Connersville, Ind.. A catalpa tree planted at the head of his grave has grown so much that one can not see from the front, the inscription on his grave-stone but on looking back of the tree, one can read the inscription, "In Memory of Samuel Moffett." They had ten children, James, William, Isaac Lambert George Irvin, Jean, Nancy, Susan, John Franklin, Elizabeth Minerva, Samuel Calvin, and Mary Ann Emmeline.

JOHN DONALDSON.

John Donaldson was born in Scotland, about the year 1755. He went to County Armagh, Ireland. One of his daughters, Mary, born December 25, 1780, married Samuel Moffett, May 2, 1801, died December 23, 1871, at Bourbon, Marshal County, Ind., at the home of her daughter, Jean Moffett Banks.

JAMES MOFFETT.

James Moffett, first child of Samuel and Mary Donaldson Moffett, was born August 12, 1802, in Listea Lisnadill, County Armagh, Ireland. He went to America, 1803, to Grainger County, Tennessee, from there he went to Fayette County, Indiana, December 29, 1826, where he married Margaret Goss, September 8, 1829. He entered a farm in Delaware County, Ind., near Yorktown, now owned by Samuel Coffman (1908). He never moved to it. He had no children and died five miles north of Connersville, Ind., August 29, 1836.

WILLIAM MOFFETT.

William Moffett, second child of Samuel and Mary Donaldson Moffett, was born in Grainger County, Ten-

nessee, November 7, 1804. While clerking in a store in Ft. Jefferson, Dark County, Ohio, he took down a gun to shoot some pigeons, when it was accidentally discharged, the contents entering his head, killing him. He died September 9, 1831. He was never married. He was buried at Ft. Jefferson, Ohio.

ISAAC LAMBERT GEORGE IRVIN MOFFETT.

Isaac Lambert George Irvin Moffett, third child of Samuel and Mary Donaldson Moffett, was born in Grainger County, Tennessee, December 12, 1806, went to Fayette County, Indiana, December 29, 1826. He married Maria McCray, December 13, 1832, entered a farm seven miles south of Muncie, Delaware County, Indiana, in September, 1836. Deed recorded October 15, 1833. They engaged in farming and were very successful. He was honest in all his dealings, and hospitable to the greatest degree. His house was a common stopping place for both "Traveler and Tramp," for food and lodging. He belonged to no Church himself, but never refused to aid any Church by money or work when asked. He was a great reader, especially of history, and was in a general way well informed for the age in which he lived.

He lived on the farm he entered, in Delaware County, Indiana, until his death which occurred after a few days illness, February 5, 1892, at the advanced age of 85 years, 1 month and 25 days. He was buried at the Sunderland cemetery, on the banks of Bell Creek, about one-half mile west of his farm.

They had eleven children, as follows: Mary Elizabeth, Samuel Calvin, Susan Menerva, James Franklin, Sarah Jane, William Henry, Nancy Amanda, Jemima Ann, John Tomlinson, Clarinda Emmaline, and Lambert Irvin.

WELL KNOWN AUCTIONEER CALLED AWAY.

(From Muncie Morning Star, June 30, 1913)

James Franklin Moffett, 73 years old, probably one of the best known auctioneers in Indiana, Ohio and Illinois, and a prominent resident of Delaware County, passed away at the Home Hospital yesterday morning at 9:45 o'clock, following an operation for rupture trouble. The operation was performed early Saturday morning. Mr. Moffett had been ailing for some time.

Mr. Moffett probably was as well known as any man in the county. He was known by nearly every farmer in eastern Indiana. He began auctioneering in 1881 and in 1892 he was considered the leading auctioneer in Indiana. He had probably conducted more live stock sales than any man in the Hoosier state.

Born in Delaware County.

He was born in Delaware County, September 11, 1839, and was the son of the late Isaac Lambert George Irvin and Maria McCray Moffett. On October 10, 1868, he was married to Mary Jane Stewart, the daughter of the late James and Drusilla Reynolds Stewart. To this union were born five children, all of whom are living.

After leaving school and the home place, Mr. Moffett taught school until 1881 when he began auctioneering. In 1881 he moved to Anderson, but removed to Springport in 1887. In 1892 he settled on the home place on the Burlington pike and lived there until Mrs. Moffett was called beyond.

Mr. Moffett was one of Delaware County's dyed-in-the-wool Democrats, he always voting the straight Democratic ticket. He cast his first vote for President for Stephen A. Douglas. He was always active in the campaign, giving both time and money for the cause of Democracy. He also was a great Sunday School worker and always took an active part in the Sabbath School work.

LETTER FROM SAMUEL HAMILTON TO WM. H. MOFFETT.

Newry County Down Ireland,
October 27, 1836.

Dear Cousin

I take the liberty of addressing these lines to you to let you know that I am the young man alluded to (as intending to emigrate to America) in the letter you received from my Aunt Brownlee of the first of May 1835 and to whom you spoke so friendly in your reply of 15th. May -36.

I take the liberty of giving you a little of my history first I am now nearly 26 years of age the Eldest son of your Aunt Hamilton ————— when I was 17 years of age I got my hands hurt by blasting stones so as to lose a part of two of my fingers and thereby unfitting me for manual labor in a certain degree, two years after this I undertook the office of Schoolmaster at which I have continued ever since—I am married some thing more than 4 years and have two fine stout sons—and having had a notion (of a long time) to emigrate to America I therefore resigned my situation at Lurgan 13 miles from my fathers for America and had all preparations nearly ready but my friends being all against my gowing to that country and laying so many cases before me Set me in an unsettled way of thinking I therefore engaged with a gentleman in Newry for to teach his School it is worth 30 L per year Having still the notion to go to America I wish you candidly to state whether you would advise me to go to that place or the Canadies if I go to the brittish settlements (from my interest with the gentlemen of this country I could take with me Testimonials and recommendations that might recommend me to some of the Brittish Gentlemen there) but if you be kind enough to answer this I will in a great

measure depend upon your friendly advice and from your being a man of public business you will be able to give me the perticular details of that country— This is a fine country for the wealthy they are becoming more wealthy and the poor are becoming poor the monopoly of this country are accumulating all to themselves and it hurts the feelings of any poor thinking man to see the transactions of every day—

Let me know the manner of obtaining and settling land in that country, etc.—

Aunt Brownlee lives 30 miles from me & when she received your letter she sent a copy of it to my fathers (who lives about half way between us) in order that I might see it, but when they reed it (they being against my leaving Ireland) detained it untill a short time ago lest it should give me to much encouragement—I am sorry that I did not receive it in time that this could have met you in Baltimore—I expect that my Aunt has wrote to you before this, I have not heard from them for some time but expect that she and husband is well or I would have heard of it— Your Uncle James Moffett and family is well Uncle Robt. & your Uncle Saml Hamilton and family is well and he wishes to be remembered to your Father Mr. Shannon who spoke to him very friendly in a letter he sent my Grandmother about 18 years ago—they all live about 15 miles from me and I have heard from them few days ago—They send their love to you.

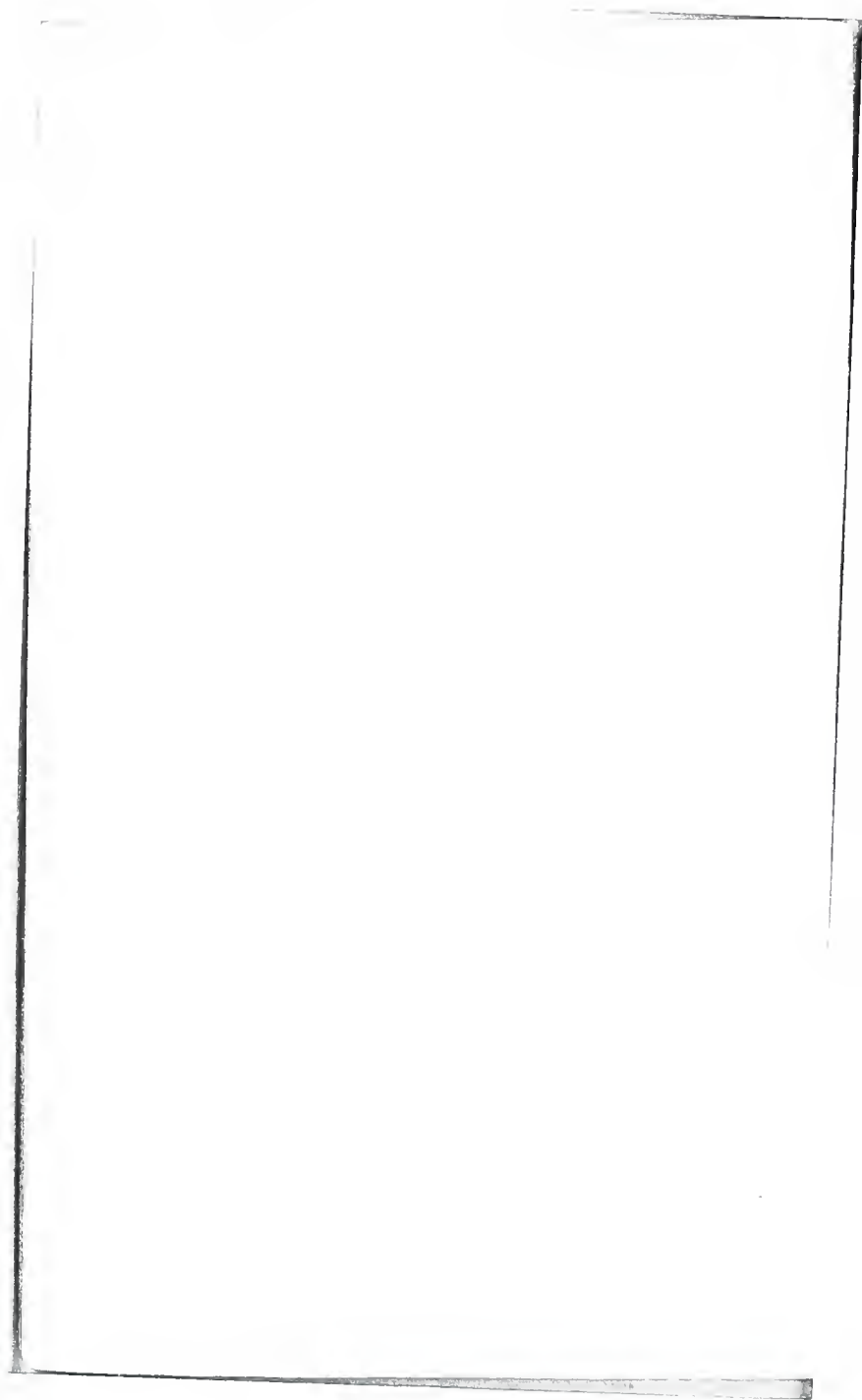

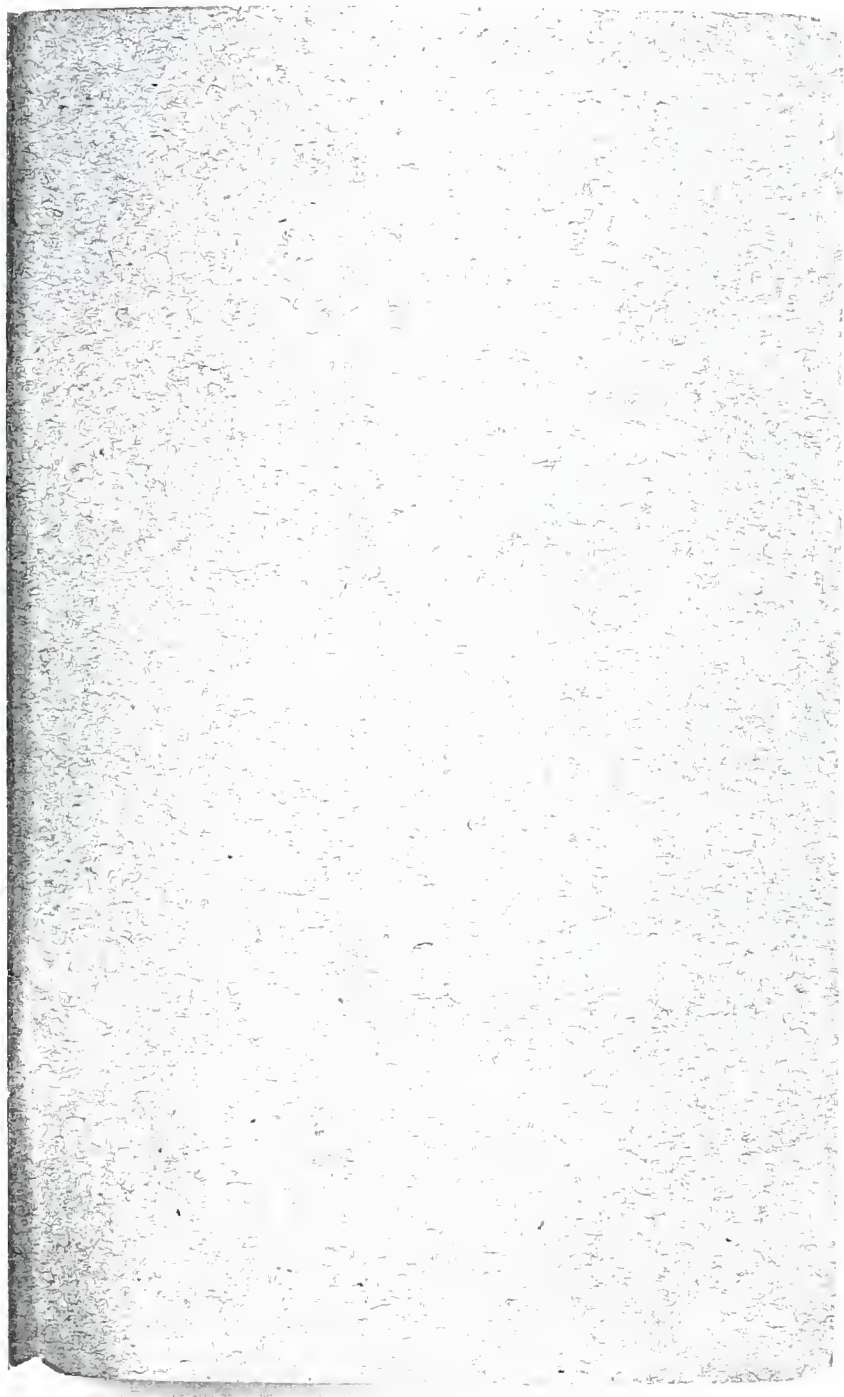
