

Att a general town meeting holden at John Osgood's house 9th 1st 1656, chiefly warned & intended for the entering & recor(?)-/ding of town orders now in force & particular men's grants of land in a new town book, the old being rent and in many places defective & some grants lost.

Imp. It was agreed upon & Voted that the order and agreement made at first planting of this place. VIZ: that all persons should pay to the rates & charges of the town, & church according to their land (which way we have practiced ever since and upon such termes we have granted out lands to all new comers) should be entered in the first place in this new booke.

This above written was disannulled by the major part of votes at a lawful town meeting the 2 of December 1661.



At a general Town Meeting 1th of March 1660.

The Town taking into consideration the great damage that may come to the town by persons living remote from the town upon such lands as were given them for ploughing or planting and so by their hogs & cattle destroy the meadows, adjoining thereunto, have therefore ordered and do hereby order that whosoever inhabitant or other shall build any dwelling house in any part of the Town but upon such house lot or other places granted for that end without express (?)/(This denotes the end of a line in the original. HJS) leave from the town shall forfeit twenty shillings a month for the time he (?)/shall so live in any such prohibited place provided it is not intended to restrain any person from building any shed for himself or cattle that shall be necessary for the plowing of his ground or fencing of his corne but to restrain any from their constant abode there, the town having given houselots to build on to all such as they have received as inhabitants of the town.

At a lawful town meeting the 17 October 1661, it is ordered that every male person of sixteen years and (over?) shall upon three or four days warning by the surveyor attend the mending of the highways upon forfeit of double damages for every day neglect by any person and so likewise every team. That is every man four shillings

a day and every team ten shillings a day so neglected.



Agreed that his other six acre lot shall pay a third part of rates, which is eight shillings the year and further agreed that there shall be street division laid to it and no more. Our meaning is to (?) last till they continue in this way of rating.

At a lawful town meeting the third day of February 1661, it is ordered that all grants of land and meadow, already granted and to be granted shall be entered into that book. Also Edmond Faulkner is chosen to enter these aforesaid grants and to be allowed two shillings of every particular man for his house lot and accommodations provided every man bring in his grants to him within seven years.

Af a lawful town meeting the 17th day of the sixth 1661 whereas there have been different apprehensions between the town of Andover and Mr. Francis Dane about his rights and privileges in the town, it is firmly agreed and ordered and granted on the 17th day of ffebr 1661, that Mr. Dane's lots shall be accounted for an eight-acre houselot and to have all privileges belonging thereto the rights thereof at all times to be taken before the rights of George Abbott Sr. according to the constant order and proceedings of the town. Granted (?) (?) all those aforementioned rights and privileges without exception to have and to hold to him and his heirs forever. This is the true meaning of the town and Mr. Francis Dane whereto the said Francis sets his hand and three of the townsmen in the behalf of the rest of the town of those aforesaid eight acres six acres with all the privileges thereto belonging the inhabitants doe acknowledge rate free during his abode in the commi(?). The other two acres with the privileges according to a two-acre houselot are to pay rates from this time forward, Francis Dane, John Osgood, Edmond Faulkner, Thomas (torn).



At a lawful town meeting the 24 Nov. 1662, granted to Ralph Farnum 30 rod of land at the south end of his lot.

Granted to Andrew Foster eleven acres of land on the east side of the highway and on the southwest side of the land of Timothy Stevens.


Granted to John Ruse three acres of land adjoining to his nine acres by that new field gate, which is for his new field division.

At a lawful town meeting the 28 December 1663, granted to Robert Russell two acres of meadow in a little meadow about half a mile on this side of Richard Earker's Beechen meadow on the left-hand of the cartway.

At a lawful town meeting the ll of February 1663, granted to William Chandler a gore of land on the east (?) side of Shawsheen River, by the old clay pit, whereof two acres is granted him for public charges and if there be above two acres, he is to allow the town for it what they shall so meet and in case, the town shall afterward see occasion to build a mill there, he shall resign to them so much of the convenience of it as shall be judged convenient to set a mill thereon, and allow him so much land elsewhere for it.

Granted to John Frye, Jr., two acres and a half of swamp land at the southwest corner of his lot for public charges past, and four shillings and fourpence now paid already.

Granted to Andrew Foster senior five acres of swamp land for public charges joining to the northeast side of the lot of Andrew Foster, Jr. in case John Lovejoy, Thomas Chandler and Thomas Johnson, who are to lay it out, shall think it convenient for the town and him: whereas he is take it elsewhere. This grant is allowed by this town.



Att a general town meeting 20th Decr 1664, it was ordered and agreed that at any town meeting orderly warned, any seven or more authorized by law to vote shall have power to act and make order (?) and the same to be authentic and valid as if the whole town were assembled and further it is agreed that whoseever shall have legal notice of any town meeting and shall not attend the said meeting (?) at the time and place appointed shall forfeit the sum of (?) to the use of the town for every such default (?) collected by such as the town shall appoint, (?) shall satisfy the town or such as they shall depute that they had inst and necessary cause to be absent and now are to dept without leave of the town till the meeting be dissolved and so declared by the selectmen or the major part of the inhabitants then assembled.

Mr. Bradstreet, John Frye, Sr., Richard Earker, Daniel Poore and Thomas Chandler are chosen selectmen for the year following 65.

Granted to Nathan Parker his swamp land adjoining to the east end of his own land behind the pond being nine acres and a half provided it be swamp (?) land according to order or equivalent thereunto.


Granted to Samuel Martin five acres of swamp land and his street division land adjoining to the land of John Farnum and on which side the lot layers shall see most convenient.

Granted and laid out to Andrew Allen five acres of swamp land adjoining to his houselot and the swamp land of William Chandler bounded on the northwest corner with a white oak, on the southwest corner with a white oak, on the northeast corner with a stake.

Granted to John Frye, Sr., a slip of land between the upper end of

his claypit meadow and the river, as part of his swamp land.

Granted to Marc Graves 16 of upland adjoining to the south end of the land of John Lovejoys and Shawsheen River on the west, which is for his third division. All other former grants thereof be void (?) of that third division of




At a general town meeting the 15th of January 1664, it is ordered that whereas there was the last town meeting an order made that whosoever should not come to town meeting according to day and time appointed after legal notice and at this present day all failing herein except Mr. Bradstreet, Richard Barker, George Abbott, Sr. and John Johnson, were to pay to the town for the use thereof sixpence a man for this present days neglect and from that days forward whosoever shall neglect to come at the day and time appointed after legal notice given him by the constable or his deputy shall forfeit to the Town twelve pence for every such neglect except (?) and the constable is appointed to gather up all such fines and is to have a fourth part for his pains.

Also it is ordered from this day forward that whosever shall not, from year to year, bring into the town or selectmen their public charges due by them before the town rate be made shall (?)ose it.

Given to John Ruse, Jr., half an acre of land adjoining to the south end of his other land by the field gate.

It is agreed by the town for incouradgment that such persons as shall undertake to build a corn and a saw mill shall have liberty to cut timber upon any part of the common provided it is not within two miles of the meeting house, only on the west side of Shawsheen River on any part of the common.

At a general town meeting the 27th of February 1664, granted to William Ballard all the parcel of flaggy or rubbish meadow adjoining to his other land and the pond, which he had of Richard Barker on the west side of Shawsheen River.



At a general town meeting the 27th February 1664 it is ordered that whereas there was formerly a mistake in an order written in the town's book concerning Mr. Dane's yearly maintenance that the Selectmen shall have power to speak with him to the determining of it.

At a general town meeting the 15th January 1665.

Granted to John Frye, Sr. a little parcel of meadow adjoining to his last division, which is the remaining part of the whole meadow.

Sold unto Schuel Blanchard a neck of upland or as much as he shall desire there adjoining to the east end of his crane meadow not exceeding ten acres, he paying after five shilling an acre to the town for it. Granted to him at a town meeting 9th February 68, two acres more to make his ten acres to twelve for all which he is to pay but fifty shillings to the town.

It is ordered that all that have any right or interest in any meadow for the conveniency of fencing of it shall have liberty to fence such corners or necks of land adjoining to it for the running of this fence straight, they paying after five shillings an acre to the town for it. The meaning is so much and no more than is only for running the fence straight and as shall be judged by the lot layers.


Whereas there have been formerly agreements between Mr. Dane and the town concerning his hay that was to be provided for him, it is now mutually agreed between him and the town that instead thereof, he shall have four pounds yearly added to his rate and the other agreements concerning it to be void.

At a general town meeting the 11th of March 1666.

Granted liberty to John Aslett liberty to exchange his twelve acres of land that joins to Stephen Osgood's lot for twelve acres adjoining to his own land on the east side of the pond.

Granted to Christopher Osgood the liberty to take up seven acres and a half of swamp land adjoining to the west side of the land of John Frye, Jr., which was formerly by the town sold to his father, Thomas Rowheel.

Granted to Henry Engalls liberty to take up what land is wanting of the fifteen acres that was granted Nicholas in the new field to take up the remaining part adjoining to his four acres granted to him on the east side of Cochichewick River.




At a general town meeting the 4th of February 1667.
Whereas there was by the town the 15th of January 65 sold unto Samuel Blanchard a parcel of land not exceeding ten acres, he hath at this present meeting accepted of just ten acres for which he is indebted to the town the full and just sum of fifty shillings. Granted to him 9th Feb. 68, two acres more to make it twelve acres for all which he is to pay but fifty shillings to the town.

Granted to Stephen Johnson two rod of land adjoining to his fence and by his saw pit.

At a general town meeting the 10th of January 1669.

Whereas there have been formerly granted to Edward Whitington twenty acres of land behind the pond, it is now granted him liberty he laying it down to the town to take up so much on the west side of Shawsheen River and also to take up ten acres more adjoining to it as part of Mr. Bradstreet's last division.

The twenty acres above is granted upon the same terms as that behind the pond.




At a general towne meetinge the 7 off ffebuearry 1669, Sgt. Henry Ingalls wase chosen constable for this year. Daniell Poor wase chosen grand jury man. John Lovjoy and William Chandler were chosen ffence vewers ffore the southerly parte of the towen. Samuell Martin and Nathan Stevense ffor the northerly parte off the towen and Nathan Parker & John Aslett are ffence vewers ffor the new feeld and Daniel Poor and Gohn Farnam ffor the ffeeld over Shawsheen.

It is ordered that theare shall no rames bee suffered to goe att liberty after the first off Aguste too the ffirst off November upon the street or common, in any parte off the towne upon the penalty off ffive shillings ffor every such rame suffered goeinge att liberty exepeing any Ram that shall acsaidintaly stray ffrom willeam balard & where they are to be kept the finder taking care presently to take him up & secure him shall not be liable to the penalty aforesaid.

Ittem It is agreed and voted that the selectmen with three more joined to them, that is, Nathan Parker and George Abbott Sr. and John Lovejoy shall and are hereby empowered to make sale of a certain parcel of land as they in their discretion shall see meet, not exceeding a hundred pounds for the defraying the charges about the new meeting house, and they have liberty to take in two or three inhabitants if they see cause in the making sale of the aforesaid land.

At a general town meeting the 22 March 69, Thomas Chandler is chosen to carry the vote to Salem.

Granted to Mr. Simon Bradstreet on the south side of Boston Brook 40 acres of land whereof twenty





Sold and granted formerly to William Barker wenty acres of land by Rowley bounds, to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church the sum of ten shillings yearly and the said William Barker is received as a townsman and to have liberty and privilege of the common for feeding cattle and use of wood and timber as his occasions will require.

Sold and granted formerly to Alexander Sessions twenty acres of land by Rowley bounds, to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church, the sum of ten shillings yearly and the said Alexander sessions is received as a townsman and to hath liberty and privilege of the common for feeding cattle and use of wood and timber as his occasions may require.

Granted and sold to Lawrence Lacy twenty acres of land by Rowley bounds to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church the sum of ten shillings yearly and the said Lawrence Lacy is received as a townsman and to have liberty and privilege of the common for feeding cattle and the use of wood and timber as his occasion may require.

Sold and granted to Joseph Parker Junior twenty acres of land by Rowley bounds to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church, the sum of ten shillings yearly and the said Joseph is received as a townsman and to have liberty of the common for feeding cattle and use of wood and timber as his occasions may require.



Sold and granted to John Abbott twenty acres of land between goodman Fosters ground and Joseph Ballards or thereabouts so it prejudice not other men, and to enjoy to him and his bairs forever, paying to the town or Church towards all charges the sum of ten shillings yearly and the said John Abbott is received as a townsman and to have the liberty and privilege of the common for feeding cattle and use of wood and timber as his occasions may require.

Sold or granted to William Blunt or exchanged for a sale of grant he had before over Shawsheen, twenty acres of land in some convenient place near Joseph Ballards and to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church the sum of ten shillings yearly and the said William Blunt is received as a townsman and to have liberty and privilege of the common for feeding cattle and use of wood and timber as his occasion may require.


Granted to Samuel Holt one acre privilege upon the common, he paying four shillings by the year to the town forever.

Sold or granted to Hugh Stone four acres of land near to his other land, not to the prejudice of highways or other men, to enjoy to him and his heirs forever, he paying two shillings by the year to the town forever.


Granted, allowed and voted that the bridge on this side of the sawmill shall from hence forward be counted a town bridge and be made and maintained by the town ingeneres. Only those that last made the bridge are to be excused so many days of themselves and their cattle as they wrought at making that bridge in the common in work that is to come only to each of 2s a day

Sold and granted to Edmond Faulkner twenty acres of land upon the hill next Joseph Robinsons by Rowley line, to enjoy to him and his heirs forever, paying to the town towards all charges and in lieu of all rates to the town or Church, the sum of ten shillings yearly and in case the said Edmond shall at any time put such to lime upon it as the town shall approve, or have no just matter against them, he is to be admitted to be a townsman and to have all the same privilege in the common equal to the other twenty acre grants.

At a general town meeting 9th of January 1670, granted liberty to Mr. Walker and John Haselton to get 15 or 16 thousand of cedar shingle or so many as will cover their meeting house, provided they cut down no trees but take such as are cut down already and so to have them freely.

It is ordered that no man shall have liberty to cut or make any shingles to sell out of town until they have liberty from the selectmen of the town.

Lt. Osgood and John Stevens are chosen to see that the highway towards Salem to be mended and made passable, that lie within our bounds and to be done before the next court to hold at Salem.



Whereas there was formerly granted to Robert Barnard five acres of meadow beyond far woodchuck meadow and by him sold to Mr. Bradstreet, it is now granted liberty to Mr. Bradstreet to lay it down to the town and to take up so much more in any common meadow he can find.

It is ordered concerning Mr. Danes wood: due unto him from the town that all allotments that pay rates to him shall pay and bring in unto him from this day forward, a load for every six acre allotment, and those that have not carried in all for time past, are to carry it into him within a month after this time, or else to pay him after two shillings the load in wheat and Indian corn and so forward for time to come.

Granted to Lt. Osgood thirty acres of land for his swamp division adjoining to his house lot on the north side of the mill river.


Granted liberty to Mr. John Rogers, minister of Ipswich to get so many cedar shingles as will cover his house provided he cut down no trees but take such as is already cut down.

Granted liberty to George Abbott Sr. to exchange part of his last division on the west side of Shawsheen for so much as he shall lay down to the town, to take up so much more for it on the same side of the river where it is to be laid out by John Frye Sr. and Nathan Parker. Also he is to have four acres of swamp land laid out and adjoining to it.

Given to Steven Johnson a gore of land lying on the west side of his swamp land before his house containing about one acre and not to go farther than will bring his farm straight to the corner of John Fryes farm.

Given to John Frye Sr. the side of the hill that lies to the north side of his meadow by the clay pit with a slip of land lying between the meadow and Shawsheen river.

Granted free liberty to Thomas Poor to sell his house and the land belonging to it.



Mr. Bradstreet, John Frye Sr. Richard Barker, John Stevens and Lt. Osgood are chosen selectmen for this year, and to have the same powers as the last year in all respects.

William Chandler is chosen constable and Steven Osgood, grand jury man.

Joseph Marble is received in to be a townsman and to pay four shillings per the year to the town.


At a general town meeting the 2 of March 70, it is ordered and voted that whereas there is now a difference between our town and the town of Woburn concerning the bounds between them and us, the town hath given full power to the selectmen to order and prosecute all means whether by law or otherwise to the ending all such differences and all charges to be borne by the town.

Whereas there have been formerly granted to William Chandler four score acres of land for his last division and lying upon goodman Fosters brook, it is now granted him liberty to exchange about ten acres or so much as may be with convenience and not prejudicial to others, and to take up so much as he lay down at the swamp that is on the left hand of of the way going on to the pine plains.

Granted liberty to Mr. Bradstreet to take up 40 acres of land upon the south side of Boston Brook, whereof 20 acres is for his Shawsheen division and 10 acres for fifty shillings in money paid towards the mill, and the other ten acres in consideration of writing the new town book.

Joshua Woodman is admitted to be a townsman, he paying yearly to the town in rates what is fitting.

Granted to Richard Barker four acres and a half of land below Saunders land and adjoining to a bit of meadow which is for his swamp land.



Granted to Joseph Wilson twenty acres of land where the town shall think best, he paying 10 shillings by the year to the town and to have the same privilege as the other twenty acre lots.

At a general town meeting the first of January 1671, Mr. Bradstreet, Lt. Osgood, Richard Barker, John Stevens and John Frye junior are chosen selectmen for the year ensuing.


Thomas Farnum is chosen grand juryman for the ensuing year.

Whereas there was formerly granted to Edward Whittington, twenty acres of land on the west side of Shawsheen river, he hath now liberty to lay it down and to take up so much on this side of the river about three miles from the town in some place that may not be prejudicial to other men and to have the same privilege as the other grants, he paying ten shillings by the year to the town.

Granted liberty to Steven Johnson to make use of so much old cedar timber that is down as will make twenty thousand of shingles, he paying the town for it.

Sgt. Ingalls is empowered by the town to cause to be brought to Mr. Dane, all his rates and wood and to sue or distrain upon any that shall neglect or be behind.

Granted liberty to Henry Ingalls to lay down his three acres of swamp land at back end of his lot and to take up so much joining to his other land at the pond.




Granted liberty to Joseph Wilson to take up so much of his twenty acres of land that was granted to him as is wanting in that he take up at home provided he come not on the side the old bridge upon the brook, and to take it on both sides of the brook and by Shawsheen river.

Richard Barker, John Frye Jr. Henry Ingalls and Thomas Farnum are chosen surveyers for the year ensuing.

At a general town meeting 6th January 1672, Mr. Bradstreet, Lt. Osgood, kichard Barker, John Stevens and Ensign Chandler are chosen selectmen for the ensuing year.

Steven Johnson is chosen constable and George Abbott Sr. grand juryman for the next ensuing year.

It is ordered and agreed that no man shall have liberty to cut down any cedar tree or trees within the liberty of the town, to sell out of the town without liberty from the selectmen, but shall according to the former order forfeit ten shillings to the town for every tree so cut and sold out of town and also it is ordered that any man shall have liberty to cut out and impound any cedar already cut down by selling it out of town, he or they paying to the town eighteen pence for every thousand so sent out of town and provided that they shall give notice to the selectmen of the town that they may appoint some to view them, otherwise they shall be all forfeit to the town. John Stevens was chosen to view all such shingles and to take an account of them to whom any person shall give notice that have made any shingles to sell out of town.




Also it is ordered and agreed that from this time forward; upon every first Monday in January, there shall be a general town meeting from year to year.

It is also voted and agreed for the better bounding of lands that every man in the town that hath any upland lying in common or unfenced, shall by the last day of May next, get two or three of his next neighbors joining upon him, to run their bounds and to make some plain marker, either by tree or a hole dug in the ground or heap of stone, and whosoever shall neglect so to do shall forfeit five shillings and also five shillings for every months neglect after, and so shall make a return to the selectmen of the bounds, and if bounds can not be found, then so to return it to the selectmen, that so they may appoint some to lay it out again.

Ensign Chandler, Steven John, Richard Barker and Henry Ingalls are chosen surveyers for mending the highways for the ensuing year.

Whereas there was formerly granted to Edward Whittington ten acres of land on the west side of Shawsheen river which was part of Mr. Bradstreets great division upon the right of Robert Barnards, the which Mr. Bradstreet bought of him, it is now granted liberty to the said Edward to lay it down to the town and to take up so much adjoining to his twenty acres on this side of the river and adjoining to the land of Henry Holt.

It is ordered that all last grants of upland and meadow that is brought in under the lot layout man shall be entered in the town book.



At a general town meeting the 3 February 1672, it is agreed that the selectmen shall place all persons in such seats as they see meet.

William Chandler is chosen grand juryman for the ensuing year, ye(-?)

It is ordered that whatsoever dogs be in the meeting house on the Sabbath Day, the owners thereof shall pay six pence for every time being there and George Abbott Jr. is appointed to take notice thereof and to have the pay for his pains and to gather it up.

Granted liberty to Steven Johnson to make ten thousand shingles of cedar already cut down and to dispose of them as he see good and not to pay anything to the town for them.


At a general town meeting the 5 January 1673, Mr. Dudley Bradstreet Lt. Osgood, Richard Barker, Ensign Chandler, John Stevens are chosen selectmen for this ensuing year.

Samuel Martin is chosen constable for this ensuing year.

Steven Johnson is chosen grand juryman for this ensuing year.

It is ordered that if any man shall speak in the town meeting after silence commanded twice by the moderator, shall forfeit twelve pence.

Dudley Bradstreet is chosen clerk of the writs and of the town, and likewise to record all grants laid out on the town books.



Granted to Robert Bardell the fifth January 1677, twenty acres of upland about Bushy Hill and adjoining to Rowley Line, he the said Robert paying ten shillings per anno to the town forever, and not to make sale of the land without the consent of the selectmen of the town.

Granted to Samuel Marble this 5th January 1673 the privilege of being a townsman, he the said Samuel paying four shillings per anno to the town forever for herbage and firewood.

Granted the fifth January 1673 to Lawrence Heart ten acres of upland upon the hill by Thomas Farnum, he the said Lawrence paying five shillings per anno to the town forever and not to make sale of the said land without leave from the selectmen of the town.

Granted the fifth January 1673 liberty to Joseph Ballard to change two acres of upland he formerly bought of the town for ten shillings and laid it on the west side of his land adjoining to his house, and now he hath liberty to lay it on the north end of his said land.

Granted to George Abbott Sr. the 5th January 1673, so much of a parcel of upland by pole hill as the lot layers (viz) Nathan Parker, Daniel Poor, Thomas Johnson shall think sufficient in lieu of three acres of meadow for his last division which he hath not yet taken up.

Granted the 5th of January 1673, liberty to Henry Ingalls to lay down to the town two acres of meadow which he hath in great Wades meadow and to take up the same quantity in the wet meadow.

Granted to William Barker the 5th of January 1673 a parcel of swamp land lying behind his house and half an acre of upland to set a barn upon, the said land to be valued by Sgt. Stevens and Alexander Sessions, and he the said William to pay to the town the tru valuation thereof.

Granted the 5th of January 1673 to Joseph Marble and to Samuel Marble, a parcel of lowland adjoining upon the south side and east end of their meadow they bought of Samuel Martin and to be valued by the lot layers, the said Joseph and Samuel paying the true valuation thereof to the town.

Sold to Hugh Stone the 5th of January 1673, two acres of swamp land lying on the west side of his land and adjoining to his pasture, paying to the town for said land, ten shillings per anno for four years.

Sold to Samuel Frye the 5th of January 1673, five acres of upland adjoining to the land of Benjamin Frye, he the said Samuel paying to the town twenty shillings per acre within the space of three years (viz) the third part of five pounds every year until the whole sum be accomplished.

At a Fown Meeting this second February 1673, it is ordered and voted that if any man shall speak in the town meeting while anything of town affairs is either in voting or agitation after the Moderator hath commanded silence twice, he shall forfeit twelve pence per times and twelve pence shall be levied by the constable, and this order to stand good forever.

John Stevens, Stephen Johnson, George Abbott Sr. and Daniel Poor are chosen surveyors for the year ensuing, and are empowered to call forth ye inhabitants of the town four days within the SD year to be employed in cutting bushes and mending highways for the good and benefit of the town, and at the discretion of ye said surveyers upon the former penalty.

Granted to goodman Ballard Sr. the benefit of a parcel of land lying betwixt Rowell's Folly and the land of John Frie Jr. for a highway to his third division of upland ye SD land leading from the countrey highway to the said Ballards land.


Granted liberty to Edward Whittington to change some part of his twenty acres of land formerly granted him by the town, as Joseph Ballard and Henry Holt shall meet provided it be beneficial to the towne and his neighbors.

Granted liberty to Mr. Dane to lay those three parcels of swamp land (viz) that parcel he bought of Richard Sutton which was 9 and half acres: and that parcel of Mrs. Danes which was 6 acres and 6 acres of his own, which land lieth below goodman Russ his house, he hath now liberty to lay it in a square and Joseph Parker Sr. and Daniel Poor together with Lt. Osgood and goodman Barker Sr. are to lay it out.

Granted to William Ballard Sr. a pine iland lying betwixt Shawsheen River and his meadow and the pond, upon consideration he resigneth up two acres of land, without his fence, by his house and so much within as is necessary for the erecting of a Fulling Mill.

Granted to Edward Whittington and Walter Wright the above said two acres of land laid down by goodman Ballard with 3 acres more adjoining thereto for the encouragement of erecting a Fulling Mill, which they promise to get about ye next Spring.

Granted to Henry Ingalls twenty acres of upland lying betwixt rattlesnake holes and Stephen Osgoods meadow, he the said Henry paying yearly ten shillings to the town and not to prejudice the highway to the meadow lying that way.



Granted to Jno. Russ Jr. liberty to lay his fathers swamp Division which is 4 acres by his own house in some convenient place not prejudicial to the town.

Given to Ralph Farnum 6 acres of upland on one side, or one end of Woodchok Plain and Sgt. Stevens and John Frie Jr. are to lay it out to him.

At a Town meeting on the fourth day January 1674, Richard Barker Sr. with Edmond Faulkner, Daniel Poor, Sgt. Thomas Farnum and john Frie Jr. are chosen selectmen for the year ensuing.

February, John Lovejoy and Nathan Parker are chosen Constables for the year ensuing, and John Barker Grand Jury man.


William Eallard and William Chandler are chosen surveyers for the south end of the town and Serjent ffarntted (?) Dudley Bradstreet for the north end of the town, who have full power to call forth the inhabitants of the town two days this year at any time the surveyers shall think fit.

Granted to John Frie Sen^e this 4 January 1674, liberty to change twelve acres of land adjoining to his house lot and to take up so much by his son Samuel Fries lot which he bought of the town.

Granted to John Johnson to change his last division of upland and to take 4 acres for it and to lay it adjoining the pine swamp and the pople hole between goodman Phelps, his land and the river so as it prejudice not any particular way.

Whereas there is great controversy in the town about the giving out of land, the town therefore have chosen a committee to consider of the same, to see if it be convenient to give away any more land, or how and to whom. They have therefore chosen Dudley Bradstreet 2 Lt. Osgood: 3 Ensign Chandler: 4 goodman Barker — 5 good Frie Sr.: 6 John frie, June, 7: George Abbott Sr.: 8 Daniel Poor: 9 Thomas Johnson: 10 John Lovejoy: 11 Sergt. Stevens to consider about the same and bring in the result against the next meeting day.

Granted to Francis Faulkner the privilege of a townsman upon the account of the land he now enjoyeth, paying for the same as others do, that is, ten shillings for twenty acres.



At a general Fown meeting 1st February 1674/5 it was ordered and agreed by the Fown in general that all those that have upland and meadow now to take up, that they shall lose the same unless they get it layed out by this time twelve months, except the Fown see great reason to the contrary.

It was also ordered and agreed upon that all or any of the Last division of upland and meadow which shall be brought into the Recorder with the bounds and butments attested unto by the lot layers and sealed by them or brought to the recorder by them. They shall be entered in the Town book, they the said lot layers keeping a book of the same bounds.


It is further ordered that once within this three year every man that hath any land lying unfenced either upon other men or by itself shall take one of his neighbors with him and renew the bounds marks and give the same into the selectmen, that so it may hinder future trouble, and whosoever shall fail so to do shall forfeit the sum of five shillings to the Town's use.

Liberty granted to a tanner that shall be allowed of by the Fown to make use of what bark is needful for his work in Fowne provided he fell no trees that are fit for building or rail timber.

It is forther ordered and declared that no man shall have liberty after the first of January 1675 to sell or transport any cedar out of the Town either in shingles or otherwise but shall forfeit twenty shillings for every thousand of shingles or quantity of cedar proportionable unless the Town shall upon some extraordinary occasion grant liberty to the contrary. And he likewise declared that if any man, shall betwixt the date hereof and the first of January 1675, transport any new stuff in shingles or otherwise out of Town, he shall forfeit twenty shillings per thousand to the Town's use, and if any can make it appear that any stranger hath illegally taken out of the bounds any cedar or other timber, he or they making it so appear shall have (illegible) shillings for their pains and trouble.

Granted liberty to Andrew Allen to change six acres of land lying upon the pine plain and to lay it to his land below the plain not prejudicing any highway.

Granted liberty to Richard Barker to lay down fourteen acres of his great division and to take it up nearer the outside of the Town bounds.

Itis also declared and voted that Redding shall be prosecuted (?) at the next Cambridge Court for not mending the highway allowed by the county.

It is likewise declared to be the mind of the town that the countrey road to Obourne (Woburn?) shall lie through William Blunt his land and the land of Joseph Ballard and Sherborn? Wilson and so to come by the house of Andrew Foster Jr and so to John Fries, the town making the above so persons full satisfaction for the same.

Granted liberty to Edward Phelps to change twenty acres of his great division and to take so much by his house lot, not prejudicing any way.

At a general town meeting the 3rd January 1675, Richard Barker, Daniel Poor, Edmond Faulkner, John Stevens and Henry Ingalls are chosen selectmen for the next ensuing year.


Nathaniel Dane and Steven Osgood are chosen constables for the next ensuing year.

Ed Faulkner is chosen town clerk for the next ensuing year.

The 13th November '75.

Laid out to John Johnson on the west side of the Shawsheen river by Thomas Johnson and Daniel Poor and by the poplar hole, 40 acres of land which is for his great division and bounded on the northeast corner with a pine marked; on the southeast corner with a pine marked, on the northwest with tenne little black oaks marked; on the southwest corner with a great black oak marked, which is for his fouerscore acres formerly granted and afterwards exchanged for these 40 acres. Laid out, Thomas Johnson and Daniel Poor.

Whereas it has been formerly ordered that there should be yearly a town meeting the first Monday in February, it is now appointed to be the first Monday in March.

At a general Fown meeting the 6th March 75-76, George Abbott Sr. is chosen Grand Jury man for the next ensuing year.


Granted to Joseph Abbott twenty acres of land either on the adjoining to south side of Rogers Brook and adjoining to Shawsheen river, or else on the west side of the Shawsheen river on the common land and as near as conveniently to the land of Edward Phelps, for which land he is to pay to the town tenn shillings by the year forever, and he to have all the same privileges as the other 20 acre lots have.

Granted to John Marston Jr. 20 acres of land upon the same Fearmes as the rest have and the place to bee allowed by the selectmen which since was agreed to be on the west side of George Abbotts Woodchock meadow.

Granted and laid out to George Abbott Sr. a parcel of land which is in lue of his last division of meadow and adjoining to his great division at the north corner and so bounded with the highway that now is and at the southwest corner with a white oak marked by the swamp and from thence to the mouth of the brook where it run into the river.

Granted to Sgt. John Stevens, Stephen Johnson, Samuel Wardle and Andrew Foster liberty to take up every one as much meadow that will be proportionable to others men if it be to be had. If not then as much swamp as will answer to it, thay proposing theire place first be Proposed to the town to have theire assent which meadow and swamp is to make up this full proportion and soe to pay rates answerable as other men.

Laid out to Samuel Frye upon former liberty of exchanging 17 acres of land at the southside of his other land and east end: 5 acres whereof which he bought of the town, the other 12 exchanged with the town and bounded at the southwest corner with a black oak marked, the southeast corner with a little red oak marked, the northeast corner with a black oak marked on the side of the hill.



At a lawful town meeting the first day of January 1676-7, Lt. John Osgood, Ensign Thomas Chandler, John Frie Jr. Stephen Johnson and Dudley Bradstreet were chosen selectmen for the year ensuing.

Christopher Osgood was chosen Constable for the south part of the town for the year ensuing. Fimothy Johnson was likewise chosen Constable for the north part of the town for the year ensuing.

Sgt. John Stevens was chosen Grand Jury man for the year ensuing, and Dudley Eradstreet was chosen town clerk till another be chosen in his room.


Sgt. John Stevens and Thomas Johnson were chosen surveyers for the year ensuing, the one for the north part of town and the other for the south part etc.

The instructions for the selectmen were that they should manage all prudentials of the town except the disposing of land and timber unless it be for the defraying of charges about the meeting house.

Sold to George Abbott Jr. 9 acres of upland on the north side of Joseph Marble, his land, providing it be not prejudicial to Richard Barker and he to pay for it nine pounds in sweeping the meeting house and ringing the bell at thirty shillings per annum.

Whereas there hath been some difference betwixt the town and some men which had land granted them, they paying to the town ten shillings per annum, the town in general do hereby declare that they were to pay the ten shillings per annum, as the rest of the town pays to the minister. (viz) the one half in wheat and other half in Indian corn, both ones chargable at the usual price it goeth in town from man to man.

Granted to goodman Kemp liberty to move a parcel of swamp land adjoining to Andrew Foster, his land at pole hill. The said Kemp is to have the use of it for seven years, provided he stay in the town so long. If not to throw it up to the town at his departure or at the seven years end, if he stay in town.



Granted and sold to Edward Whittington five acres of upland and swampland adjoining to the north end of his land upon the Indian Plain, he paying twenty shillings per acre and to make payment for ye whole in three years and twelve pence upon the pound till whole be paid. The payment to be made the one half Indian Corn and other half wheat, both merchantable at price current in fown.

Granted to John Preston twenty acres of upland upon the west side of Shawsheen river provided it prejudice no highway, and he is to pay to the fown ten shillings per annu for ever, the one half wheat, the other half Indian corn, both merchantable at price current.

Granted to Zacariah Eires twenty acres of upland upon the pine plain beyond Andrew Fosters, he paying yearly ten shillings to the town, half wheat, the other half Indian corn as above, etc.


Granted to Nicholas Nichols twenty acres of upland near the pine swamp on the way to goodman Holts provided he prejudice not the way to goodman Holts, nor to the said swamp and he is to pay yearly to the town for ever ten shillings, the one half wheat, the other half Indian corn both merchantable at prices current in town.

Dudley Bradstreet was chosen to enter all grants in the great town book, for which he is to have two pence a grant in money or else he is not obliged.

It was ordered that the order made the first of January 1672 about the running the bounds betwixt neighbor and neighbor he in full force and virtue and all are to bring in their returns by the last of May next to the selectmen upon the forfeiture of five shillings for every defect forthwith to be distrained by the constable for the use of the town. Else the Constables are to pay it.

Granted and sold to Samuel Preston three acres of upland on the west side of his lot and adjoining there to, he paying twenty shillings per acre within three years, the one half in wheat, the other half in Indian corn, both merchantable at price current and to pay three shillings a year till the time before mentioned for payment.

Granted liberty to goodman Allen to lay down thirty acres of land upon the Pine Plain, and to take up fifteen acres in the ye leiu of the thirty.



which fifteen acres he shall join to his broken up tand beyond William Elunts land.

Granted liberty to William Barker to lay down his land which lies by Ipswich highway and to take up so much in lieu of it nearer his house.

Granted liberty to John Abbott to lay his land in a long square and also to change two or three acres and lay it on the other side of the way.

Granted libertie to any that will to improve what cedar is fallen down in the swamp next the pond and dispose of it out of town, allowing the town eighteen pence per thousand for all shingles they shall sell as abovesd: provided they fell no trees upon the penalty of ten shillings a tree.

Granted to Andrew Foster Jr. a parcel of swamp land by the pine tree in the way to goodman Ballards for such a part of his division of meadow as the lot layers shall find it by measure.

At a legal general town meeting fifth day of March 1676-7 whereas there was an order made the 18th of January 1664 about the building of a corn and sawmill and then left to a committee to agree with the builders upon what condition the town should have their boards etc. they coming to no agreement, the whole time, this meeting have hereby declared the said act to be void.


Granted to Nathan Stevens twenty acres of upland adjoining upon Rose Meadow Brook, he paying to the town ten shillings per annum, half wheat and half Indian corn forever.

Granted to James Frie, a piece of ground just enough to set a house upon, facing it to the streete and joining his house to his father's lot against the house of Robert Ames.

Granted liberty to Ensign Chandler to lay down a parcel of land at the lower end of his lot and take as much on the back side of his barn, so as not to prejudice the way to the rail swamp.

Granted liberty to Thomas Johnson to change forty acres of his great division and lay on each side of his meadow near pole hill.

Granted to Ephraim Foster twenty acres of upland joining upon Rowley line near Ipswich way, he paying yearly to the town forever ten shillings, the one half wheat, the other half Indian corn.

Granted liberty to John Preston to change his twenty acres which was granted him on the west side of Shawsheen River and to lay it adjoining to hickolas Nichols, his land in the way to goodman Holts providing he prejudice no highway, to meadows or otherwise.

Sold to Nicholas Holt three acres of upland adjoining to the land of his father Holt, he paying twenty shillings an acre half wheat, the other half Indian corn, to pay it in three years and one shilling a year till the whole be paid.

Granted to Ebenezer Barker twenty acres of upland joining to the land of John Aslett near the sandy flats, he paying yearly forever ten shillings to the town, half in wheat and the other half Indian corn, and the said land to join to Rowley line.


At a general lawfull town meeting April the 9th 1677, it was voted and passed by the town, that the selectmen that now are, should prosecute Thomas Fuller of Willhill at the next Salem _____ as a trespasser for cutting down and carrying away a great many cedar trees in the bounds of Andover contrary to the town's order and without their knowledge.

At a general town meeting the 7th day of January 1677, Lt. John Osgood, Ensign Phomas Chandler, Daniel Poor, Stephen Johnson and Dudley Eradstreet were chosen selectmen for the year ensuing. The instructions for the selectmen for the year ensuing were that they should manage all the prodentials of the town according to their best skill, only they are not to dispose of land or timber unless for defraying charges about the meeting house.

Corporal Samuel Martin was chosen Constable for the north end of the Fown for the year ensuing.

Thomas Osgood was chosen Constable for the south end of the town for the year ensuing.

John Marston Sen. is chosen Grand Jury man for the year ensuing. It was voted and passed that a committee of six men should be chosen to join with the selectmen to consider of such things as the selectmen shall inform them of referring to the towns concerns and to advise therein according to their best skill



and also to agree with Fuller and others if they see good cause so to do.

The committee are as followeth: Richard Barker Sene George Abbott, John Frie Jun. Sgt. John Stevens, John Lovejoy Sr. and William Chandler Sr.

Granted liberty to Stephen Johnson to take up some swamp land in the rail swamp by Andrew ffosters land, it being for two acres of his last division of meadow and the lot layers are not to allow above two acres of swamp for one acre of meadow in any swamp.

uranted liberty to Sgt. John Stevens to take up some swamp land instead of meadow, the place being upon mosquito brook betwixt the Ford and John Asletts meadow, the lot layers observing not to allow above two acres of the worst swamp for an acre of meadow.

Granted liberty to John Bridges to take up twenty acres of upland joining to Rowley bounds near to Lt. Osgoods meadow, he paying yearly to the town ten shillings per anu., the one half Indian corn and the other half wheat and when it is inhabited to pay four shillings more for the comanage of his homestead.

At a lawful town meeting the fourth day of March 1677-8 after the Moderator was legally chosen, the town orders were read and are in the selectmen's book.

The town meeting is adjourned till this day seven night of the llst instant.

At a lawful town meeting the 10th of March 1677-8, Lt. Osgood was chosen Moderator and so declared by the Constable. John Faulkner is allowed a Fownsman his father confirming to him upon his twenty acres he had granted him upon the walnut tree hill.


It was voted and passed that those men that have and shall have twenty acres of land granted, paying for the same tenn shillings per anu, shall pay the first year they have.

Granted liberty to Samuel Wardwell to take up as much upland adjoining to the west side of his lot as will balance his divisions of meadow which is, tenn acres. He is not to be allowed above two acres of upland for one of meadow.

Granted liberty to Joshua Woodman to get shingles enough to cover his house not exceeding seven thousand which is to be old stuff and short shingles.

Granted liberty to John Marston Jr. to change his twenty acres of land and lay it on the east side of Bear Hill.

Granted liberty to Samuel Ingalls to lay his land (he had of Robert Eardwell,) a little to one side of the hill it now lies upon.



Sold to John Lovejon Dr. the acres of land adjoining to his land at Shaw-sheen for which he is to pay the next year fourty shillings, ye one half wheat, the other half Indian corn.

Granted to Christopher Osgood twenty acres of land, four on this side of Shawsheen river and remainder over Shawsheen river, to be layed out by Ensign Chandler and Thomas Johnson so as not to prejudice the clay pits or any way to meadows. He is to pay tenn shillings a year to the town in wheat and Indian corn.

Thereas George Abbott, shoemaker stands possesed of a grant of twenty acres of land granted to his brother Joseph Abbott, the town have remitted the first year's payment.

At a lawful town meeting this 6th day of January 1678, Lt. Osgood was chosen Moderator for this present meeting.

John Frie Jr, Richard Earker Sr, William Chandler, John Barker and Christopher Osgood was chosen selectmen for the year ensuing.

John Bridges was chosen Constable for the north end of the town for the year ensuing. Samuel Holt was chosen Constable for the south end of the town for the year ensuing.

Samuel Martin was chosen Grand Jury man for the year ensuing.


Given as a gratuity to the widow Stevens six acres of land at the easterly end of George Abbott's land and on the west side of the way going to Salem, provided it prejudices no highway to any man's land lying thereabouts.

Granted liberty to Thomas Osgood to change five acres of upland upon ye Indian Plaine and to lay it on the west side of the highway to Woburn adjoining to the land of William Chandler.

Sold to Ephraim Stevens two acres of land on the easterly side paying for ye same after the rate of twenty shillings per acre, by this time twelve month, ye one half wheat and the other half Indian corn at the current price.

Sold to Stephen Parker an acre of upland upon the basking plain adjoining to the land he bought of the selectmen, he paying within a twelve month thirty shillings to the town, the one half wheat and the other half Indian corn.

Granted liberty to the selectmen that were the last year, to dispose of some rubbishy lowland to make satisfaction to Sgt. Fuller of Will's Hill for four pounds thirteen shillings and six pence in money which the town owes him, they laying it out as little prejudicial to the town as they well can, and to make returns of what they do to the selectmen that now be.



Granted liberty to modern Lovejoy to alter the way that lies through his land and over his needow, to tay it a little higher, he making a good cart bridge and to clear the way at his own charge.

Granted liberty to Sgt. Stevens to change that eight acres of land which was formerly Thomas Poors and to lay it on the east side of his lot, not prejudicing the way thereabouts.

Granted liberty to Andrew Foster Jr. to take up an acre of swamp land in a round hole by ye way on the right hand going to Hugh Stone's house, the same being for half an acre of his last division of meadow.

Granted liberty to Mr. Faulkner to lay down ten acres of swamp land at the lower end of his new ground and to take up so much near the foard the which land he formerly layed down.

Sold to William Johnson half an acre of land joining to his land that he now hath, he paying within a twelve month to the town ten shillings, one half wheat and the other half Indian corn.

Granted liberty to Ebenezer Barker to change his twenty acres of land which he had of the town and to lay it upon the Huckleberry Plain.


Granted to Daniel Rolf a twenty acre lot on a hill beyond Samuel Holts house, he paying yearly to the town forever ten shillings, the one half wheat, the other half Indian corn.

Granted liberty to Joseph Robinson to change half that land which was Mr. Danes lying in the durty swamp and to take up so much on the easterly end of John Asletts land not prejudicing the way to Eradford.

At a lawful town meeting the 3rd of March 1678-9, Lt. Osgood is chosen Moderator for this present meeting. It was agreed and concluded that all land granted to particular persons in Shawsheen Field, in the Newfield and Cochickawick Field, for the making of fences at the first fencing of the said fields shall be theirs forever and their heirs. Also that parcel of meadow in Shawsheen field is confirmed to the widow Stevens and her heirs forever.

It was declared and voted that no man shall have liberty to cut cedar to transport out of town either in shingles or otherwise after Michaelmas next upon the penalty of forfeiting the same and all that get any betwixt this and that, are to give notice thereof to Sgt. John Stevens by the time before mentioned or else forfeit the value of the same.

'Granted to Mr. Dudley Bradstreet six acres of land adjoining to the highway to the Common Field and so towards Watts, his lot, in consideration of keeping the town records at the town meeting which he promised to do during his abode in the town.



or sted to Mr. Edr na Faul mor two seres of land adjoining to his land which is the new ground which is for ten shillings in money lent the town.

armsted to Mr. Edmond Faulkner six acres adjoining to his land behind the pond is in consideration of his loss sustained by the Indians.

urate to John Farnum six acres of land adjoining to his land by his house, which in consideration of his loss sustained by the Indians.

Granted to Ephraim Stevens that two acres of land which he bought of the town the last town meeting. The town feel cause to give it him in consideration of his loss to last last the Indians.

Granted & given to William Eallard Sr. a small parcel of land of about 50 rods joining to his own land and to Shawsheen River.

Granted liberty to John Abbott to alter the way that lies through his land and to lay it below his land he making a good sufficient cart bridge over the swamp.

Sold to Richard Barker Jr. an acre of land at the head of the Wolf swamp on the couth side of the way, he paying to the town within a twelve month twenty shillings, the one half wheat, the other half Indian corn.

Sold to Samuel Frie an acre of land on the east side of his land by his house, re paying to the town twenty shillings within a twelve month, the one half wheat, the other half Indian corn.

Given and granted to John Russ Jr. in considerations of his loss by the Indians six acres of land, he making return of the place he shall pitch upon the next town meeting.

Granted liberty to goodman Phelps and any that shall join with him to setup a house to Mr. Eradstreets fence, not to exceed sixteen foot from the fence.

Granted liberty to Lt. Osgood to change a nook of land of his street division which is without his fence, and to lay it on the west side of that land he bought of ar. Eradstreet.

At a lawful town meeting the 5th of January 1679, Lt. John Osgood was chosen weeting.


Richard Barker Sr. Deacon Frie, John Barker, William Chandler and Christopher Occood were chosen selectmen for the year ensuing.

Joseph Robinson was chosen Constable for the north end of the town. Josiah Wilson chosen Constable for the south end of the town, both for the year ensuing.

Ralph Farnum was chosen Grand Jury man for the year ensuing.

It was voted that the selectmen for the future shall not have liberty to fell any lead upon no account whatever unless they have farther orders from the town.

Given and granted to John Russ, Jr. six acres of land adjoining to the north part which of Panuel Marble in consideration of the loss he sustained by the Indiana.



Attems lawfull towne meeting the first day of March 1679/80 Ensigne Chandler was chosen moderator for this meeting.

Whereas there was formerly a Committe chosen to settle the bounds of Mark Graves his half moon meadow according to the report made to the towne by Left. Osgood & Serjt. Ingalls, and they failing to doe it, the towne hath made choise of Left: John Osgood, Ensigne Chandler Serjt: Ingalls, Good: Barker Senr: and Good: Poor to se the thing forthwith done and make returne thereof to the select men & to be kept in their booke, tell the sd. Graves shall se cause to have it recorded in the towne Records.

It was voted and passed that whereas serjt: John Peabody of Rowley Village hath trespassed upon the Common by cutting of timber the in towne hath left it to the select men that now are wth mr. Bradstreet & Left: Osgood, to make an agrement wth sd Peabody.

It was voted that the Committe that goes to veiw Good: Graves his meadow shall also take a veiw of what low rubbishy ground was sold to Samuell Martin by the select men that was formerly.

It was voted and passed that the select men should suet Richard Sutton for what rates is due from him to mr: Deane.

Sold to Stephen Osgood two parcells of Land about a quarter of an acre of upland by his house, and three quarters of an acre at the lower end of his lott to make his fence straight, he paying to the Towne twentie shillings in wheat & Indian Corne.

Sold to John Abbott about a qutre. of an acre of land on the east side of his lott, he paying to the towne after the rate of twenty shillings per acre.

Graunted libertie to John Marstone junr: to Carry out of towne about six or seven thousand of shingles which he hath already gott he paying to the towne eighteen pence per thousand for the same to the select men or their order: this present year.



Att a lawfull Fowne Meeting att Andover the 3rd day of January 1680 Left: John Osgood was chosen Moderator for this Meeting.

Capt: Dudley Bradstreet & Left: John Osgood Ensign: Thomas Chandler: Serjnt John Steevens, Sg. Sergnt John Barker were chosen select men for the year ensuing

George Abbott Drummer was chosen Constable for the North end of the Towne for the year ensuing & Joseph Ballard was chosen Constable for the south end of the towne for the year ensuing.

Richard Barker senr: was chosen Grand juryman for the year ensuing.

Att a lawfull towne Meeting this 2nd of february 1680 Ensign: Thomas Chandler was chosen Moderator for this present meeting.



Whereas it was formerly a town orde made for the allowances of 30 for each wolf was killed in the towne, That order is hereby repealed and ** will allowe noe more than what the law specifies.

It was voted that there should be a Committee chosen to agree with Mr: Deane to seat persons in the meeting house.

The Committie Chosen for the work aforesaid was Capt: Bradstreet Ensigne Chandler, Deacon ffrie Good: Barker senr: George Abbott senr:




It was voted and agreed upon that if any person either male or female, shall sitt in any other place in the meeting house then where they are appointed by the aforesaid Committee, shall forfeit for every such offence to the use of the towne 20 * (pence abbreviated? or could it be as much as shillings?) to be forthwith gathered by the Constable, by ordr: fromsd Committe, & if sd Constable faileth to doe, as abovesd, to pay 3d sum himself.

River of Merimake frome the uper end and lower end of the aforesd twenty rods, & the abovesd person(s) with such as they shall joyne with them, are to injoy the abovesd priviledge the ful and just terme of twenty one years, from the first day of May next. the first ten years, they shall have it for nothing, the other eleven years, either to pay to the towne 10d 8? per annum or resigne up their future interest in ye sd place and alsoe they are to sell to any inhabitant, bass at 5d per peice provided those that buy buy two at one time, the partie buying to chose one ye partie selling to choose another and if the partie buying chose rather to pay 3d per peice for *** in money, the owners of sd priviledge shall not refuse the same, provided as abovesd they buy 2 at a time each partie.

Graunted to Richard Barker senr: att the meadow joyning upon fullers line wherein Samuell Martin hath an acre and a half that is to say from the place where Samuell Martin shewed the Left: & good: Poor whereabouts ffullers line came over all which meadow is graunted to Richard Barker in full satisfaction of soe much meadow as he lost by ffullers line. Left: Osgood Ensigne Chandler Serjnt Ingalls Daniel Poor, are desired to goe and mark the trees where the Left: & good Poor shewed us, (?) that Sam Martin told them, that Serjnt ffullers son told him that his fathers line came across as he thought.

It was noted that all swamp Land formerly layd out by ye ose meadow shall not be accounted (rest undeciphered)



Graunted libertie to Stephen Parker upon the account of his fathers right or meadow two acres of swamp land betwixt his owne Land & the <u>hustle berry plaine</u> as he hath gott the lotlayers, already to bound it.

Att a lawfull towne meeting this tenth day of October: 1681 Dudley Bradstreet Left: Osgood Ensigne Chandler Richard Barker senr: John ffrie junr: Serjnt: John Stevens Serjnt: John Barker were chosen as a Committe, and are hereby impowred to dispose of that parsonage Land which was given to Good: Barker senr: & Good: ffrie senr: as ffeofes in trust for the use & behohfe of the ministrie, to change that, or other lands upon the Common, for land and other accommadations for the ministrie, as near the meeting house as they Can Conveniently.

The abovesd Committe are alsoe desired to Consider and act Concerning Mr. Deanes Sallery, either by petitioning the Genll: Court or otherwise as they shall thinke best.

Thomas Osgood is accepted a Townsman paying yearly to the towne four shillings as other four shilling men doe.

Att a Lawfull towne meeting ye 2d of January 1681 Esigne Thomas Chandler was chosen Moderatr: for this meeting.

Capt: Bradstreet, Left: Osgood, Ensigne Chandler, Richard Barker senr: & Deacon ffrie are chosen select men for the year ensuing.

Samuell ffrie is chosen Constable for the year ensuing, for the south end of the towne, & Joseph Steevens for the North end of the towne.

Daniell Poor senr: is chosen grandjuryman for the year ensuing


It was voted and passed that whereas the Committe chosen the last towne meeting had power to dispose of some of the Common for the purchasing of a Convenient place for a ministers house to be built upon,) that act is hereby made voide, and libertie given to the sd Committe, to lay the bounds of the parsonage land farther into the Common, provided they leave as much of sd personage land to the Common, as they take out of the Common.

It was universally voted that the Committe abovesd should give mr Bernard a Call to setle here in Andovr: for the Carrying of the work of the ministrie here amongst us.

Sold to Epraim Steevens four acres of Land of that which was formerly Thomas Poors, and adjoyning to the land of Samuell Martin, he paying to the towne within a twelvementh four pounds, the one half wheat the other half Indian Corne.

Granted libertie to John Tyler to change that twentie acres of land which was granted to John Bridges and to lay it to ye est end of his lot he had of Lawrence Heart and to run ye breadth of his lot only he is to pay to ye Towne five pounds in money to ye Towne & 50d ye next year alsoe sold sd Tyler at ye same time a hole of meadow called bull rush hole for which he is to pay 20d in money psent to time?)



Sold to Hugh Stone tem rods of ground joyning to his hortyard he paying to the towne two shillings and six pence im money.

Att a lawfull meeting of the towne this 6th of March 1681/2 Ensigne Thomas Chandler was

chosen Moderator for this meeting.

Graunted libertie to many man (the Towne or Committe they shall chose) to sett up a saw mill, ffulling mill & grist mill, upon Shawshin River neare Rogers Brooke, to take up twentie acres of Land adjoyning to the sd place and to enjoy the same for ever, with the priviledges of a Townes man.

Capt: Dudley Bradstreet Left: Jno. Osgood Ensigne Thomas Chandler Deacon Jno ffrie, Serjnt: John Steevens are chosen as a committe to act in this affair to make articles with such person, or persons as they shall judge fit and their sd act to be binding to the towne, provided they allowe of now timber to be transported out of towne, in case the inhabitants of the towne shall be ready to buy what is cut at sd mill.

Voted that satisfaction should be made to Thomas Johnson, for what meadow was intended for him, which afterwards proved Daniel Poors senr William Chandler senr: & Joseph Marble are appointed to measure the abovesd meadowe that was left, and measure as much to him in some other meadowe that is Common, and if the meadowe propounded be not enough to have ye rest in

swamp Land.

Voted and passed that the Powne shall give Mr: Barnard fifty pounds per annum, ye on quarter of it in money, the use of the personage, & all his firewood, during the time mr: Deane shall carry on part of the work and when mr: Dean shall cease to carry on part of the work, then Mr. Barnard shall have eighty pounds per annum, one quarter part of in money together with the use of the personage, and all his fire wood during the time he shall carry on the whole work of the ministrie.

Voted that Richard Barker senr: shall take up as much meadowe or swamp Land, as is his due for what he lost in the Beechen meadowe and was to have had in a meadowe of Samuell Martins but is now to take up as abovesd:



Graunted to Goodman Barker Senr: a parcell of swamp Land on the North side of bear hill and soe towards mr: ffaulkners meadowe, for as much as it will amount to towards his meadowe he lost at Beechen meadowe.

Graunted libertie to Samuell Phelps to exchange six acres of upland to take it from the west end of his lot, and to lay it on the south side of his house, William Johnson & John Chandler to lay it out.

Sold to Joseph Steevens about a quarter of an acre of upland between his land and the cart way leading to William Chandlers he paying within a twelvementh for it after the rate of thirty shillings per acre the one half wheat the other half Indian Corne.



Sold to Stephen Parker an acre of Land on the east side of the swamp by his house, betwixt that and the west end of the ware hill, prejudicing noe high way, he paying to the towne by this time twelve month either thirty shillings in Indian Corne & wheat in equall proportion or twenty shillings in money.

Voted & passed that a Committe be chosen and impowred to take notice of what meadowes was layd out joyning upon swamps, and to state the sd bounds as near to sd swamps as can be imagined, their bounds was ever intended, and rather to intrench upon the lowne then upon any mans propertie.

Capt: Bradstreet Left: Osgood, Ensigne Chandler, Good: Poor, Richard Barker Senr: John Lovejoy Nathan Parker, Thomas Johnson, are chosen a Committe to act as abovesd, & their returne, to be accounted authentike, notwithstand any imperfect entry of meadowes as above circumstanced, and the sd bounds which sd Committe returne to be accounted the proper bounds.

Voted and passed, that whereas Mr: Barnard made propositions to the Towne this meeting, for a four acre lott &c: the Towne have agreed, as abovesd to take it into their Consideration, tell the next Towne meeting, and then to returne a full answere.


Att a meeting of the Towne the 5th of March 1682/3 according to Towne orde: Left: Jno: Osgood was chosen moderatr: for this meeting.

It was voted and passed that, the South end of the Towne provide bulls for themselves at their owne charge, and for the North part of the Towne to doe the like.

Capt: Bradstreet was chosen to goe to Ipswich the first day of Ipswich Court there to Consult with, & hear what the Gentlemen of the several Townes betwixt Naumbeage & Memonake, that are to meet there about Mr: Masons claime, have to offer for the good of sd severall Townes, & soe to make report to the Towne.

Whereas the lot layers through a mistake layd out to Goodman Ballard Senr: two acres of Land more then his due, in those percells of land near his house, the Towne hath given him libertie, to enjoy it, for which end he hath throwen up to the Towne, a percell of broken up land of about two acres & a quarter in Shawshin feild, adjoyning to the land which, was formerly John Lovejoys Senr:

Given & graunted to Joshua Woodman (in Consideration of his loss he sustained by the Indians) six acres of land on the North east side of a peice of meadowe of Goodman Phelps; and the south end of Ensigne Chandlers Land he had of John Russ, provided it prejudice noe high way to any man's propietir, as Goodman Poor shall judge being to be one of the lotlayers to lay it out.

Graunted libertie to Samuell Blanchard to take up as much swamp Land on the southeast end of his meadowe, as to make up his last division of meadowe not exceeding the towne ordc: about swamp land, laid out for meadowe.

According to a vote passed the last towne meeting about Mr. Barnards propositions made to the towne, it was put to vote whether the towne or any of them did thinke they were in a Capacity to answere Mr: Barnards requests, which they by this vote declared they were not.

Voted and passed that, the towne shall pay for Mr: Barnards diet soe long as he remaines a single man in the towne, the Towne in the mean time paying of him noe wood & the towne to have the use of the Lott & meadowe in the mean time.

Voted & passed that five pounds of Mr: Deans sallery shall be payd in silver during his abode, in the ministrie.

Voted that Thomas Johnson shall have libertie to take as much swamp land, on the North end of ensig(ne) Chandlers Lot as shall make up that parcell of meadowe graunted to him this time twelve month, as much as Good: Poor tooke from him at the pond meadowe, not exceeding the towne ordc: about swamp Land.

Graunted libertie to James ffrie to stake up the five acres of land graunted him this time twelvemonth, out of the Parsonage Land, to take it on the North side of Musketo River & betwixt the Millers meadowe, & the Wades meadowe way, to have the sd land upon the termes he had the other begining at the same time.



William Barker was chosen, Constable for the North end of the towne for the year ensuing.

Left: Chandler is chosen Constable for the South end of the towne for the year ensuing.

John ffarmum is chosen Grandjurie man for the year ensuing.


Woted and passed that whereas Joseph Steevens was chosen by the select men the last year to sit among the boys & keep orde; among them in the meeting house on the Sabbath Day he naving refused, he is hereby ordered to sit among them for three months to Come or pay twenty shillings to the use of the Towne, to be distrained by the Constable and all persons to be choosen by the select men for the service abovesd, for the future & refusing, must expect the same penalty, & the Select men from year to year are to see meet persons Chosen, & upon default of the persons see chose to issue out their warrants for the gathering the sd penaltie according to this orde:

Graunted libertie to George Abbott Senr: to change an acre or thereabouts of his Land by Ensigne Steevenses, on the north side of sd. Land & lay it on the South side, of sd: Land & Ensigne Steevens & Corpll: Nathan Steevens are the men appointed to Lay it out.

Sold to Richard Barker junr: a frogg pond lying against his house & soe to joyne to his house provided he make a way on the south side of it to the satisfaction of the neighbourhood, he paying to the Towne for it after the rate of 30d (?)* per acre, & Joseph Robinson & Alexande: Sessions are appointed to lay it out. * (probably shillings abbreviated)



Graunted libertie to Henery Ingalls junr: to lay that twenty acres of upland formerly graunted him by the towne, on the hill by Stall: ffries, and to lay if adjoyning, to the Southend and the east side of his fathers Land, not prejudicing any high way.

Sold to Joseph Willson a gore of Land between the Land of John Aslebeee and his owne Land, he paying to the Towne after the rate of 30 (shilling abbreviated)? per acre, in specie formerly mentioned: & Good: Lovejoy Senr: & Hop Tyler are to see it layd out.

Att a lawfull Towne meeting this 3d: Day of March 1683/4 Capt: John Osgood was chosen Moderatr: for this meeting.

Whereas Richard Earker, Senr: lost two acres and an half of meadowe in the Eeechen meadow, by Good: ffuller of Wills hill, the Towne hath graunted him libertie, to take an acre of it in a swamp lying between the Land of Stephen Parker & the land of Stephen Barker, the other acre & half to be taken in the wolf swamp, being layd out according to towne orde: (viz:) not exceeding two acres for one.

Sold to John Graunger two acres of upland in the South side of the way against his house he paying to the Towne for it wthin a twelve month either fourtie Shillings in money or three pounds in pay as the towne debts are to be payd (viz) one half wheat the other half Indian Corne at Country prist. (i.e. priced)

Sold to Samuell Marble a small Gore of Land lying betwixt the South end of his Land and the middle way going over the swamp and soe over the swamp just to stake in the swamp, he Constantly & always maintaining the sd middle way to be Conveniently passable to a teem & paying to the Towne for the sd Land, after the rate of thirty shillings in pay or twenty shillings in money, Capt: Bradstreet & John Aslbee are appointed to lay it out.

Sold to Moses Haggott a parcell of Rubbish ground joyning to his owne Land, not prejudicing any way he paying after the rate of thirty shillings in wheat & Indian Corne in equall proportions or twenty shillings an acre in money, to be payd to the fowne within a twelve month, & John Chandler & ffrancis Deanin are to lay it out.

Graunted libertie to John ffaulkner to lay downe to the Town twelve acres of his Land on the North end of the wallnut tree hill, and to take in leieu of it ten acres adjoyning to the Land of John Marstone June: and ye wolf swamp on ye north side of Ipswich rode,

Voted & passed that Daniell Poor Senr: & Thomas Johnson shall be the only lottlayers in the Towne tell others be chosen, & Nathan Parker is discharged of that place.

Att a lawfull Fawne meeting, the 25th, of April 1684 Capt: John Osgood was chose moderator.

Abraham ffoster was chosen Constable, for the south end of the Towne for the year ensuing:

At a lawful meeting of the town this 5th of January 1684 Capt. John Osgood was chosen moderator for this present meeting. Capt. Bradstreet, Sergeant Barker, Christopher Osgood, Daniel Poor, Sr., and John Marson, Sr., were chosen selectmen for the year ensuing.

John Osgood, Jr., was chosen constable for the north end of the town for the year ensuing, and George Abbott, Jr., was chosen constable for the south end of the town for the year ensuing.


Corpll. John Chandler was chosen grand juryman for the year ensuing.

It was voted and passed that whatsoever person in the town hath sold any meadow to out town people, shall by the first Monday in March next give an account of sd quantity of meadow so sold and the persons to whom it was sold, or pay, to the town for default hereof the sum of five shillings, the aforsd account to be given to the selectmen for the time being and the said selectmen upon as aforsd are hereby ordered to gather the sd five shillings with the rest of the Town rates & this order to continue from year to year as men shall sell meadow.

It was voted and declared that all persons who have meadow ajoining to any swamps shall give them in writing to Capt. Bradstreet by the first day of Feb. next, upon the forfiture of ten shillings to the Town, to be gathered by the Selectmen with the Town rates. The occasion of sd vote was that the committee appointed in the year (82) may settle such bounds according to the Town order in the abovesd order in (82).

At a lawful town meeting this 2d March 1684/5 Capt. John Osgood was chosen moderator for this meeting. It was voted & passed that whosoever shall fall any tree or trees across any public or private cart way, and left the same lay there twenty four hours shall forfeit for every such offense five shillings to the use of the Town to be gathered by the constable, by warrant from the selectmen any person complaining to the selectmen & making proof of the same.

It was voted and passed that all those that had land sold them by the town the last year shall get it layed out within this two months and to make a return of the same to the selectmen by the time appointed or shall forfeit five shillings to the town and their grant. It was also voted at the same time, that for the future what land shall be sold to any person by the town shall have it layed out within the year and returned to the selectmen upon the forfeiture of 10 shillings.



It was voted and passed that the selectmen that now are shall agree with John Grainger to build a convenient court yard for the parsonage house and to pay him out of a parcel of land on the west side of Shawshin river, lying between the land of Francis Faulkner and Daniel Poor, Sen.

Granted liberty to Samuel Marble to change so much land on the upper side of the way by his house as he shall take in to his lower hoptyard on that side of the way and Capt. Bradstreet and Ensign Stevens are to see it done.

Granted liberty to Ephraim Stevens to lay down that two acres of land the town gave said Stevens, and to take up so much in the swamp that runs to Job's Folly, not perjudicing any person or way, and Corporal Martin and John Aslebee are to lay it out. Granted liberty to Ralph Farnum, Sen., to lay down forty acres of his great division and to take up thirty acres in the lieu of it upon the hill by Samuel Holt's, he leaving a road betwixt Goodman Holt's land and the land he takes up.

Sold to Jacob Marston twenty acres of upland on the south side of the way against the place where Joseph Parker, Jun., had a house standing, he the said Jacob paying to the town five pounds per annum for six years from the date hereof, the one half English, the other half Indian corn.


Sold to Timothy Aboutt twenty rods of land adjoining to the twenty acres of land formerly granted to Edward Whittington, he the said Timothy paying to the town two shillings and six pence in money. Joseph Ballard and William Blunt to lay it out.

Granted liberty to Goodman Russell to lay down ten or twelve acres of upland on the west side of his land and lay so much on the southeast of his land not perjudicing any highway.

Granted to George Abbott 8 or ten rods by his well provided he pay the town after the rate the town sells land. Joseph and John Ballard to lay it out.

Granted liberty to Lt. Chandler to take as much swamp land adjoining to the land he purchased of William Johnson as will satisfy according to town order for three quarters of an acre of meadow for his last division.

Granted to Sgt. Johnson liberty to take up a parcel of swamp according to town order as much as will satisfy for half an acre of meadow on the south side of his pasture before his house.



Voted and passed that for the future the selectmen shall from year to year make the ministers rate sometime in September. that so the constable may gather the English part may be gathered in October and the Indian Corn part as soon as it is merchantable.

It is ordered that the selectmen shall take care to make a new fence on the west side of Mr. Dean's pasture against those he adjoins to

The above said vote was not consented to:

It was voted afterwards that the selectmen shall fence the west side of Mr. Dean's pasture by his house, only to set it up new but not to maintain it.

Voted that Ensign John Stevens and John Aslebee shall have the improvement of twelve acres of land, for seven years from the date hereof the said land lying upon Bear Hill, and to leave it in English Stubble and to sow it well and sufficiently with English hay seed at the of the said term and to make use of no other timber or brush for the fencing of it but what now grows upon the ground they are to improve.

Granted to Ebenezer Barker two acres of upland adjoining to his land on the west side of Shawshin River which was part his father's great division, and is in consideration of damage he received in his pay from the town for building the parsonage house.


Granted liberty to Stephen Osgood to improve a parcel of land adjeining to the end of his lot, for seven years and at the end of seven years to leave it in English stubble and to sow it the last year well and sufficiently with English hay seed and to improve no other stuff for the fencing of it but what grows upon the said land. Lt. Chandler and Walter Wright to take an account of it.

At a lawful town meeting this 4th day of January 1685, Ensign John Stevens was chosen moderator for this meeting.

Capt. Dudley Bradstreet, Capt. John Osgood, Lt. Chandler, Ensign John Stevens and Corporal Samuel Martin were chosen for the selectmen for the year ensuing.

Corporal Nathan Stevens was chosen constable for the north end of the town for the year ensuing. James Frie was chosen constable for the south end of the town for the year ensuing.

Corporal Samuel Holt was chosen grandjury man for the year ensuing.



Sold to John Carleton twenty acres of upland lying betwixt the land of Samuel Frie and Henry Ingalls, Jr. his land leaving a sufficient road for cattle and carting betwixt said lands. He the said Carleton paying yearly to the town five pounds in good merchantable corn the one half English, the other half Indian, till he shall have paid thirty pounds, beginning the year from this present meeting.

Granted liberty to Henry Ingalls, Jr., to set up a sawmill upon Mustletoe river below Boston meadow way, he damnifying no highway to meadows, but no liberty given to make use of any town timber but what particular inhabitants of the town, bring for their own use, to be used in the town.

Voted and passed that the selectmen for this year shall have power to sue all constables or any others indebted to the town, ratifying and confirming hereby their act herein and also to manage all prudentials of the town as it here mentioned.

Granted liberty to Henry Holt to set a sawmill upon Ladle meadow brook provided he sell no timber out of town, nor to damnify any persons nor road.

Sold to John Bridges about two or three acres of upland or what shall appear to be there to his content, lying on the north side of ten acre meadow provided he pay to the town thirty shillings per acre, in such pay as the town sells land for, within this twelve months and also he is to allow Capt. Bradstreet a convenient cart way to that part of his meadow, and not to live upon said land himself nor suffer any so to do.

This he threw up to the town again.

Voted and passed that the way that goes by Samuell Blanchard his house, and hath done for many years, shall yet be continued a way for inhabitants to go to Keyinesi'k and Chelmsford — and for inhabitants to come to the town, but not to be reparable by the town.

Sold to Sgt. John Barker about half an acre of upland or what shall be convenient for him joining to his father Barker his house lot, not prejudicing the way to the mill, he paying for it as land is usually sold (viz:) thirty shillings per acre.

Voted and passed that Joseph Ballard and John Abbott Senr. shall measure the country road through Abraham Foster his land and meadow, and to allow it two rods wide and lay so much to him adjoining to the same tract of land, either upone one side or one end so as to run the length or bredth of his said land.

Sold to Joseph Stevens an acre of swampy land lying on the southeast side of Ephraim Stevens his land, which was formerly in the possession of Thomas Poor, he paying to the town thirty shilling 20d. of which he hath already paid in 2 wolves which he catch in since the rate was made, and the other ten shillings to be paid out of the next wolf he catches.

Lt. Chandler was chosen for a lotlayer for this year to serve with Thomas Johnson, in the time of Goodman Poor his sickness, or till the town take further order.

Sold to Joseph Robinson ten acres of upland adjoining to the land he formerly changed upon Mr. Dean his account, leaving a good highway there and paying to the town thirty shillings per acre, in specie, as land is sold by the town for, the paying five pounds per annum till the whole be paid beginning from the date hereof.

Whereas Robert Grey had formerly a grant of ten acres of upland upon condition he paid ten pounds to the town in such a time as is there mentioned, the said Robert Grey came into this meeting and did freely resign up the said land to the town again, which the town hath accepted of. Sold to James Frie half an acre of swamp adjoining to his piece of meadow he hath in a meadow called millers meadow, he paying of fifteen shillings in English and Indian corn, good and merchantable, within this twelve month.

At a lawful town meeting this 1st of March 1685/6 Capt. John Osgood was chosen moderator for this meeting.


Sold to Ephraim Stevens a parcel of swamp near the ground he formerly bought of the town containing about two acres or what shall appear by measure, for thirty shillings per acre, the one half English, the other half Indian corn, to be paid by this time twelve months, he observing the town order for laying it out.

Granted liberty to Moses Haggett, to take up what land formerly sold him by the town which he forfeited by not observing the town order therein, and he is to pay 5d to the town, for this renewal of his grant, and for his land as formerly it was sold him.

Granted liberty to the Widow Abbott, the relict of George Abbott, Sr., to call forth the lotlayers and to new lay the said Abbot's great division of upland with four acres of swampland, according to a former order of the town, it having been formerly laid out and returned imperfectly so that it could not be entered in the records.

Granted liberty to Samuel Marble liberty to exchange a parcel of land he hath lying on the west end of Stephen Barnard's land he the said Barnard bought of said Marble, and to lay out so much on the south west side of a parcel of ground the town gave to Joshua Woodman for his loss he sustained by the Indians.

Sols to Samuell Preston an acre of swamp land lying on the left hand of the way leading to John Abbott's, he paying according to a town order: Thirty shillings in English and Indian corn at the current price, it lying in the meantime as security to the town for the payment thereof.



Voted and passed that the committee that was chosen in the year (82) shall still continue in force, and hereby are obliged to go about the business relating to meadows, and to make return of what they have done the next town meeting the town paying them for their time.

Voted and passed that the major part of the selectmen for the time being and from time to time shall be a committee for the ordering where each person male and female shall sit in the meeting house, by male and female is meant from 18 or 20 years old and upward and persons that are disobedient to this order shall pay ten shillings per diem for their disorder.

Voted and passed that the constable from year to year shall the last Monday in August at nine of the clock in the morning call all the inhabitants of the town by name (by inhabitants is meant all householders and persons that have the management of any estate and hired servants) and if any such person shall not then appear at the meeting house and bring the bills of their rateable estates, they shall pay five shillings to the use of the town the selectmen making the constable a reasonable allowance for his care and pains.

At a town meeting of the town lawfully assembled this 11th of October 1686.


Lieut. Thomas Chandler was chosen moderator for this meeting.

Voted and passed that the town will give Mr. Barnard some land for his own inheritance.

Voted and passed that Mr. Barnard shall have the land which is between the way leading to Shawshin field and the way leading to Cochichawick field and northerly to the line where the Common fence formerly stood.

Voted and passed that Mr. Barnard shall also have three score acres of land out of that four score acres of land which was John Johnson's great division, and liberty given to him the said Johnson to change it for another place as appears upon record, and Lieut. Chandler and Goodman Poor and Thomas Johnson to lay it out.

Voted that those that catch wolves in the town of Andover and act therein as the former law of the country did direct, shall have ten shillings for each wolf, to be paid by the town unless the authority of the country take some other order about such things.



At a lawful town meeting this 3rd day of January 1686

Capt. John Osgood was chosen moderator for this meeting.

Capt. John Osgood, Richard Barker, Sr., Daniel Poor, Sr., Stephen Osgood and Christopher Osgood are chosen selectmen for the year ensuing.

Francis Faulkner is chosen constable for the north end of the town for the year ensuing.

John Chandler was chosen constable for the south end of the town for the year ensuing.

Voted that Richard Barker Sr., shall have a parcel of meadow in Wades meadow, on the easterly side of Ensign Stevens his meadow, being bounded with the Cedar swamp and the upland it being in full satisfaction for a high way for the inhabitants of Andover over his the said Barker's Wades meadow and the grant in the year (79 - 80) is hereby made void.

Voted and passed that for the future the town shall change no land with any man, but with the consent of eveny inhabitant of the town; they having sufficiently experienced the damage thereby, already.

Voted that Mr. Barnard's wood shall be paid in long wood and to be proportioned as the town shall afterwards agree.


Voted and passed that the selectmen for this year shall be a committee for this year for the proportioning of each man's share of wood to be paid to Mr. Barnard according to every man's rate for this year which they are forthwith to do, and to signify to the inhabitants.

At a town meeting this 7th of March, 1686/7

Capt. John Osgood was chosen moderator for this meeting.

Voted and passed that Deacon John Frie shall go down to Boston and inquire of the authority there how they understand the meaning of their proclamation about the selectmen and constables continuing in place till farther order: informing them of our actions herein and to make report to Capt. Osgood, who shall inform the town thereof.

Voted and passed that the hill called the Ware Hill beginning on the north with the land of Stephen Barker and Stephen Parker and going southerly to the land of Henry Ingalls Sr., and the lands and meadows already laid out and westerly with land already laid out said hill to remain for (torn) sheep pasture forever the wood and timber for the inhabitants.



Voted and passed that a tract of common land lying betwixt the land of Christopher Osgood and the land of John Changler and so between that way and the farther clay pit meadow shall always lie as a sheep common not prejudicing any way.

Voted and passed that a parcel of land lying between the land of William Ballard, Sr., and the pond called Ballard's pond and so to the end of the pine plain, and so between the land of Joseph Ballard, Hugh Stone and William Blunt, and so to John Abbott shall for ever lie for a sheep pasture.

Voted and passed that all the common land betwixt the land of Stephen Johnson, Andrew Foster, Joseph Lovejoy and so to Lt. Chandler's land, shall always lie for a sheep common the abovesaid sheep commons being free for all commoners both for fire wood, timber and the feed of other cattle, horses or otherwise, but not for others.


Voted and passed that no fish called alewives shall be stopped by any person whatsoever in their going up into the pond, but what shall be caught at the mill in their passage except for eating in their families upon the forfeiture of five pounds, and said person to be suable that shall so do, by any that finds themselves aggrieved.

Voted and passed that the act about the way going through Goodman Blanchard's land made the 4th of January, 1685 shall be of no value, it being done upon wrong information.

Voted that whereas a way was allowed through the land of Goodman Lovejoy and Samuel Blanchard they have chosen mutually and the town allowed of Capt. Osgood, Lt. Chandler, Ens. Stevens and Cpl. John Chandler, and Deacon Frie to be a committee lay the way through said land; and to do it by the last of this instant March and the town to be at no charge about it.

Sold Stephen Barker an acre of land adjoining to the land of said Stephen, he paying after the rate of thirty shillings per acre according as we formerly sold land.

Sold to Ephraim Foster a parcel of land at the northeast corner of said Foster's land he paying according to former usage (viz.) thirty shillings per acre.



Andover the 2d day of January, 1687: at a lawful town meeting there according to town agreement

Capt. John was chosen moderator for this meeting.

Capt. John Osgood, Daniel Poor Sr., Christopher Osgood, John Aslebee and Joseph Eallard are chosen selectmen for the year ensuing.

Stephen Parker was chosen constable for the north end of the town for the year ensuing and Samuell Blanchard was chosen constable for the south end of the town for the year ensuing.

Granted to Sgt. Samuel Martin two acres of land in the wolf swamp adjoining to the land that is now in in the possession of Samuell Marble, it being in consideration of an acre of meadow he lost by Sgt. Fuller's lines he laying it in a long square.

Voted and passed that whereas William Barker hath got the lotlayers to lay out a parcel of land that lies betwixt his own house, Sgt. Earker's house and Lawrence Lacy his land and the land of Alexander Sessions, the town declares that act void and confirmes the said land to the neighborhood for a sheep common for ever.

Voted and passed that the town will allow such encouragement both of wood land and mine toward the setting up of iron works as may be most convenient for the same and least of judicial to the town and not to damnify the mill upon Shawshein river provided the owners agree with the committee according to the town order. The sawmill in said order excepted.

Granted liberty to Robert Eimes Moses Tyler & the neighborhood thereabouts to set up a house for their convenience for their families and horses on sabbath days to join to the south end of Goodman Phelps his house and so ranging with Capt. Eradstreet his line...

Granted liberty to Hope Tyler to set up a shop in the street near his house, provided he exceeds not fourteen foot from the wall nor about two and twenty foot in length.

At a lawful town meeting May the 21st 1688



Voted that the number of selectmen from time to time shall be six.

Capt. Bradstreet, Capt. Osgood, Lt. John Stevens, Christopher Osgood, Cpl. John Aslebee, and Cpl. Joseph Ballard, are chosen selectmen for the year ensuing.

Capt. Thomas Chandler was chosen commissioner for this year.

Stephen Parker was chosen constable for the north end of the town for the resuing. Samuel Blanchard was chosen constable for the south end of the town.



Voted and passed that there shall be an addition made to the meeting house as soon as conveniently can be done, the selectmen to observe the law about it, the addition to be for eigness as the selectmen think meet.

Upon consideration that there was a small corner of land on the north side of Joseph ovejoy's land, which is no ways beneficial to the sheep common there granted as the neighborized informs, the town have therefore sold the said Joseph Lovejoy two acres of said land on the north side of his own land he paying thirty shillings per acre in specie as usual.

Whereas: Abraham Moor hath irregularly set his house upon the common, the town with his m consent hath fined him ten shillings and also sold him an acre of land where his house now stands he paying to the town within a twelvementh thirty shillings for it in specie usual.

At a general town meeting the 20th day of May 1689

Capt. John Osgood was chosen moderator.

It was voted and declared by the inhabitants of the town of Andover no man dissenting, that it is their mind and desire that the Governor, deputy Governor and assistants chosen in the year 1686 (with the addition of such gentlemen as shall be chosen by the major vote of the inhabitants of this Colony, to make up the number according to charter) and the deputies then sent by the Freemen ______ of the said colony should be the Government settled in this Colony according to charter rights, until the Government be more orderly settled by the Crown of England.

Capt. John Osgood was chosen as a representative of the town to carry the abovesaid vote of the town to Boston and also the votes for such magistrates and others, as are wanting in the former choice, in the year (86).

At a town meeting legally warned to be this 15th July 1689:

Samuel Blanchard was chosen moderator for this meeting.

It was voted and passed (that whereas the time for choice of constables and selectmen sas lapsed) the last year that the choice of said officers should be only till our usual town seetings for choice of such officers (viz:) the first Monday in January next.

Voted the number of selectmen shall be but five for this choice.

Capt. Dudley Bradstreet, Capt. John Osgood, Cpl. John Aslebee, John Osgood, Jr., and Cchard Barker, Jr., are chosen selectmen till the first Monday in January next.


Daniel Poor was chosen constable for the north part of the town for the time abovesaid.



Granted liberty to Samuel Marble to change a parcel of land upon the gravelly ridge near his barn and to join it to Sgt. Nathan Stevens his lot, Sgt. Nathan Stevens and Sgt. John Bridges to measure said parcel of land, and to acquaint the selectmen of what the difference in worth is, and to give under their hands the bounds of said land that a record may be made of it.

Sold to Robert Eimes of Boxford eight thousand short shingles in the cedar swamp next the maple meadow he paying one shilling and six pence to the town per thousand all the said shingles to be old stuff already fallen down, by eight thousand short shingles is meant stuff to make them of and cpl. Ephraim Stevens to take a view of them and make return thereof to the selectmen.

Voted and passed that a committee be chosen to appoint the several inhabitants that shall belong to the several sheep commons granted to the several parts of the town and to state the bounds of it and as to others that may hereafter settle within the said precincts.

Capt. Bradstreet, Capt. Osgood, Capt. Chandler, Lt. Barker, Christopher Osgood, Deacon John Frie, John Abbot Sr. are appointed for a committee for the end abovesaid and are empowered accordingly.


The particular grants of land and meadows granted to William Chandler.

granted to him ten acres of land on the hill on the south side of his house, five acres whereof was granted to William Ballard, for a house lot and four acres to himself for his house lot and one acre for his new field division bounded on the west with the house lot of Andrew Allen, on the southwest with a great red oak on the southeast with a white oak and on the east with the land of Mr. Dane, on the northeast corner with a stump.

Granted to him seventeen acres of land for his division land above little Hope bridge bounded on the north with a brook and a high red oak stump, on the west with a hill, on the south with a great clump of rocks, close by the river and on the east with Shawshin river.

Granted to him two acres and a half of meadow: on the south side of Shawshin river against Bilrekey meddows, between the meadow which was John Remington's and the meadow of George Abbot Senior.

Granted to him all the meadow between George Abbot Sen. and the brook which runs out of the meadow of Andrew Foster in the east of Shawshin River, with all the meadow on the south side of that brook from the river to a clump of asps, where the brook and the upland meet, with the meadow on the north side of that brook from the river to the there the brook and the upland meet with a bit of meadow on the east side of Shawshin liver against Pole Hill. All these partiels are granted for three acres and a half be it more or less.



Att a Gen'l towne meeting ye 3d of March 1689:90 Left. John Barker was chosen moderator for this psent meeting.

The towne order for ye year ensuing were read att this meeting & ye returne of ye committee about dividing the sheep commons:

Sold to Walter Wright all the land he hath fenced in more then his due (which ye Committee appointed for that end) judged to be three quarters of an acre, he paying to the use of ye town after ye rate of thirty shillings an acre, within a twelve month and to pay fifteen pence for a year for every year since he hath fenced it, tell this time that he hath bought it which he owns to be five year.

Granted to John Marstone and Nathan Steevens junr: libertie to improve eight or tenn acres of upland upon he bear hill, leaving ye same in english stuble and sowing it sufficiently with english hay seed at ye end of ye term of seaven years, the time to begin from ye date hereof: and to use noe fencing timber about it but what grows upon ye land they fence in, but to take none of ye common for that end.

Graunted libertie to William Lovejoy & Saml Preston to improve tenn acres of land upon he top of he hill on ye left hand of ye way leading from sd Lovejoy his house to towne, and to have it seaven years from ye date hereof, as ye above sd. John Marstone & Nathan Steevuns have it soe to sowe it with english hay seed sufficiently as aforesd.

Sold to Robert Grey a parcell of land he formerly bought of ye towne but not being able to pay for it he resigned it up to towne, and has now bought it again, & Saml Holt hath engaged to pay five pounds a year for three years in such pay as the towne usually sells land for.

Benjamin Barker are chosen to look after Cochichawicke River for the free passage of the fish (called alewives) into the great pond in the season of them and they are to be discharged for their pains by the selectmen, they giving an account of their labor therein and no inhabitant or strangers shall be suffered to stop or catch any of said fish till after they come to the old mill which was formerly Joseph Parkers. This is meant only while they are going up to Spawn, and any that shall break this order shall pay five shillings fine to be gathered by the overseers abovesd by order from the selectmen.

That for the future that all representatives of the town shall bring a note from the clerk of the court for the time they hath served, or else to lose their pay.



Voted and passed the Yeoman Act of the town of granting twenty shillings in pay for each wolves head catched in Andover to be paid by the treasurer by order from the selectmen, be continued two years longer from the date hereof.

Granted to William Barker, Lawrence Lacy and Ephraim Foster sixteen acres of land upon the south end of Jacks Hill to improve for seven years and then to sow it with English hayseed and then throw it up to the town, they using no other hade (?) to fence it with than not (?) grows upon the land.

At a lawful town meeting January 1st 1699-1700, Capt. Christopher Osgood chosen moderator for this meeting.

Mr. Dudley Eradstreet chosen clerk for the meeting.

Granted to the widow Eleanor Chandler six acres of land upon the right hand of the way to goodman Elanchards, between William Eallards and William Johnsons, not prejudicing the way to Crane meadow swamp. This land was given in consideration of cost in her estate.


Voted and passed that whereas Abraham Foster had formerly a grant of land to make him satisfaction for the country road that goeth through his land and he not being satisifed with said land, the town hath now given him one acre more of swampland joining on the southeast end of his farm, not running above twenty rods in length with which he hath declared himself fully satisifed for the road is to be open and without gates.

Granted liberty to William Chandler to lay down an acre of land on the northeast side of his land between William Abbotts and his house, and to take up an acre on the south side of the land, not prejudicing any highway.

Whereas there was granted to Sgt. Voted and passed that the returns of Capt. John Osgood and Sgt. Henry Ingalls, chosen as a committee appointed to lay out the half moon meadow belonging to Mark Graves Sene shall be counted good and valid.

Voted and passed that Lt. John Barker be joined with to the committee for looking after encroachments upon the common and said committee are to make report of their actions to the town next town meeting.



Granted to John Ballard and others that join with him, sixteen acres of land upon Sutton Plain on the south side of the way that goes to William Chandlers meadow to improve for seven years and then to be thrown up to the towns use, this land not to prejudice any way, but to be fenced with the timber that grows upon it and sown with English hayseed.

At a legal town meeting March 4th 1699-1700, Lt. John Osgood chose moderator for this day.

Voted and passed that John not prejudice the watering place.



Granted liberty to Samuel Stevens to improve five acres of land on the woodchuck plain on the right hand of the way leading to Salem to improve for seven years and then to sow it with English hayseed and throw it up to the town.

Granted unto John Granger liberty to improve five acres of land upon the right hand of the way leading from Fhomas Abbotts to the head of the pond to improve for seven years and to throw it up to the town, sowing it with English hayseed.

Granted liberty to John Johnson to improve two acres of land on the east side of Jobs Folly on the right hand of the way leading to Topsfield to improve for seven years and then throw it up to the town.

Sold unto Capt. Frye twenty six rods on the south side of the land he bought of Ensign Ballard and twenty six rods on the west side of the land which land he hath formerly fenced in, he paying the usual price.

Granted liberty to Ensign Joseph Ballard and John Russ to exchange one half of the twenty acres of land granted by the town to the mill upon Shawsheen river for so much land on the westerly side of sd river on which goodman Russ hath built the obligation in all respects which belonged to said land to be layed upon the land so exchanged and in lieu thereof the easterly part of half of said land granted to the mill on which end Ensign Ballard hath built, shall be confirmed to him as a free grant from any obligation.

Lt. John Chandler and Sgt. George Abbott to lay down, the one to the town and to deliver the other to Ensign Joseph Ballard for the towns use.

At a lawful town meeting the 13th day of May 1700, Lt. John Osgood was chosen moderator, and Christopher Osgood was chosen clerk for sd meeting. Voted that a committee be chosen consisting of five men to settle the setting of the meeting house in the gallerys, and below what is needful and to attend the following instructions given to direct them in that affair. The committee chosen are Capt. Chandler, Christopher Osgood, Capt John Osgood, Capt. Ephraim Stevens, and Sgt. Samll Frye. The instructions given are to make one rule out of allotments rates, age and dignity.



At a lawful town meeting January 6th, 1700-701, Sgt. Ephraim Stevens was chosen moderator for this meeting.

Voted and passed that a leanto shall at the towns charge be forthwith built to the parsonage house.

The above persons are likewise appointed a committee to take care and agree with workmen to build and finish the parsonage leanto which was granted the last town meeting day.

Voted and passed that the selectmen from timt to time shall take care that a suitable school master be provided for the town.

Voted and passed that Ephraim Foster be chosen to take care that John Eams or other encroach not upon the town common but to make report to the town of any that so do.

Voted and passed that Lt. John Osgood and Ens. John Aslbee be added to the committee appointed April 10th 1698 for to take care for the restoring the town records.

Voted and passed that the committee appointed for to repair the town records, are a committee for to bring into the next town meeting a list of those who have an interest in the town common.

Quartermaster Moses Tyler, Cornet Nathaniel Stevens, William Abbott, Timothy Osgood, Sgt. William Johnson, Walter Write, Daniel Poor, Samuel Frye, Ephraim Foster were chosen surveyers for the ensuing year.

Sgt. Ephraim Stevens was chosen clerk of the market.

Deacon Joseph Stevens, Copl. Hooker Osgood, William Foster, Joseph Wilson jr. were chosen tithing men for the ensuing year.

Joseph Parker, John Johnson were chosen fence viewers for the year ensuing.

Corpll Benjamin Earker was chosen pound keeper.

The above said officers sworn to their respective offices as the law directs before me Christopher Osgood, town clerk.

Voted and passed that the selectmen shall have power to agree with a school master for the year ensuing, and to assess upon the inhabitants as the law directs to raise moneys to defray our ministers rates, a school masters salary and what other necessary charges shall arise for the maintenance of the poor and other necessary charges.

Voted and passed that there be a meeting of the proprietors of the town on the 8 day of inst. March to consult what is needfull to be done in order to the protecting of what is wanting in our original records of the proprietors settlement.

At a lawful town meeting of the inhabitants of Andover the 24th day of May 1703, Lt. John Osgood was chosen moderator for sd meeting.

Proposed and voted that a committee be chosen by the town, of five men so with those proprietors of land in Andover that have not their land yet entered in the new town book of records of land and the next (?) neighbor joining therewith, that they may have the most use (?) and full intelligence of the bounds of such lands, and what the (?) committee shall act and agree upon in settlement of such bound, entering (?) their return of what they do under their hands to the town, and there being accepted shall be accounted authentic to be entered on record, and where any land (?) upon the Town common, the sd committee shall have power to settle all such bounds and make return as above said. And do now appoint the first Tuesday in October next, be a general Town meeting of the inhabitants of the Town to look at the committees return.

The committee chosen for the abovesd affair are John Osgood, John Abbott, Henry Holt, Sen and Deacon Joseph Stevens, John Chandler and any three of them agreeing shall be accounted authentic for the return of abovesd for which service they shall be allowed 2 shillings per diem out of the town treasury.



At a lawful town meeting on the 5th day of October 1703, Lt. John Osgood was chosen mederiator for sd day.

Voted and passed that the committee chosen by the town at a meeting the 24th of May 1703 for the settling of the bounds of such lands that were not yet entered in the new town book of records, that said committee be continued in sd service till the last Tuesday of November next on which day they shall bring in their returns of what they shall do in said affair.

And it is voted that the last fuesday in November next be a general town meeting of the inhabitants at 8 of the clock in the morning to attend sd work, and it is voted that whosoever do neglect the settlement of the bounds of their lands against the day, shall bear the charge of what shall then be restored at (?) their own particular cost.



At a lawful town meeting on the 6th day of March in the year 1703-4 Lt. John Chandler was chosen moderator for sd meeting.

Mr. Dudley Bradstreet was chose town clerk for the year ensuing.

John Granger chosen constable for the north end of the town for the year ensuing.

Nehemiah Abbott is chosen constable for the south end of the town for the year ensuing.

Ensign John Aslbee chosen town treasurer for the year ensuing.

Capt. James Frye, Sgt. Stevens, Sgt. Abbott, Lt. Johnson, Ephraim Foster, William Foster, William Abbott, Dan Poor, Corpl. Benjamin Barker were chosen surveyers for the year ensuing.

James Bridges is chosen surveyer for the year ensuing.

Sgt. Ephraim Stevens is chosen clerk of the market for the year ensuing.

John Farnum Jr., John Johnson Jr., William Chandler and Edward Phelps are chosen tithing men for the year ensuing.

Thomas Johnson Jr. is chosen tithing man for the year ensuing.

Upon application of Reverend Mr. Barnard it's voted and passed that the town shall pay to said Mr. Barnard the year next ensuing eight pounds money which is in consideration of his supply of wood for the next year.

John Marston Jr. is chosen grand jury man for the year ensuing.

Voted and passed that the vote of the town on the first day of March 1702-3 empowering the selectmen to levy upon the inhabitants money for defraying necessary town charges be - (torn)



24 May 1703 voted that the minutes of our town meeting shall hereafter be entered in our new town book.

Voted and passed that a handsome piece of black broadcloth be bought for a funeral cloth for the towns use and the payment be made for it out of the town money.

At a lawful town meeting on the 30th day of November 1703, Lt. John Chandler was chosen moderator for sd meeting.

The return of the committee was then read and the settling of the bounds of such lands as could not be found on record, and their return was accepted and justified and ordered to be recorded in our new book of records of land for Andover.



Confirmed to the present selectmen for this present year.

At a legal town meeting Monday March 5th 1704-5, Lt. John Osgood was chosen moderator for this meeting.

Copl. Christopher Osgood is chosen town clerk for the year ensuing.

Voted that the selectmen for the year 1704 shall give in their (?) accounts to the Town of their disposing of the money put into their hands.

Voted and passed that the 2nd Monday inst. March be appointed for a general town meeting to consult of, and act about, several things that appear to be of concernment for the towns interests as to encroachments of land and other things.

Voted and passed that the vote of the Town on the 1st of March 1702-3 impowering the selectmen to levy upon the inhabitants money for the defraying necessary Town charges.



Att a lawfull town meeting the 12th day of March 1704 Capt. John Chandler was chosen Moderator for said meeting.

It was voted and passed that Mr. Barnard in answer to his request to the town in that regard shall have eight pounds in money given him of the town in the lieu of the wood the town was to provide for him which is to be understood for this ensuing year and the payment thereoff to be made the next winter.

Voted and passed that Sgt. John Aslebee and Walter Write, Ensign Ephraim Stevens, John Abbott: Ensign Joseph Ballard be a committee to view and take notice of any incroachments that is made by any person upon the town comon and the return of any three (?) of the five be accounted authentic. They are to take notice of any comon land they find taken in by any particular person and to warne them to remove their prices straight to their proper line forthwith and to make their returne of whate they so find to the town the next General Town Meeting.

Voted and passed that Ensign Joseph Ballard shall have the liberty of the land which his son Hesekiahs shop now stands upon so long as he shall have occassion for a smith's shop to stand there: and after that: the land remaine the towns again.

Granted liberty to Ensign Ephraim Stevens to take in so much of the town's land adjoyning to his own: as to set up a leantow at the end of his Barne: of ten foot wide and liberty therewith to make his yard square with his leantow.

Voted and passed that no rams shall be suffered to go upon the comon with the ewes from the first day of August to the last day of October and whatsoever rams are found contrary to this order within the time abovesaid, the owners of said rams shall pay two shillings per week for every ram so found which shall be payable one halfe to the informers and the other halfe to the Town Treasurer for the use of the Towne.

Granted to Samuel Farnum a stripp of land from the horsbridge on this side his house to the Brooke on the east side of the Brooke: not to damnifye the Roade as it now is nor the privilege of watering at the Brooke for cattle.

Granted liberty to Joseph Robbinson to exchange an acre and a half or nor exceeding two acres of land: he laying it down on Eushill the northwest corner of his land running eastward and to take it up on the outside of our bounds, next to Rowly Line adjoyning to Left John Peabody's land.



Att a lawfull Town Meeting Legally warned by order from the selectmen on the 15 day of October 1705 to consult and agree about the building a New Meeting house.

Left John Aslebee was chosen moderator said meeting - Voted & passed that there shall be one meetinghouse built as may be sufficient and convenient for the whole town as may be.

At a lawfull Town meeting legally warned by order from the selectmen on the 12 day of November 1705. To consult and agree about a New Meeting house and the place where it shall be sett for the best conveniency of the inhabitants. Capt. John Chandler was chosen Moderator for said meeting.

A vote proposed by the moderator that those that were minded the meetinghouse should be set by the Widow Allins should go out at the North Door and those that were minded to have the meetinghouse to be sett in the center of the inhabitants should go out at the South Door.

Accordingly it was voted and passed that the New Meetinghouse that was voted the 15th of October to be built in Andover should be sett for the conveniency of the Town as near as any place can be found convenient in the center of the inhabitants. Ems. Joseph Ballard, Henry Holt: Sergt. Francis Dane, Quartermaster Moses Tiler, Timothy Osgood: James Bridges are a committee chosen by the Town to compute and find out by measure and number of the inhabitants. The center of the Town, according to the Town vote to set the new Meetinghouse as may be convenient for the inhabitants, and to bring in their report of their doings to the Town at their meeting this day fourthright.

Att a lawfull Town meeting legally warned by order from the selectmen on the 26th of November 1705 to consult and agree of the place & methods for the building a New meetinghouse in Andover. Leiftenant John Osgood was chosen moderator for said meeting and no town business effected but to take in the return of the committee which was that they could not agree.

Att a lawful Town Meeting legally warned by warrant from the selectmen on the 19th of January, 1706/7 farther to consult about the building of a meetinghouse for the inhabitants of Andover according to our former vote. Ensign Ephraim Stevens was chosen moderator for said meeting and no other Town business effected.



Att a lawful Town Meeting Monday March the 4th 1705/6 Ensign Ephraim Stevens is chosen Moderator for said meeting. Capt. Christopher Osgood was chosen Town Clerk for the insuing year. Capt. James Frye, Capt. Christopher Osgood, Left. John Aslebee, Left. George Abbot, Sergt. Samuel Frye are chosen Selectmen for the year ensuing.

John Farnum Junr. and John Johnson Senr. are chosen constables for the ensuing year: John Johnson for the South end: and John Farnum for the Northend.

Lieft. John Aslebee is chosen Town Treasurer for the year ensuing.



Att a lawfull town meeting legally warned and convened together the 17th day of May 1706. Lieft John Aslete was chosen Moderator for said meeting.

Voted and passed that the selectmen shall have power to agree with a schoolmaster for the year ensuing and go assess upon the inhabitants as the law directs to raise moneys to defray our minister's rates, a schoolmaster's salary and what other necessary charges shall arise for the maintenance of the poor and other necessary charges.

Voted and passed that the twenty-cight acres of land sold to Leift. Joseph Chandler to Ensign William Lovejoy taken out of Benjamin Abbott's land by exchange with the town for the benefit of the committee and the Iron Works. The said Joseph Chandler shall have that six acres which Ensign Lovejoy hath broken up and cleared laying down all the rest of the twenty-eight acres to the use of the Town in common for ever. The town adding to his six acres eight acres more of land to joyn on the northerly end. Thereof running down the river, which will make the whole fourteen acres and this shall be ratified and confirmed to the Iron Works and Chandler the owner thereoff: forever and to be a finall conclusion, of all controversy that might arise from any grants formerly to said Works and this land to be layd out by the Lolayers: Lieft. George Abbott and Deacon Joseph Stevens, and they to take a quitt claims of Lieft. Chandler of the land granted to the Works excepting the abovesaid six acres brought into improvement.

Att a lawfull Town meeting anually apointed on Monday the 3d day of March 1706/7.

Leift John Aslebe was chosen moderator for said meeting. Capt. Christopher Osgood was chosen Town Clerk for the ensuing year. Capt. Christopher Osgood: Capt. James Frye, Leift John Aslebee, Leift. George Abbott: Sergt. James Frye are chosen selectmen for the year ensuing.

Corpll. John Frye: and Joseph Lovejoy are chosen Constables for the year ensuing. Mr. Andrew Peeters is chosen Town Treasurer for the year ensuing.

Capt. John Chandler: Quartermaster Moses Tiler: Lieft. George Abbott, Sergt. Francis Dane, Sergt. Samuel Osgood: John Carleton: Sergt. William Chandler, John Maston, Jonathan Blanchard, James Ingalls, Daniell Poor: are chosen surveyors for the year ensuing.

Granted liberty to Richard Barker Senr. to exchange with the Town six acres of land he laying it down at the upper end of ye woolfe swamp the land that was formerly improved, he taking it up again between his pond ground and Jacob Marstons on ye (?) and ______ of ye way. Done by the lottlayers.



Granted to Leift. John Aslebe a slipp of land about one acre or not exceeding an acre and a quarter lying on ye northside of Samuel Hutchisons barn on ye westerly side of ye land of Sergt Benjamine Barker down to ye old sluice. Leaving to Sargt Barker and his heirs forever, a liberty of a way through said land by gates or draw bars for to cart his hay from his meadow.

Att a lawfull town meeting legally warned by order of ye selectmen on Monday the 12th of May 1707 Leift John Osgood was chosen moderator for said meeting.

Voted and passed that the vote passed in a town meeting in March the 1st 1702/3 for the impowering the xelectmen to assess on the inhabitants moneys for the defraying the ministers rates, a schoolmasters sallary and other necessary charges in ye town. That siad vote is now revived for the ensuing year and also the selectmen are chosen assessors for collection of the country tax.

Att a lawfull town meeting legally warned by order from the selectmen the 26th day of May 1707. Capt. John Chandler was chosen moderator for said meeting.

Voted and passed that the return made of the line run by the artist Leift Burnett of Reading by which he found by measure that the center of the inhabitants was in Abraham Fosters Junr; Lott near his house that this place is accepted as the center or near thereabouts.

Voted and passed that meeting house be built for the inhabitants of Andover of these following dimensions viz. of sixty foot long and fourty two foot wide and twenty foot studd and with a flatt roofe.

Voted and passed that Capt. John Chandler, Leift George Abbott: Sargt Samuel Frye, Ensign William Lovejoy, Quartermaster Moses Tilor be a committee to agree with.



Voted and passed that ye selectmen shall be hereby impowered from the Town: to take care for the Reverend Mr. Barnards: settlement in some convenient house for the present supply till a house can be built for him.

Att a lawfull town meeting legally warned by order from the selectmen the 2d day of July 1707.

Leift John Osgood was chosen Moderator for said meeting.

Voted and passed that there shall be some convenient fortification made with boards and timber about the house where the Reverend Mr. Barnard is for the present shrowded - and that the said stuffe used about said worke. Shall be taken away againe for the Towne use as they shall after (?) see ocasion and that a committee be chosen ande appointed to see the said matter speedily effected for Mr. Barnard security and convenience. The committee chosen to see the above said worke effected are Timothy Osgood, Coronett Stevens, Richard Barker; The committee are also to take care in procuring boards that they may be such. That may be suitable to improve afterwards in the building of a house for Mr. Barnard.

Att a lawfull town meeting legally warned by order of the select men the 9th day of September 1707. Capt. John Chandler was chosen moderator for said meeting.

Voted and passed that the New Meeting House that was voted to be built for the whole town of Andover that it shall be sett upon the spott of ground near the tree called Holts Tree, where the cross paths meet as the southwest corner of George Abbotts ground.

Voted & passed that the town will be at the expense of 40 or 50 shillings if it be needfull to the repayring and mending the roofe and walls of the house Mr. Barnard is now resident in and that there may be (?) improved to prepayr the wall of said house.

Ensign Lovejoy and Walter Write are chosen to be added to the former committee chosen and appointed to take care for the making a fortification about the house where Mr. Barnard is at present settled according what was voted in our former meeting on July the 2nd, 1707:

Voted Liberty that Mr. Barnard may take so many of the brickes that belonged to his former house to make a chimney in ye Brick house belonging to ye house where he now liveth.



Att a lawfull fown meeting Legally warmed by order from the selectmen on the 27th day of February 1707/3 in obedience to and according to order of the gen'l court to chose a commissioner and trustees to take in the valuation of the state of the Town and to procuring therein as said act directs: Capt. John Chandler was chosen moderator for said meeting.

Capt. Christopher Osgood was chosen commissioner: Capt. John Chandler, Mr. Andrew Peeters, John Abbott, Corpll Nehemiah Abbott, Ephraim Foster are chosen for Trustees for the management of said affair.

By warrant from the selectmen in warning of said meeting there was also orders given in said warrant thatt tryall might be made in ye town meeting to recondite our long diserened if it be possible by a regular vote of such persons as are quallified for voting as the Law directs accordingly. The matter was offered to the Town and another wote past in upon the former spot viz - that the new meeting house should be set at that place commonly called Holts free, for which vote there was in number (?)

Att our annuall Town meeting for the choyce of town offices on the 1st day of March in the year 1707/8 M(?) Ephraim Stevens was chosen moderator for said meeting.

Capt. Christopher Osgood was chosen Town Clerk for the year ensuing.

Capt. Christopher Osgood, Capt. John Chandler, Srgt. Samuel Frye, Leift. George Abbott, Sargt Francis Dane are chosen selectmen for the ensuing year.

Steven Earker and Nathaniel Abbott are chosen constables for the ensuing year.

James Ingalls, Abraham Foster, Sergt John Ballard, Stephen Osgood, Sargt Hooker Osgood, Quartermaster Moses Tiler, Richard Barker Senr., Sargt Samuel Osgood, Sargt. William Chandler, Ephraim Foster are chosen surveyors for highways for the year ensuing.



Sold to Thomas Abbott Junr. half an acre of land for his conveniency to sett a dwelling house upon which land is to be layd out to him at the East end of his barne joyning to his pasture: for which he is to pay to the Town fifteen shillings in money the next Michlemas ensuing.

Att a lawfull Town Meeting of the regular Voters in town affairs, Legally warned by order & warrant from the selectmen in order to determine our long difference about the spott to sett our new Meeting House, convened on the 12 day of October 1708. Capt. John Chandler was chosen moderator for said meeting.

It was voted and passed that the New Meeting house which shall be built for the inhabitants of Andover shall be sett att the spott commonly called Holt's tree where it was formerly voted where the cross paths meet on the southwest corner of Leift George Abbottsland. The number of votes was eighty eight: and the lossing vote was number 29.

Voted and passed that the New Meeting house shall be built according to these dimensions following viz. fifty-six foot long and fifty-foot wide and twenty-two foot studds and with a square roofe without Dormers with two Lucoms on each side.

The fown meeting was then by the Moderator adjourned to the next Friday at noon which will be the 15th day current that then the Town might chose a committee to carry on the measure of the work of ye new Meeting house and also to consult about raising money for said work, and to impower same to take care to repayr our present meetinghouse for our present comfort (?) and also to impower the selectmen to raise money for to defray our necessary town charges.



Voted that Capt. John Chandler, Lt. George Abbott, Sgt. Samuel Ffrie, Ens. William Lovejoy, Quartermaster Moses Tyler be a committee to agree with workmen and Laborers and for teams and what shall be necessary for the carrying on the building and finishing of our new meeting house, for which vote there was 81 in number; and that the Town will furnish them with money for the carrying on of said work, which money shall be raised at three or four payments as the major part of the Town shall agree for the time and sum: this particular vote had in Number 84 and (?) it was voted that 100 pounds in or as money shall be raised on the inhabitants out of this cropp in this first year for which vote there was numbered 84.

At a lawful town meeting warned by order from the Selectmen on the 24th of December 1707, upon the occasion of ye coming up of ye gentlemen appointed by ye honored General Court as a committee to hear the allegations made by the fown and the petitioners in regard of the difference between the petitioners and the Town concerning ye place for setting the new meeting house: Capt. John Chandler was chosen Moderator for said meeting. Capt. John Chandler, Capt. Christopher Osgood, John Abbott Sr. and Ensign William Lovejoy: Sgt. Samuel Ffrie, Henry Holt, Capt. Nehemiah Abbott, Sgt. Francis Dane, are chosen and appointed by ye Town to manage the difference with the gentlemen of the committee in the Town's behalf and so attend the gentlemen in viewing the places proposed for ye setting of ye meeting house in answer to the allegations that shall be made by ye petitioners.



At a lawful town meeting legally warned by order (torn) Town the 3rd day of September 1707, according to the vote (torn) Capt. John Chandler was chosen Moderator for said meeting. At this meeting, there was offered a paper of discentors from a vote of a former meeting which they desired to be entered in the records in this place and they continued their discent at this meeting, which is here entered as followeth:

Andover, September the 15th, 1707. We whose names are hereunto subscribed being a certain number of the Town aforesaid, being qualified according to law to vote in Town Meetings, do herein enter our contrary decents against the Town's actings any further about the setting, building or erecting of a meeting house on ye place on the westwardly end of George Abbott's land where the place was last voted: by some of our Town of Andover aforesaid at a Town Meeting, held at Andover on Tuesday, the ninth day of this instant September in the year 1707, which vote entered in our Town Book as we understand. Therefore, we, the subscribers, are against the setting of the meeting house on the place aforesaid for the several reasons following:

- 1st. The place that is voted where the meeting house is to stand is the Proprietor's Common and there is no leave of them that it shall stand there, which should have been first known that they give or sell land to the Town for that use.
- 2dly The place voted to set the meeting house on is so far from the parsonage that the Town hath settled Mr. Barnard upon that he cannot, with any conveniencey, go constantly to it to preach. Neither can the whole Town remove him except he pleaseth. And the Town in reason cannot think that he will be willing considering the remoteness of the place and therefore, Mr. Earnard's mind should have been known by the Town in that matter whether he would be pleased to remove yea or no.



The place voted for the meeting house to stand on is much besides the greater part of our inhabitants for the bulk of the town that live near together in the town: and where it was first placed, and not in the center as it is inhabited the way they must go to meeting.

We, the subscribers, are much of the opinion that the last vote that past and is entered in our Town Book is not legal for this reason. In that said vote was obtained by many voting in the meeting aforesaid that was not qualified according to law: neither had many of those persons that estate ratable to the value of 20 pounds to a single rate besides the pole which qualifications all persons must have before that they can vote in the choice of any town offices; and if so sure they had need be as well qualified for the choice of a place to set the meeting house on, it being a thing of so great weight.

We, the proprietors for ourselves, that have hereunto subscribed being interested in all and every part and parcel of common and undivided land in the town aforesaid, do herein forbid the granting or laying out any of the common in that place there by George Abbott's land where the meeting house shall stand for that use for some of the reasons already mentioned.

Granted to him a seven-acre houselot bounded on the north with the houselot of John Osgood, on the south with the highway, on the west with the street, on the east with the land of Joseph Parker.

Granted to him two MEXEX of street division, one before his house, bounded as it is now fenced; the other next to the street lands of Mr. Francis Dane, having the highway on the east and north.

Granted to him the sponge of meddow for John Stevens his meddow on both sides of Mosquito Brook for two acres, having the meddow of John Osgood on the east, and Daniel Poore's on the south.

AT A GENERAL TOWN MEETING THE 24TH OF NOVEMBER 1662

It is ordered and granted that for every acre of houselot there shall be laid out to it twenty acres of upland to be taken up and chosen the same way and order that hath been used in divisions of land according to the times of men coming to the town, which land may be taken up in any place beyond Shawsheen River within the bounds or in any place this side of the river provided that no part of that on this side of the river be within four miles of the meeting house; provided also that they within have meddow granted on the further side of the Shawsheen River may take their land next to their meddow, and no ther shall disappoint them thereof, though it be their liberty to choose before them, and everyone is to make choice of his place where to be as soon as possible may be, especially those that are to choose first, so that all divisions may be laid out by the first of May next and furthest and whomsoever hath not by that time made choice of his place shall lose his liberty of choice and he that cometh next may take up his alottment and so others afterward as they can find their places.

Joseph Earker, Thomas Chandler, Nathan Parker and John Lovejoy are chosen and appointed as lotlayers to lay out and measure the several lots, all which they are to lay of four-square or long squares not exceeding twice the length at the breadth of every lot contain and are to mark trees or set stakes or hoops of stones at every corner which they are to enter and record in a book with the length and breadth thereof and to give ye parties it concerns a transcript thereof unto their hands, as they are to do for all other lands that at any time they shall lay out and it is agreed that there shall be two of ye four lotlayers at the laying out of this or of any other land granted by ye town and for the laying out of these alottments there shall be allowed six shillings a day to those two lotlayers that shall be employed to be paid by him or them that sets them to work and if they can dispatch that which they are called forth to do in less time than a day, yet no part of their said allowance shall be abated and for the laying out of meddow ground, they shall be allowed twopence an acre or six shillings a day at the choice of the lotlayers and for such houselots as hath been alienated or sold by the first grantor and so remains doubtful for whom division of land belongs. The said lotlayers are to forbear laying forth any land as xx belonging thereunto til the controversy be decided or have further division therein from the town.

Granted in Shawsheen Field eight acres, Mr. Bradstreet's land on the east end of it, John Osgood's land at the west end of it, the way on the north side and the meddow on the south side of part of it.

Granted to him the cutting all the meddow and Shawsheen Field next his land to the cartway for making some fence, all this land and meddow aforementioned was legally granted to John Stevens and his heirs forever February 1, 1659.

THE PARTICULAR GRANTS TO NICHOLAS HOLT

Granted to him fourscore acres of land whereof threescore are for his last division, the other twenty for the three years debt due unto him from the town, the which land was laid out by John Lovejoy and Thomas Chandler, thirty acres of it laid out upon the plain called Stony Plain being fourscore rods in length from the north to the south. From the east to the west, three score rods. Bounded on the east with a small swamp and on the west with a swamp.

Fivtie acres where his house doth stand running from a swamp below his house having a great red oak marked, running southwest threescore rods marked with a red oak, and to a little swamp, and westward upon the hill 100 rods marked with a dry(2) walnut turning again northeast threescore rods having upon the northwest a pine swamp with a pond in the middle of it, turning down east a hundred rods upon the side of the hill which measures to 37 acres and a half whether more or less; the other 12 acres and a half whether more or less; the other 12 acres and a half whether southeast side of his house bounded with the stony valley upon the southeast, and because his land was stony, the lotlayers did allow him all the stony land lying karidaxthax by the side of his lot to the foot of the great hill lying on the north side of his house and running down to his great meddow.

His great meddow was allowed him for 20 acres, be it more or less.

At a meeting of the selectmen of Andover the 19th of June 167, it was ordered and agreed upon that the surveyors of the town shall have liberty to call forth ye inhabitants of ye town as many days as they shall judge meet, not exceeding four days and are to improve them in mending ye highways about ye town and any being legally warned by having a day's notice and not coming shall forfeit three shillings per day for a man and six shillings for a team (unless ilhess present). The said forfeiture to be distreined(?) forwith by ye constable and ye one-half to go to ye use of ye town and ye other half to ye surveyor that shall so warn them. ****

At a town meeting the 3rd of March 1689/90, the town voted this order above to stand til it be repealed by the town and have made this addition to it. (viz) That the surveyors shall appoint _____ to appear at ye place they are to work at the sun and xxxxxxxxxxx an hour high with their dinner with them and with such tools as the surveyors shall appoint them to bring, (if they have them and to forfeit sixpence for every hour that they tarry after the above time of sun an hour high, said money to be gathered by the surveyors and to their use of the company that works at that place where the delinquent should have appeared. A rationall allowance for time always to be allowed for them to travel to the place of work and so for men and what time the surveyors shall spend more than the rest of the inhabitants of the town, the town shall pay them for and if one surveyors squadron works in two or more places at once, he shall have liberty to make a deputy or deputies for those places he cannot be with them himself, who shall have power to punish any delinquent as the surveyor might do. Voted and passed ax the above said.
