

PREFACE.

The Elliot name, variously spelled, even to Elot and Ellit, is one of the most numerous in our Colonial period. The combination, John Elliot, occurs with surprising frequency during the seventeenth and eighteenth centuries among the old sea-coast towns of New Hampshire, Maine and Massachusetts. No antiquarian has yet had the hardihood to undertake a full genealogy of the various branches of this extensive family.

To date five monographs have been published. One of four pages relates to the Elliots of Keene, New Hampshire, who are descended from Lieutenant Andrew Eliot of Beverly, Massachusetts. Another of seven pages gives the records found in the Registers of Nazing, Waltham Abbey, Cheshunt, Hunsdon, Roxwell and Cornwall, England. Caverley's Eliot Memoir was published in 1881; and the Eliot Family of Beverly, Massachusetts (157 pages) in 1887. President Charles W. Eliot is descended from the Beverly branch. A Genealogy of the Eliot Family (184 pages) was published at New Haven, Connecticut, by William H. Eliot, Junior, in 1854.

This last pamphlet has been made the basis of a large volume of 344 pages, published in 1905, entitled *The Descendants of John Eliot, Apostle to the Indians*. The chief editor of this publication is Mrs. Wilimena Eliot Emerson, daughter of the original compiler. The work is rich in material relating to the eminent preacher, is handsomely printed and il-

lustrated, and is altogether an admirable production as far as it goes. Yet, notwithstanding its size, but 742 descendants of Eliot blood are included in the volume, and these are mostly in Massachusetts and Connecticut.

It is obvious that there is a large Elliot field still untilled. The present writer has explored but a small corner of it; but most of the facts here presented have never before appeared in print.

It is a matter of regret that our John Elliot cannot be traced with certainty beyond the settlement of Boscawen, New Hampshire, in 1734. Even if we accept the strong circumstantial evidence that he was the John Elliot, son of Francis, baptized at Durham, New Hampshire, December 21, 1722, we are but thrown back to another blank wall, for no investigation has been able to determine who or whence was this Francis.

Research has been made in the New Hampshire Provincial Papers in the State House at Concord; in the New Hampshire State Library and the New Hampshire Historical Library, also in Concord; in the Essex County Records at Salem, Massachusetts; in the library of the New England Genealogical and Historical Society, Boston; and in the Court records at Nashua, Exeter and Dover, New Hampshire. Various family traditions have been blown away by these investigations, and many John Elliots have been found about the antecedents of our John Elliot.

The writer has worked intermittently at this compilation for the past twenty-five years. Only those who have conducted a similar research can

have any idea of the time and labor involved. Hundreds of letters have been written and hundreds of miles travelled to get together a comparatively small amount of material. Most people think a request for genealogical information is the one thing that need not be answered promptly. The ignorance of most people regarding the vital statistics of their nearest relatives is discouraging. It is common to receive long letters containing absolutely no definite dates or facts, but filled with apologetic statements to the effect that "Aunt Susan knew, but nobody else remembers" or "Our family Bible got lost somehow" or "Since grandsir's house was burned, we've got no records" or "The snow is so deep I can't get over to the grave-yard, seven miles."

Another thing, even more perplexing than the lack of material, is the conflicting statements. In many cases the family Bible, the tombstone, a personal recollection and the town clerk's record all differ. In the first two cases the inaccuracy is explained by the fact that the inscriptions may have been made at a much later date than the occurrence. We all know that human memory is uncertain. The bureau of Vital Statistics in the State House, containing transcriptions from the town books, is considered the court of last resort, but even that is not infallible; and although it contains an invaluable mine of facts, the earlier records are mostly lacking.

Every effort has been made to secure accuracy of dates and facts in the present work; but the writer has sometimes been obliged to conjecture which of three different dates would be most reasonable, as it has been found impossible to get absolute proof of any of them. The incomplete records in this book are due to the failure to get replies to repeated requests for information from the persons concerned.

In regard to the spelling of the name chaos prevails. We have one signature of the first John Elliot (sic) still preserved; but there seems a tendency among the later generations to use two t's. There is so much confusion that no attempt at uniformity has been made in this work. It may be mentioned that the Dr. John S. Elliot⁴ family of Manchester, New Hampshire, whence came the gift of the Elliot Hospital, continue to use the single t. The writer's uncle, Charles Ira Elliott⁵, introduced the double letter into his branch. The Elliotts of the Flume House in the Franconia Notch use two t's.

In conclusion the writer may remark that if, through the publication of this little monograph, any Elliott descendants become more intimately acquainted with the lives of their ancestors or if any future compiler finds material which supplies the needful blocks for a larger structure, the compiler has been amply repaid for the expenditure of time, money and labor.

THE OLD FAMILY BURYING-GROUND.

In the northern part of Boscawen, New Hampshire, not far from the Salisbury line, on a secluded farm, lies a small enclosure, now well overgrown with bushes, where repose the remains of some of the pioneer Elliots. The lot lies to the west of the highway, nearly a quarter mile in from the road, known as Water street. The nearest house to the north, up the hill, is called the Raleigh place, and was once the home of John³ (Methodist) Elliot. Still farther north, just across the Salisbury line, stands an abandoned house with an even finer view, formerly the home of Durrill³ (Elliot), brother to John³. Other homes of early Elliots once stood within a closer radius to the burying-ground, but nothing now remains except the cellar-holes.

In searching among the ancient graves one looks in vain for the last resting-place of John¹ Elliot, the original pioneer, though it is possible that he and his wife may be buried here. The oldest markers are some crude stones, on one of which can be traced the characters J E 83. This marks the grave of John² Elliot, who died at the age of 83, February 18, 1827, as known by other records. The adjoining stone says simply T E, which stands for Temperance Durrill, his first wife, who died before 1781. Nearby stones are marked D E and A L. These initials mean Durrill³ Elliot and Ascenith³ Elliot, wife of Noah Little, who were the second and third children of John² and Temperance (Durrill) Elliot. Ascenith³ Elliot died June 8, 1808.

By tracing other inscriptions it is found that John² Elliot is surrounded by the graves of six of his thirteen children; by nine grandsons and nine grand-daughters; and by four great-grandchildren. In most of the cases the husbands and wives of the Elliots are buried with them, making a patriarchal assemblage which, under our changing conditions, could not be found in any modern cemetery.

A list of the graves of the descendants is interesting. Beside John² Elliot's two children, already mentioned, Durrill³ and Ascenith³ (Elliot) Little, there are found the graves of John³ Elliot and Sally, his wife; Joseph³ Elliot and Hannah M., his wife; Enoch³ Elliot and Mary, his wife; and Susannah³ (Elliot) Hale with Royal Hale, her husband. Enoch³ and Susannah³ were children of John² by his second marriage.

The nine grandsons to John² Elliot are Enoch⁴ and Calvin⁴, sons of Enoch³; William Harrison⁴, son of Joseph³; Bartlett⁴, Thomas Jefferson⁴ and Nehemiah Cogswell⁴ Elliot; and Frederick Hale, Samuel Hale and his wife, Sarah D. Cram, and Benjamin F. Hale and his wife, Matilda L. Ambrose, sons of Susannah³ (Elliot) Hale.

The nine granddaughters to John² Elliot are Lucinda⁴, with her husband, John Clement; Hannah M.⁴ and Fidelia⁴ (Elliot) Emerson, daughters of Joseph³; Miriam B.⁴, daughter of John³; Melinda B⁴. Folsom, daughter of Enoch³ Elliot; Susan⁴ (Elliot) Flanders; and Sarah Adams Hale and Harriet M. Hale, daughters of Royal and Susannah³ (Elliot) Hale. Miss Harriet M. Hale, who died in 1906, at the age of 86, has a grave marked by a modern slab of marble.

The four great-grandchildren to John² Elliot are the infant daughter of Thomas Jefferson⁴ Elliot; and George Q. Clement, son of John and Lucinda⁴ (Elliot) Clement; and two infant children of Samuel and Sarah D. (Shattuck) Hale.

Beside the foregoing there is found a stone marked: "Benjamin Rowell, d. Dec. 11, 1857, ac. 51." Benjamin Rowell's name is also inscribed on the south side of the marble block commemorating the Hales. On this block are given the years of his birth and death, "1806–1857." Underneath Benjamin Rowell's name is that of Dudley Cram, probably Mrs. Hale's second husband, with the dates, "1802–1865." On the north side of the Hale block the inscriptions read: "Infant 1848–1848; infant 1849–1849; Martha Hale 1768–1850." Near by is a small marble stone on which are cut in tiny letters: "dau. son." Perhaps these may belong to the Hale family.

There are twelve rough or broken stones on which no chiselling of any kind can be traced. They indicate graves, most of which are bounded by footstones also, which are probably the last resting-places of some of the early Elliots. One ancient slab of rough granite, different from the others in form, is shaped somewhat like an old-fashioned coffin set upright in the ground. Possibly this may mark the remains of the original pioneer, John¹ Elliot.

THE ELLIOTS OF BOSCAWEN, NEW HAMPSHIRE.

The settlement of Boscawen, New Hampshire, was begun in April, 1734, when some thirty-three sturdy pioneers from Newbury and Haverhill, Massachusetts, and other coast towns pushed their way up through the valley of the Merrimack. At a point about three miles to the north of the place where this river is joined by the tributary Contoocook they made their stand. The new settlement was called "Contucook" from the river; and it bore this name till 1760 when it was re-christened for Admiral Boscawen, and has since enjoyed the distinction of being the only post-office in the United States so called.

The new town was literally an outpost of civilization, for to the north an unbroken wilderness stretched toward the St. Lawrence river; and to the east there was no settlement nearer than Rochester, New Hampshire. We do not find John Elliot among the names of the twenty-seven original settlers which have come down to us; but it is certain that if he was not one of the thirty-three pioneers who built their cabins at "Contucook" in the year 1734, he came there soon after.

(1) JOHN ELLIOT.

The first time John Elliot's name appears on the records of Boscawen is in a document signed November 29, 1743, when thirty-one settlers organized themselves into a military company for defence

against the Indians. A fort had been built at "Contucook" in 1739. The position of the outlying plantation soon became so hazardous and the Indian raids so frequent that many of the settlers returned for a time to their early homes. John Elliot went to Durham, New Hampshire, where he lived from 1750 to 1765. It is strongly probable that he was a native of this ancient town for there is a record of baptism in the diary of Rev. Hugh Adams as follows: "Dec. 21, 1722, Mary Elliot, wife of Francis, and their infant sons, John and Francis."

In the Provincial Papers in the State House, Concord, New Hampshire, are six Court records relating to John Elliot of Durham. One of the documents bears the signature of John Elliot (spelled thus), written in a firm, legible hand, showing that he was a man unusually well educated for those times. According to Dr. Stackpole, the historian of Durham, John Elliot held the following offices in that town: Juror, 1757; tythingman, 1758; field driver, 1762; surveyor of highways, 1764; lot layer, 1765. According to deeds on file in the Court House at Nashua, New Hampshire, John Elliot of Durham first bought land in Boscawen on October 18, 1765. He paid to Thomas Clough of Canterbury (across the river from Boscawen) "Thirtyfive Pounds Lawful money" for two tracts of land containing about one hundred thirty-This land, according to an old map three acres. in the State House at Concord, was at the end of Mutton Road in that part of Boscawen which has now become the township of Webster. John Elliot must have been an extensive land-owner for the records at Nashua show eleven conveyances of land in which his name appears, seven times as grantee and four times as grantor. His homestead was on Water street.

On June 1, 1772, John Elliot signed a Declaration of the people of Boscawen against the closing of the Port of Boston, as ordered in the Boston Port Bill. Early in 1774 a Committee of Safety was formed of which he was a member. On June 3, 1776, he signed the Articles of Association. In 1776 and 1777 he was a member of the board of selectmen. On April 25, 1778, he was appointed on a committee "To inquire into the state of service already done in the war and make a just and equitable estimate of each Term that has been done and make report."

John Elliot fought at the battle of Bunker Hill as a private in Capt. Joshua Abbot's Company, Colonel Stark's Regiment. The Revolutionary Rolls (Vol. I, p. 61) show John Elliot, private, Boscawen, New Hampshire, enlisted May 8, 1775, and served three months and one day. On page 182 of Volume I we find a paper dated at Medford, Massachusetts, October 4, 1775. In this John Elliot is one of forty-one men of Capt. Joshua Abbot's Company, each of whom acknowledges receiving four dollars for the regimental coat "promised us by the Colony of New Hampshire."

John Elliot married, about 1743, Ruth Flanders, daughter of Deacon Jacob and Mercy (Clough) Flanders, originally from South Hampton, New Hampshire. Deacon Jacob Flanders was one of the twenty-seven original settlers of Boscawen or "Contucook" in 1734. His name constantly appears in the early records. Deacon Jacob Flanders was the son of Corporal John Flanders, born Salisbury, Massachusetts, February 11, 1659, and the grandson

of Stephen Flanders, the pioneer immigrant, who settled in Salisbury before 1646. Corporal John Flanders, at the age of seventeen, took part in the fight at Turner's Falls, Massachusetts, May 19, 1676. The primitive conditions under which the early settlers of Boscawen lived are shown by the fact that no record of the birth, marriage or death of Ruth Flanders can be found, though complete records are on file of the three earlier generations of the Flanders family when they lived in the old sea-coast towns of Salisbury and South Hampton.

There is no record of the death of John Elliot.

- (2) JOHN² (John¹) was born at the Fort at the south end of the "Plain," Boscawen, New Hampshire, in 1744. It was during the troublous times of the Indian raids, and his parents had fled to the garrison for protection. His early life, after the return from Durham, was probably passed at his father's farm on Water street. In company with his father he signed the Declaration of the People against the Boston Port Bill, 1772, and also the Articles of Association, June 3, 1776. In the former document the signature is John Elliott, as distinguished from his father, who spelled his name with one t; in the latter document the signature is John Elliot, jr.

When the Baptist church was formed at Salisbury Center, June 23, 1789, the names of John, Nicholas and Joseph Elliott are found in the list of seventy-six persons who signed the covenant. In June, 1821, John² Elliott was one of several petitioners to the Grand Lodge of Masons of New Hampshire for the formation of a lodge in the town of Salisbury, New Hampshire, to be known as Samaritan Lodge, No. 36. On the institution of this lodge in May, 1822, he was made Junior Deacon.

John² Elliott was twice married, was the father of thirteen children, and died in his eighty-fourth year.

Married, first, about 1764, Temperance Durrill of Durham, New Hampshire. The dates of her birth and death are not recorded.

Married, second, September 11, 1781, Mrs. Susannah (Boynton) Welch of Newbury, Massachusetts. They were publicly posted August 4, 1781. She was the daughter of Enoch and Rachel (Foster) Boynton of Rowley, Massachusetts, and was born April 22, 1753. Her first husband was Charles Welch of Newbury, Massachusetts, whom she married October 29, 1776. By her marriage to John Elliott she had seven children, all of whom were born in Boscawen. She died in June, 1835, aged eightytwo years.

John² Elliott died February 18, 1827.

- (3) NICHOLAS² (John¹) was born at Boscawen, New Hampshire, in 1746, and passed almost sixty years of his life in that town. During the winter of 1775-6 he took part in the Siege of Boston; June 3, 1776, he signed the Articles of Association. In 1787 he taught school on Water street. In 1805 he went to Boston, Massachusetts, where he bought a tract of four hundred acres in Landaff, New Hampshire. This land he carried on with the aid of his sons till 1826 when he sold it and moved to Irasburgh, Orleans County, Vermont, where he died. After his death most of the family returned to New Hampshire.

Married at Boscawen, Betsey Flanders, daughter of John and Eunice (Jackman) Flanders, who was born at Boscawen, June 3, 1755. They were publicly posted February 22, 1776. She died at Waterford, Vermont, August 8, 1836, aged eighty-one years, two months, five days.

- (4) ROBERT² (John¹) was born in Boscawen not before 1748. He early identified himself with his native town, as is shown by his signing the Articles of Association, June 3, 1776. He was the first of the family to leave home; and late in the year 1778 he removed to Coventry, now Benton, New Hampshire. He made his clearing on the Meadows in the southwestern part of the town near the Haverhill line. The place is now High street. The town was still a wilderness in 1812, but of the thirty-threemen living there then Robert Elliott is credited with five acres of arable land, four of mowing and ten of pasturage. Probably he had more of virgin forest. He headed a petition of ten names, asking for the first town-meeting, which was held at the house of Major Jonathan Hale, December 30, 1801. In 1803 Robert Elliott appears as a tythingman; and it is said that he was the first man in town to "team" to Boston with an ox-team. In December, 1838,

he was one of five to organize a Methodist church in East Haverhill.

Married Hannah Bowley, daughter of ——— Bowley of Haverhill, who died at Haverhill, October 12, 1828, aged seventy-nine years.

Robert Elliott died at Benton in November, 1841.

- (5) OLIVE² (John¹) was born at Durham, New Hampshire, August 24, 1750. On January 8, 1772, she married William Danforth of Boscawen, who was born there, August 18, 1748. He was the son of William Danforth, one of the pioneers of the Boscawen settlement in 1734 and the great-grandson of William Danforth of Newbury, Massachusetts, who migrated to this country in 1667. William Danforth was a corporal in Capt. Samuel Atkinson's company at Coös in Haverhill, New Hampshire, December 1,

1776. He was also a sergeant in Capt. Parker Kimball's company, Colonel Stickney's regiment, which joined the Continental Army at Bennington and Stillwater.

Olive (Elliot) Danforth died at Boscawen, October 13, 1838. William Danforth died November 12, 1840.

(6) OLIVE³ (John², John¹,) was born at Boscawen in 1765. On March 8, 1785, she married Major Stephen Bohonon of Salisbury, New Hampshire, grandson of Andrew Bohonon, one of the pioneer settlers of Boscawen in 1734. Stephen Bohonon was a first cousin of Daniel Webster, being the eldest son of Ensign Andrew Bohonon and Susannah Webster, sister of Judge Ebenezer Webster, father of Daniel. Andrew Bohonon was a first cousin of Olive Elliot as their mothers were sisters. When less than sixteen years of age Stephen Bohonon, at the instance of his uncle, Capt. Ebenezer Webster, enlisted in the Revolution. where his father was already serving. Father and son fought together at the battle of Bennington. Later Stephen Bohonon served with Captain Webster at West Point when the treachery of Arnold was discovered. Webster had the distinguished honor of being selected to guard Washington's headquarters the night following the discovery. Bohonon walked before the tent all night, and said Washington did not once lie down, but was employed in writing throughout the night. Major Stephen Bohonon kept the first store at Salisbury South Road (the main village). Afterward he lived for several vears at Chelsea, Vermont, where he was a magistrate, town clerk in 1791 and representative in 1796. The last twenty years of his life were spent in Salisbury. the village of his birth. The New Hampshire Patriot, in a lengthy notice of his death, says: "His funeral was attended by a large concourse of citizens, among whom were eight soldiers of the Revolution, each nearly eighty years of age."

Olive (Elliot) Bohonon died at Salisbury, New Hampshire, June 10, 1843. Major Stephen Bohonon died at Salisbury, January 26, 1831.

(7) DURRILL³ (John², John¹) was born in Boscawen about 1766. He was a man of excellent judgment and ability and in religion a Congregationalist. He married Betsey Bean, daughter of Esquire Joseph Bean, a wealthy and influential resident of Salisbury. At the time of the wedding it was said they were the handsomest couple ever married in town. Esquire Bean gave to each of his children a farm. The one given to Betsey was in Salisbury, just across the line from Boscawen, adjoining that of her father-in-law,

John² Elliot. The house, which is still standing (1918), is situated on a beautiful height, commanding a magnificent view.

Durrill Elliot died at Salisbury, New Hampshire, during the summer of 1825 or 1826. Betsey (Bean) Elliot died at Fort Covington, New York, in September, 1845. Their eight children were all born in Salisbury.

These three and others used to have great political discussions at the store. David Elliot always stoutly maintained the principles of Jeffersonian Democracy to which faith he was devoted. He was a member of the Christian Baptist Church.

Married in 1800 Susannah Carter, born May 25, 1782, youngest of the twelve children of Lieutenant Winthrop and Susannah (Eastman) Carter of Boscawen. Lieutenant Carter was one of the leading men of his day. He served from April 28 to October 21, 1755, in Capt. Joseph Eastman's company, Col. Joseph Blanchard's regiment, in the expedition against Forts Du Quesne, Niagara and Crown Point. During

the Revolution he was second lieutenant in Col. Thomas Stickney's regiment, raised January 20, 1776. He was lieutenant in Capt. Ebenezer Webster's company in Col. Moses Nichols' regiment, which joined the Continental Army at West Point in 1780. He served in this company from June 29 to October 25. Maj. Stephen Bohonon, who married Olive Elliot, David's elder sister, was also a member of this company. Lieutenant Carter was a large land-holder in Boscawen and Canterbury. Beginning with 1790 he kept tavern at Boscawen Plain in the house later owned by Nathaniel S. Webster. He was elected selectman in 1771, 1796 and 1797.

About 1836 he sold his farm, which he had bought seven years previous, to his son Lyman, and removed to Lisbon, the adjoining town. Here he bought a farm on which he lived a number of years. finally selling it to Brewster Young. He then bought the tayern, which stood a few rods above the Moses K. Little place on the north side of the highway that years ago led to the ferry. This he kept for a short time, being succeeded by his son, Jacob Blaisdel, and then by another son, Lyman, who conducted the tavern till it was destroyed in 1851. Nicholas Elliot then went to live with his son, Jacob Blaisdel, in the McIntyre house, second above the Salmon Hole brook on the east side of the river. The last year or two of his life he spent at the home of his son Lyman in Landaff. In a school record of District No. 3 of the town of Landaff is the following: "Nicholas Elliot made moderator in 1822; furnished board for the school teacher at 42 cents per week; and in 1829, 1830 and 1831 was a member of the school board."

He first attended the district school and afterwards fitted for college at Salisbury Academy. An old program of a public exhibition at this academy, August 20, 1819, shows that J. S. Elliot took part in three dialogues during the morning session and in one dialogue during the afternoon (History of Salisbury, pp. 213, 214, 215). J. S. Elliot began the study of medicine with Dr. Austin George of Boscawen, August 11, 1822. attended his first course of lectures at Dartmouth College and his second at Jefferson Medical College, Philadelphia. He was graduated from the Dartmouth Medical School in 1825, receiving therefrom the degree of M. D. In 1826 he began the practice of medicine at Strafford, Vermont, and continued there till 1829 when he moved to Pittsfield, New Hampshire. On August 1, 1839, he received a commission as surgeon of the Eighteenth Regiment of Militia in New Hampshire from Governor John Page. This document is still preserved by his grandchildren at the old home in Manchester.

In 1844 Dr. Elliot removed to Manchester, New Hampshire where he lived until his death, twenty-two years later. Dr. Elliot was accounted one of the skillful practitioners of his time. Beside his pro-

fessional ability he also possessed remarkable sagacity, shrewdness and foresight in business matters shown by his accumulation of a handsome property. Politically he was a Democrat of the most unswerving type, but the exacting demands of a busy professional life precluded his holding public office.

In her will Dr. Elliot's widow, after making numerous charitable bequests, left the residue of her estate, subject to the death of her mother, Mrs. Batchelder, for the establishment in the city of Manchester of a hospital to be known as the Mary Elliot Hospital. The bequest at the time of Mrs. Elliot's death amounted to about \$60,000. This was the first considerable private benefaction given to the city of Manchester; and the institution was one of the first general hospitals to be established in the state. Representatives of six of the leading Protestant churches, together with the mayor and president of the Common Council, ex officiis, were constituted a board of trustees.

The hospital was incorporated July 21, 1881, but no steps could be taken to carry out the project till after the death of Mrs. Batchelder, which occurred in July, 1884. In March, 1886, the trustees purchased for \$7,600 the Robert Hall estate of twenty-seven acres, a sightly elevation about a mile and a half southeast of the City Hall. Meanwhile the fund was accumulating, and when the hospital was formally opened, April 17, 1890, the total assets amounted to \$84,655 of which \$42,470 had been invested in site, buildings and furnishings.

The hospital has proved itself such a valuable institution that other gifts and bequests have been made so that the report of 1915 gives the assets at \$150,431. The main building has seventeen private rooms for patients beside two wards containing seven beds each. A maternity wing, accommodating twelve patients, is the gift of Mrs. Frank P. Carpenter and her sister, Mrs. L. Melville French; and the nurses' home and the endowment for the operating room are due to the generosity of Miss Emily Smith.

In 1826 he went with his father to Vermont, but remained there a few years only when he came back to New Hampshire and settled in Manchester. This was about 1830. In Manchester he learned the trade of a mason, which he followed ever after. In November, 1849, he moved to Henniker from which place, October 12, 1861, he enlisted in the Civil War as a private in Company E, Seventh Regiment, New Hampshire Volunteers. He was past fifty-seven when he enlisted, and he served from November 7, 1861 to December 22, 1864 when he was mustered out. Beside serving himself he gave his only son to the cause. John S. Elliott was an honored member of Senator Grimes Post, G. A. R., Number 25, who turned out in a body at his funeral. At the time of his death he was the oldest veteran in the state, and with one exception, in the United States. He died at the age of eighty-four while on a visit to friends in Lisbon.

"He is a man thoroughly practical, of sound judgment, and invariably correct in his opinion touching values of land and other property." The people in his neighborhood constantly asked him to make their wills, preferring him to a regular lawyer. His

charges were light and his wills were never broken by the courts, though there were occasional contests. Many people, knowing that they were near their end, would ask him to draw up a will for them, according to his own judgment, giving them an opportunity to alter the first draft, if necessary. In many cases no changes were made.

Charles P. Elliott greatly enjoyed thinking out knotty problems and planning about social betterment. Eminently fitted for public office, he was never elected to any because his party was not in the ascendant. In religion he was a Presbyterian. He was a man of large size and at the age of seventy-three weighed three hundred pounds.

- (68) GEORGE FRANCIS⁵ (Dr. John S.⁴, John³, John², John¹) was born at Pittsfield, New Hampshire, July 14, 1844. When an infant of five months his parents moved to Manchester, New Hampshire, and that city became his permanent home till his death at the age of sixty-one years. He was educated at the North Grammar School and the old High School. After leaving school he began the study of medicine with his father, but abandoned this for business pur-

suits. During early life he conducted a large farm in Bedford for his father, thus acquiring valuable experience in handling real estate, which was his chief occupation during his later years. He inherited a handsome property, also his father's sagacity about money matters, and at the time of his death was one of the heaviest individual taxpayers in Manchester. For years he was a trustee of the People's Savings Bank.

Mr. Elliot travelled extensively, both at home and abroad; he read much, and was an interesting talker. He was especially well informed concerning the history of Manchester. He was one of the earliest members of the Amoskeag Veterans, of which organization he became first lieutenant. It is worth noting that this somewhat celebrated military company was formed in the office of his father, Dr. John S. Elliot. George F. was a member of the Manchester Old Residents' Association. He was a thirty-second degree Mason and a member of the Manchester Lodge of Elks. He was stricken with paralysis while attending a meeting of the Scottish Rite Masons at Nashua in April, 1905. He partially recovered from the first shock; but on July 10 he received a second stroke, which resulted in his death on October 6 of that year.

Married, at Manchester, November 7, 1868, Lucina M. Blake, born in Lunenburg, Vermont, November 17, 1847, the daughter of Thomas and Lucy (Adams) Blake of Danville, Vermont.

George F. Elliot died at Manchester, October 6, 1905.

From 1855 to 1857 he was engaged in the service on the Pacific Coast frontier, where he remained in connection with the defences of San Francisco until 1870.

In 1870-1 he was in charge of the construction of

the aqueduct at Washington, District of Columbia. He was Engineer Secretary of the Lighthouse Board, 1870-4; and later, Assistant to the Chief of Engineers in Washington, District of Columbia. In 1874 he published "The Presidio of San Francisco, California, and Lighthouse Establishments in Europe," embodying the results of an inspection in 1873. At the time of his death he was engaged in collecting facts and figures preparatory to publishing a history of the Elliott Family.

She received her education in the public schools of her native town, then called Sanbornton Bridge; and also at Miss Maria Eastman's Select School in Concord, New Hampshire. Later she taught both in public and private schools. In 1854 she went to the Pacific Coast, sailing from New York in company with Mr. John Wesley Ladd, a brother of her future husband, and with Mrs. Reed, whose husband was a business associate of Mr. W. S. Ladd in Portland, Oregon. They crossed the Isthmus, not by canal, but on mule-back; thence sailed for San Francisco where they met W. S. Ladd and Mr. Reed.

On October 17, 1854, Caroline A. Elliott and William Sargent Ladd were married, going soon after to their permanent home in Portland, Oregon. liam S. Ladd was the eldest son of Dr. Nathaniel Gould Ladd, who practiced his profession at Sanbornton Bridge (Tilton), New Hampshire, 1835-1864, and was the founder of the Ladd chair of Moral Philosophy in Tilton Seminary. William S. Ladd was born at Holland, Vermont, in 1826; but his youth was spent at Tilton, New Hampshire, where he was appointed station agent of the Boston, Concord and Montreal Railroad. Upon migrating to Portland, Oregon, in 1851 he was at first engaged in mercantile business; but in 1859 he founded the well-known banking house of Ladd and Tilton with Charles E. Tilton of Tilton, New Hampshire, as junior partner. Mr. Ladd did more than any other man to build up Portland as the leading city of the Northwest by making it the terminal of the Northern

Pacific, Central Pacific and Union Pacific Railroads. He was the first mayor of Portland and became one of the wealthiest and most influential men in the city. In 1875, while returning from a visit East, William S. Ladd was stricken with paralysis; but his indomitable energy enabled him, though partially incapacitated, to continue in business until his death, January 6, 1893.

The following in relation to Mrs. Ladd is condensed from the Portland Oregonian, October 24, 1909: "Mrs. Ladd was an active and devoted member of the Presbyterian church. She supported the church and its auxiliary societies with liberal subscriptions; but it was the cause of missions to which she was strongly committed. . . . The contributions of Mrs. Ladd to foreign missions alone amounted to several thousand dollars annually. For twenty-one years, from the time of its organization till her death, Mrs. Ladd was annually elected president of the Woman's North Pacific Presbyterian Board of Missions. Beside contributing liberally to the general fund Mrs. Ladd personally supported four missionaries in Korea, and also built a hospital there." Mr. Ladd attributed his success "largely to the encouragement and coöperation of his faithful helpmate, who was also one of the state's builders."

At the time of Mrs. Ladd's death the corresponding secretary of the North Pacific Board said: "She was an example to us all in patience, charity and punctuality. . . . Hundreds of women engaged in missionary work all over the Pacific Northwest loved and revered her. Her beautiful life has been one of the greatest inspirations I have ever known."

Caroline A. (Elliott) Ladd died at her home, 293 Sixth street, Portland, Oregon, October 23, 1909.

The eldest daughter, Caroline Augusta Elliott, became a member of the family of

Captain Joseph Ames of Boscawen, whose wife, the eldest sister of Mrs. Ira Elliott, had died June 18, 1827. Frances Susan Elliott had previously been adopted by another sister, Mrs. Phebe Ames Moody of Concord, New Hampshire.

Charles Ira Elliott, then nine years of age, lived several years with a cousin, Albert Ames of East Canterbury, New Hampshire, receiving his education in the public schools of that town and at Pembroke Academy. When he became of age he entered the Concord Railroad shops under the direction of his cousin. John Kimball, then master mechanic; later Charles I. Elliott was appointed foreman of the car department. Some time in the late fifties he went to California, entering the employ of A. E. and C. E. Tilton in San Francisco. Subsequently Mr. Elliott went to Portland, Oregon, where he became associated in mercantile business with his brother-in-law, William S. Ladd. Later the business was transferred to the Dalles, a few miles down the Willamette river, where he remained till his death, the result of an accident,

The following obituary is taken from a local paper: "Died at the Dalles, on the 29th ult., Charles I. Elliott, in the 33d year of his age. Deceased was a native of New Hampshire, but for the last two years has resided at this place.

"The details of the terrible accident that led to the death of Mr. E. our readers are already familiar with. Of how patiently and meekly he bore his sufferings it is scarcely our province to speak. Throughout his illness he enjoyed the unwearied attentions of kind friends, and although he died far from the scenes of his childhood he lacked nothing. that could minister to his comfort. With him strangers supplied the place of relatives, and when the last sad scene was over, it was

'By foreign hands his dying eyes were closed, By foreign hands his decent limbs composed, By foreign hands his humble grave adorned.'

"His funeral was numerously attended, and his remains committed to the grave with all the solemnities appropriate to the occasion. Of our unfortunate friend thus untimely stricken down it may truly be said that

'None knew him but to love him, None named him but to praise.'"

In 1886, while his sisters, Mrs. D. J. Neal and Mrs. B. A. Kimball were visiting Portland, Mr. Elliott's remains were removed from the Dalles to Riverside cemetery in Portland, and placed in the lot of his brother-in-law, William S. Ladd.

Charles I. Elliott died August 29, 1861, at the Dalles, Oregon, from the effects of accidental burning.

(73) FRANCES SUSAN⁵ (Ira⁴, David³, John², John¹) was born at Sanbornton Bridge, now Tilton, New Hampshire, March 27, 1832, and it was in this neighborhood that her early childhood was passed. Her father, Ira Elliott, died when she was six years of age, but Frances had previously taken up her residence in Concord, New Hampshire, with her aunt, Mrs. Charles Moody. Here a natural refinement and unusual intelligence were developed by her environment, and an excellent education was obtained

in the select schools of the Misses Ely and of Miss Maria Eastman at Concord.

Frances S. Elliott (Moody) was married in Concord, August 31, 1855, to Darius J. Neal, a native of Meredith, New Hampshire. They made their home at Albany, Wisconsin, where Mr. Neal was engaged in grain and cattle shipping. Here they remained till the winter of 1859-60 when they removed to Chicago, where Mr. Neal engaged in the tanning business in which he continued till the plant was destroyed by the Great Fire of 1871. Mr. Neal soon entered upon the fuel business, which engaged his attention up to the time of his death in 1908.

Joining the First Congregational church at Concord in youth, Mrs. Neal kept to that faith through life, transferring her membership to the church at Albany, Wisconsin, and afterwards to Plymouth Congregational church in Chicago. Of the best New England type she was a woman of high ideals, a devoted mother and a lover of home and the family. Hospitable, generous, modest, she made a host of friends by her sterling worth. Though never of robust health she gave liberally of her strength and time to church work up to the period of her last illness.

After months of suffering Frances Susan (Elliott) Neal died at Chicago, Illinois, October 23, 1893. She rests in the family lot at Oakwood cemetery, Chicago.

The following biographical sketch of Mrs. Kimball is taken from American Families of Historic Lineage, a work in several volumes, published by the National Americana Society, New York, in 1916:

"She was educated in the local schools and at McCollom Institute, Mont Vernon, New Hampshire. For several years she was a teacher in the public schools of Concord. Her marriage to Mr. Kimball in 1861 closed this portion of her career. By reason of delicate health, Mrs. Kimball has been obliged to lead a somewhat secluded life, but she possesses an organizing mind which directs to farreaching results. Mr. Kimball relies upon her

judgment in matters affecting their mutual interests. Mrs. Kimball's cultivated taste is reflected in the interiors of both the summer and winter homes. The choice collection of modern paintings, statuary and art treasures of every description, as well as the valuable library, have been assembled under her supervision in collaboration with that of her husband; and they constitute a collection without an equal in the state. Mrs. Kimball's life has been spent in doing good, and she has blessed not only the home, but the community in which she has lived. Her benevolence is unceasing, but so quietly exercised that only the recipients ever know its extent."

The following is extracted from a lengthy article on Benjamin Ames Kimball in Volume XVI of The National Cyclopedia of American Biography:

"In 1899 he was one of a commission of five to procure plans for and construct the New Hampshire state library building, and he was chairman of the committee which secured the building of the New Hampshire Historical Society, donated by his friend Edward Tuck [of Paris, France]. With his brother John Kimball and Frank L. Gerrish he gave a beautiful library to his native town of Boscawen [1913].

enial kindliness of bearing toward those who come in active contact with him, he has maintained the respect of those with whom he has sometimes differed in questions of railroad management. His preëminent position in the railroad world of New Hampshire is due to his commanding ability, his strict integrity and his untiring energy. To him, more than to any other one man, is due the upbuilding of a great railroad system which became an important factor in the past, present and future of New England."

The following in regard to Benjamin Ames Kimball is taken from Volume V, Stackpole's *History of New Hampshire*, published by the American Historical Society:

"He was father of many of the comprehensive measures which when brought to completion constituted the Concord and Montreal so potent a factor in the growth and prosperity of New Hampshire. He was liberal in his planning for expansion and his management always called for the conserving of the best interests of the localities traversed by his subsidiary roads and branches. . . . In his relation to the public Mr. Kimball is conscientious in the discharge of his duties and generous in the support of all forward movements. He has ever maintained personal and friendly relations with his associates and the men in his employ. His friendly greetings. words of sympathetic kindness and often substantial aid in time of need are treasured memories with many employees of the corporations he governs. . . . He has ever cherished a warm love for his alma mater and was most active and influential in the negotiations which finally resulted in the complete consolidation of the Chandler Scientific School with Dartmouth College. . . . Possessed of a vigorous mind disciplined and strengthened by education and experience, Mr. Kimball has been a leader in all that tends to the public good and can review his long life with the satisfaction which attends every duty performed. . . . He has travelled widely at home and abroad [fifteen European journevsl while his valuable private library and artistic adornment of his home bespeak the literary and cultured tastes of the owner. Concord is his winter home, 'The Broads' on the shore of Lake Winnepesaukee the attractive country estate."

The following sketch of Henry A. Kimball is taken from the Genealogical and Family History of the State of New Hampshire, Lewis Publishing Company, New York, 1908. See Volume I, page 9:

"His early education was under the direction of a tutor. Later he pursued a preparatory course of study at Phillips Andover Academy, then under the direction of Rev. Cecil F. P. Bancroft, LL. D. . . . He renewed his study under the instruction of an accomplished tutor with whom he studied and travelled in Europe, visiting many places of historic interest in England and on the Continent. While in London in 1887 he was admitted, on examination, a fellow of the Society of Science, Letters and Art. . . . He is and for several years has been a partner and associate manager of the firm of Ford and Kimball and of the Cushman Electric Light Company. He is a member and recording secretary of the New Hampshire Historical Society, and for many years he has been an interested and active member of the Young Men's Christian Association" of which he is a director. He is a Republican in politics, a member of the South Congregational church, Concord, a trustee of the Merrimack County Savings Bank and a director of the Mount Washington railroad. He belongs to the Sons of the American Revolution and to the Society of Colonial Wars.

(75) HENRY AMES⁵ (Ira⁴, David³, John², John¹) was born at Northfield, New Hampshire, August 25, 1837. After the death of his father Henry A. Elliott lived with his mother in Boscawen, removing with her to the neighboring town of Canterbury upon her second marriage in 1845. Here he remained till he was about sixteen years of age, getting his education in the public schools. In 1853 he entered the employ of Henry Newhall, a dry goods merchant of Concord, New Hampshire. Later he went to Albany, Wisconsin, where his sister, Mrs. D. J. Neal, was at that time living. While there he was appointed mail agent between Milwaukee and La Crosse.

In 1863 Henry A. Elliott went to the Pacific Coast, engaging for a time in mercantile business at Portland, Oregon, under the firm name of Wadhams and Elliott. In the fall of 1889 he went to San Francisco, California, where he entered the employ of Oliphant and Company, merchandise brokers. Later he returned to Portland, becoming real estate agent for Ladd and Tilton, bankers. This position he held until ill health compelled him to give up active business.

While in Milwaukee, Wisconsin, Henry A. Elliott met Miss Helen L. Adams of Morrisville, New York. On January 30, 1882, they were married at the home of her brother in Omaha, Nebraska. She survived her husband but a few weeks, dying in Tustin, California, August 19, 1903. She was buried beside him in Riverside cemetery, Portland, Oregon.

Henry Ames Elliott died in Portland, Oregon, June 1, 1903.

This mansion with its beautiful furnishing he converted into a house of entertainment called Elliott Hall. After his death this establishment, which attracted a limited and choice class of guests, was managed by his widow.

Meetings of the society are held in the Elliott Hall annex which was rebuilt by her to be used for that purpose. By her death the society has lost a valuable member and the town an energetic woman who was vitally interested in the doings of the day. . . .
