1621—Christian Penn, from James City to Plymouth, Mass.

1621—Robt. Penn (aged 22), passenger on "Abigail" to Capt. Matthew's Plantation, James City.

1635—Wm. Penn (aged 26), passenger on "Merchants Hope" to Virginia.

1635—Francis Penn (aged 22), passenger on "Matthew" to St. Christopher.

1676—John Penn, of (Old) Rappahannock county. Will proved Jan. 13, 1676-May 3, 1677. No children mentioned.

1685—Geo. Penn transported to Barbadoes—Monmouth's Rebellion.

1685—John Penn transported to Barbadoes—Monmouth's Rebellion.

1730—Geo. Penn, of Caroline county. Drysdale Parish.

1739—Deed to Joseph Penn, of Drysdale Parish, Caroline county.

1746—Deed to John Penn, of Drysdale Parish. Witness, Moses Penn.

1746—Deed to Geo. Penn, of Drysdale Parish. Witness, Moses Penn.

1761—Deed of Joseph (x) Penn, of Spottsylvania county, and Elizabeth, his wife, to John Penn.

1763—Deed, Sept. 3, Joseph Penn, of Spottsylvania county, to John Taylor, of Caroline county, in trust for the purposes hereinafter named. Slaves, lands, stocks, etc. For the said Joseph Penn during his natural life, then to his son, Philip Penn, son Moses Penn, son Thos. Penn; dau. Catharine, wife of Larkin Gatewood; dau. Mary, dau. Frances, wife Elizabeth Penn. "John, Philip, Moses, Thos., Catharine, Mary and Frances, children of said Joseph."

1764—Deed, Apr. 20, Gabriel Penn, of Amherst county, and Sarah, his wife, to John Penn, of Spottsylvania county. Witness, John Penn, Jr., Thos. Penn.

1771—May 13, will of John Penn, Spottsylvania county; wife, Mary; children, John, Thomas, George, William, Mildred, Sally and Frances.

1773—Jan. 21, Philip Penn, of Spottsylvania county, to ———, Merchants of Glasgow. Mortgage left the said Philip Penn by his father, Joseph Penn, dec'd, etc.

According to Mr. Joseph Penn (dec'd 1906-14) Moses Penn m. Katherine Taylor, of Caroline county. In his and his son's possessions (Mr. John Penn, of Martinsville, Va.) are the

to New Orleans, from which district his eldest son went to Congress. Several children.

2. Lucinda Penn, b. Sept. 3, 1771; m. Samuel Staples, Clerk of Patrick county for many years.

3. Gabriel Penn, b. Nov. 14, 1773; m. Miss Jinsy Clark, of Patrick county, where he lived and died.

4. Horatio Penn, b. Nov. 14, 1775; m. Nancy Parr; had several children, and moved to Missouri.

5. Polly Penn, b. July 1, 1777; m. Charles Foster, of Patrick county. Several children, and died in Patrick county.

6. Greenesville Penn, b. May 16, 1779; m. a Miss Leath, of Manchester, Va.; 2, Miss Martha Reed, of Bedford county, Va. Two sons went to Edgefield, Va.

7. Thomas Penn, b. June 15, 1781; m. 1st Miss Frances Leath, of Manchester, Va.; 2d, Miss Mary Christian Kennerly, of Amherst county, Va.

8. Abram Penn, b. March 14, 1783; m. Miss Sally Kreitz (or Critz), and had several children; moved to Tennessee, and died.

9. James Penn, b. Jan. 31, 1785; m. 1st, Miss Leath, of Manchester, Va.; 2d, Miss Mary Shelton, dau. of William and Pattie (Dillard) Shelton. Had several children, and died in Patrick county. Note.—Pattie Dillard, dau. of Col. John Dillard (d. 1822) and his

wife, Sarah Dillard. Sarah (Stovall) Dillard was sister of Col. Abraham Penn's wife.

10. Luvenia Penn, b. Jan. 8, 1787; died young.

11. Edmund Penn, b. Jan. 9, 1789; m. Miss Pollie Ferris, of Patrick county. Moved to Kentucky and died there, leaving a family.

12. Philip Penn, b. Mar. 5, 1792; m. Miss Louise Briscoe, of Bedford county.

COL. ABRAHAM PENN, B. 1743; D. 1801; M. 1768

April, 1778—The first court held for Henry county was Apr. 20, 1778, and was composed of Edmund Lyne, Abraham Penn, Peter Saunder and George Waller, Justices.

Oct., 1778—Abraham Penn is appointed Lieut. Col. in the room of Ed Lyne, resigned.

Mar., 1779—Abraham Penn is appointed Escheator for Henry county.

Aug., 1779—Patrick Henry, Abraham Penn, John Dillard, etc., are recommended to his excellency, the Governor, as proper persons to serve on the Commission of the Peace of this County.

Aug., 1779—Abraham Penn is appointed Burser to receive fines.

Mar., 1780—Abraham Penn, Esq., Lieut. Col., advanced to the office of Colonel, Henry county Militia.

July, 1780—Col. Abraham Penn recommended as county lieut.

June, 1781—Abraham Penn produced a commission as Coroner of County.

Dec., 1781—Archalaus Hughes and Abraham Penn, Esqs., are appointed to "settle the depreciation of what money run at after June, 1781, and make report."

Henry County Records.

1799—Patrick county, 3156 acres granted to Geo. Penn; 270 acres granted to Abram Penn.
