ABRAHAM MILLER of Northampton County, Pennsylvania; *b.* in Holland; *d.* 1752 in Northampton County; emigrated from Holland to Northampton County (formerly a part of Bucks County) in 1740; was a large land owner, much of which he purchased from Richard PETERS; *m.* in Holland (wife's name is not given).

CAPT. ABRAHAM MILLER of Southport (Elmira), New York; *b.* 1st April, 1735 in Holland; *d.* 25th July, 1815, in Tioga County, New York; removed to Southport New York, from Mount Bethel, Pennsylvania, in the spring of 1788; served in French and Indian Wars as non-commissioned officer; member committee from Northampton County, December, 1774; recruiting officer at Easton, June, 1775; Captain of MILLER's Company of THOMPSON's Pennsylvania Rifle Battalion, 25th June, 1775; Captain of Pennsylvania Militia, 1776; member Constitutional Convention, 15th July, 1776; first Judge of Tioga County, New York, by appointment of Governor CLINTON 17th February, 1791; 27th October, 1788, had patent No 113 for 1000 acres in the town of Southport; *m.* Winifrede McDOWELL, dau. of John McDOWELL of Hamilton Township, Northampton County, Pennsylvania.

JUDGE JOHN MILLER of Elmira, Tioga County, New York; *b.* 1760, in Northampton County, Pennsylvania; *d.* 13th April, 1833, in Tioga County, New York; was appointed first Judge 3d April, 1807, and held office until 31st March, 1810; was private in his father's company June, 1775, afterwards served in same company when it became part of First Pennsylvania Continental Line; member New York Assembly, 1804-1807; invested in Indiana lands and was member Indiana Legislature from Clark County, 1820-1821; *m.* Hannah BIRNEY.

ABRAHAM MILLER of Clark County, Indiana; *b.* 9th April, 1787, in Luzern County, Pennsylvania; *d.* 22d April, 1867, in Clark County; served in the Black Hawk War and was wounded at the battle of Tippecanoe; member City Council Jeffersonville, Clark County, Indiana, 1841-1844; served in United States naval forces on Ohio, Mississippi and Red Rivers, 1862-1865; honorably discharged by Admiral LEE at Mound City, Illinois, July, 1865; *m.* 24th August, 1842, Louisa OWEN, dau. of John and Rebecca (LOVE) OWEN of Jefferson County, Kentucky.
