Lineage

In the paternal line, this family derives from Alexander von Holstein, who came to America from Schlesgwig-Holstein, Germany, in 1830, a descendant from a noble family of Schlesgwig-Holstein; during the revolution in Germany he removed to the Lake Constance region, but soon came to America.
