JOHN BARRET HUNDLEY, Banker, educated in the public schools of Greensburg, Kentucky; Deputy Clerk in the Green Circuit Court from 1873 to 1877; read law during that time and was admitted to the bar in 1875; entered Bank of Kentucky, of Louisville, Kentucky, 5th November, 1877, where he has been continuously connected for the past thirty-nine years. A Director in the Robinson-Pettet (wholesale) Drug Company, was elected Director in 1900 of Louisville Gas Company; Member of the Board of Trustees of the Fourth Avenue Presbyterian Church, Louisville, Kentucky, and served as President of said board for fourteen years; Member of Finance Committee Louisville Commercial Club; Treasurer of the Sons American Revolution for a number of years, also elected President of said Society, June, 1913; October, 1913 and 1914.

JOSIAH HUNDLEY, II, of Amelia County, Virginia; *b.* 3d November, 1779; *d.* 9th November, 1850; was a planter; participated in the War of 1912; *m.* 3d February, 1806, Elizabeth Archer OGILBY, *b.* 1789, *d.* 25th July, 1837.

After the war, began the practice of his profession. In 1870 was elected to the Virginia Senate to represent the counties of Buckingham, Appomattox and Fluvanna. After the expiration of his term as Senator he moved to Richmond Virginia, and entered into partnership with ex-Governor Walker. In 1895 he was elected to the Legislature to represent the counties of Nottoway and Amelia. In May, 1898, was appointed by the Governor, Judge of the Third Judicial Circuit and was elected by

the Virginia Legislature, December, 1899. General HUNDLEY acquired his rank by appointment by the Governor in 1873, for his faithful service in the Virginia Volunteers; *m.* 5th October, 1881, Lucy Waller BOYD.

The year previous to graduation he was admitted to practice law and as soon as he was graduated entered at once upon a professional career in Green County, Kentucky, but the following spring a spirit of adventure and ambition led him to join with others in a trip to the El Dorado of the West. After an eventful overland journey Sacramento was reached in October, 1849, and a little more than a month later at Dry Creek the first search for gold was commenced. After mining in Nevada, Plumas and Butte Counties with varied success it was finally concluded that this life was not the most suitable for him, and consequently, in July, 1854, he was found in Plumas County settled down to the practice of the law, where he remained (a resident of Quincy, the county seat) for nine years, or until 1863. After that, until, July, 1869 he was occupied in following the legal profession at Virginia City, Nevada, at which time he removed to Oroville and on the 12th of the month opened his law office here. In 1861 while in

Plumas County he was elected District Attorney, and held the office until his removal to Nevada. In 1872 he was chosen to a like position in Butte County, where he served for two years. In 1878 upon the death of Judge SEXTON, he was appointed District Judge with jurisdiction in Tehama and Butte Counties, and when the new constitution was adopted he was elected to the position of Judge of Superior Court of the County, where he discharged his official duties for five years, declining a re-nomination. In fall of 1888 at the general election held to elect a successor to Judge Leon D. FREER, deceased, he was the choice of the Democratic party to fill the unexpired term and was elected to the position. In 1859 he was elected as a Democrat to the Legislature, where his services were marked by an honorable opposition to the Bulkhead bill; *m.* (firstly) 2d September, 1855, K. Taintor RUSSELL, *b.* 21st February, 1836, *d.* 14th March, 1889, daughter of Gen. Henry Pierrepont RUSSELL and Catherine Elkins MUSIER, dau. of John and Sarah (GUEST) MUSIER; *m.* (secondly) 12th December, 1889, Lucy R. BOBO, *d.* 21st April, 1917.

RICHARD OGILBY HUNDLEY of Greensburg, Kentucky; *b.* Amelia Court House, Amelia County, Virginia, 17th February, 1811; *d.* 24th January, 1881, in Greensburg, Kentucky; was a merchant-director in the Bank of Kentucky, Greensburg Branch, until 1861; appointed and qualified as Clerk of the Green Circuit Court 2d September, 1867; was an officer in the Methodist Church, also a Master Mason; *m.* 20th August, 1846, in Greensburg, Kentucky, Martha America (PATTIE) BARRET, *b.* 26th May, 1826; *d.* 27th July, 1899, dau. of John and Mary Walker (WOOD) BARRET (see BARRET).

The earliest information which we have, as yet been able to obtain of this particular family is that Robert BARRET "a dauntless sailor in the English Navy" is mentioned as being a Master of one of the ships of the fleet which Admiral Sir John HAWKINS commanded, and which sailed from Plymouth on the 2d October, 1595. This particular fleet consisted of six ships, namely, *The Jesus*, Admiral HAWKINS's flagship, Robert BARRET, Master; *The Mignon*, Capt. Thomas HAMPTON; *The William and John*, Capt. Thomas BOLTON, James GARNETT, Master; *The Judith*, Capt. (afterwards Sir) Francis DRAKE; *The Ang*, Master; *The Swallow*; he was evidently in the "West India Trade" and must have amassed more or less a fortune; *m.* Penelope GILBERT.
