JOHN BROWN MILTON, Rear-Admiral U. S. N., *b.* in Lexington, Ky., 25th Apr. 1848; *m.* in San Francisco, Cal., 20th Oct. 1880, Harriet Buchanan STEELE, dau. of James and Mattie (CUNNINGHAM) STEELE.

REAR-ADMIRAL JOHN BROWN MILTON graduated from the U. S. Naval Academy, Annapolis, Md., in 1870. In the regular routine of duties he served on various ships. During the Spanish-American War was on the U. S. gunboat "Scorpion," as executive officer, at the Battle of Manzanilla Bay, and after cessation of hostilities was executive officer of U. S. S. "Newark," flagship of Rear-Admiral SCHLEY. In command of U. S. S. "West Virginia," flagship of Asiatic Station in 1907; in command of the receiving ship "Independence," Navy Yard, Mare Island, Cal., in 1908-9. On 9th Jan. 1910, commissioned Rear-Admiral and ordered commandant of U. S. Training Station, San Francisco. In charge of branch U. S. Hydrographic Office, San Francisco, 1884-87. From 1890 to 1893, on duty at Naval Academy. Commandant U. S. Naval Station, Cavite, Philippine Islands, 1904-5. Light-house Inspector 12th Lighthouse District, 1901 to 1904. During the Civil War served at the front in a clerical capacity in the Military Division of the Mississippi, under the command of Major-General Eli LONG, U. S. Army.

Lineage

The ancestor of the family of MILTON of Virginia and Kentucky was Richard MILTON of Leicestershire, England, who emigrated to Virginia in the early part of the 17th century and settled at Westover, on the James River, Charles Co., Va., grant of land being recorded in his name as early as 1636. His wife's name is unknown, but he had a grandson, Richard MILTON, *d.* 1733, who moved to Richmond, Va., and in Aug. 1725, had a grant of 454 acres in Stafford Co., Va.; this part of Stafford Co. later was incorporated into Prince William Co.

RICHARD MILTON II, *d.* 1733, on the "Buck Hall branch of Occaquan." He removed from Charles to Richmond Co., Va. Was living in Richmond Co., 1720.

In Aug. 1725, had a grant of 454 acres in Stafford Co., Va., which section was incorporated into Prince William Co. *m.* Eliza ———.

ELIJAH MILTON, *b.* in Prince William Co., Va., 23d Dec. 1755; *d.* 1828. During the Revolutionary War as "Master of the Army Wagon Corps." After war, Count DE ROCHAMBEAU wished him to go to France and settle on one estate, but Elijah, preferring the wilderness of Kentucky, settled on Elk Creek, Fayette Co., Ky., and built a house there in 1807. *m.* in Frederick Co. 18th Jan. 1794, Catherine TAYLOR, dau. of Capt. William and Catherine (nee) TAYLOR.

BUSHROD TAYLOR, *b.* in Fayette Co., Ky., 10th Nov. 1807; *d.* in Henderson, Ky., Mar. 1899. Was for 26 years Treasurer of Lexington, Ky., and for 52 years an elder in the Presbyterian Church. *m.* 5th Dec. 1833, Mary CLAYPOOLE, a descendant of Oliver CROMWELL's dau.
