

## Lineage

The Quisenberry family of America are descended from Thomas QUEST: of England, who settled in Virginia in 1624; who was himself descended Heinrich QUESTENBERG of Cologne, Germany, who became a citizen of about 1468; he being of the elder branch of the family of Questenberg of Fahne's "Cologne, Julic and Berghish Families" says: "The Questenberg Cologne family which, remarkable as it is, rose in three generations from burghers to be Barons, Counts, and Imperial Counts." \*The English or elder branch of the Questenberg family became extinct in 1701. The Cologne branch became extinct in 1794; a younger branch that went to Austria became extinct in 1794 on the death of Count Johann Anthon von Questenberg, and a younger branch of the Austrian branch, that settled in Silesia, became extinct somewhat later. The American or elder branch now alone survives.

James Quisenberry (founder of the Kentucky branch of the family) Spottsylvania County, Va., 5th July, 1759; d. 5th August, 1830; in after having served in the Revolutionary War in the Orange County Militled in what is now Clark County, Kentucky; was for some time one garrison in the fort at Boonesboro, under Daniel Boone; was ordained a minister in Kentucky; m.
