(firstly) 10th August, 1789, Maria Symmes, b. 1763, Greenfield, Kentucky, 28th March, 1801, aet. 38 years, dau. of John Cleves Syx of New Jersey and Ohio, a descendant of Rev. Zachariah Symmes, who came in the Griffin, landing in Boston in 1634. John Cleves Symmes was b. 10th 1742, at Riverhead, Long Island, d. at Cincinnati 26th February, 1814; he rem to Flatsbrook, Sussex County, Long Island, and engaged in surveying; he Chairman Committee Safety, Sussex County, 1774; Colonel Sussex Regiment, : March, 1776, erected forts and battlements around New York and Long Isl

10th June, 1776, Delegate to New Jersey Convention, Member of Committee to draft state Constitution; covered Washington's retreat to Delaware; checked General Leslie in his advance on Philadelphia; with General Dickenson when he surprised the British on Staten Island; at Red Bank; at Battle of Monmouth, where he had three horses shot from under him; Lieutenant Governor of New Jersey, one year; Member of Council, six years; in 1777 Associate Judge Supreme Court, New Jersey, twelve years; 1786 Member of Congress from New Jersey; with Gen. James Mitchell Varnum and Gen. Sam Holden Parsons appointed Judge Supreme Court of Northwest Territory (north of the Ohio); took possession of Symmes Purchase in 1789 (purchased 1,000,000 acres from the United States between the Miami Rivers, north of the Ohio, including the present site of Cincinnati), on General St. Claire's Staff; buried at North Bend, Ohio. His wife, Anna Tuthill, who d. 1776, was the mother of Maria Symmes, who m. Peyton Short. Her ancestry goes back to Egbert, first King of the English, through Joan Grafton, who m. her ancestor Richard TUTHILL, son of William TOTTYL, Sheriff of Devonshire, 1549, and Mayor of Exeter, 1552. Peyton Short m. (second) Mrs. Jane Church-ILL, 14th November, 1802, at Lamington, New Jersey, b. March, 1768, d. 3d, May 1808, widow of Armisted Churchill.

ROBERT WILSON SHUFELDT, M.D., Naturalist and Author of numerous lications, was a student at Cornell University, class of 1874; served in the Fe Navy in the Civil War in 1864-1865 in East Gulf Squadron; Captain's Secre United States gunboat Proteus, 1864; First Lieutenant Medical Corps, U. eth August, 1876; Captain, 1881; Major, 23d April, 1904; Surgeon with Ge MERRITT, CROOK and SHERIDAN in Frontier Indian Wars, 1876-1881; in cha section of comparative anatomy, Army Medical Museum, 1882; Honorable Cu Smithsonian Institution, Washington, D. C., under BAIRD and later Association Zoölogy, Smithsonian Institution; later in the 80's was ordered to Fort Win New Mexico, as post surgeon; remaining there nearly six years, during which a large number of his scientific papers were prepared and published, includi "Myology of the Raven;" from this service was brought before a retiring boar duly placed (in 1801) on the retired list of the Army; Judge at World's Colu Exposition at Chicago, 1893; resided in New York City, 1901-1908, prosec special studies in science and art.
