I Richard Skaggs of Barren County Kentucky knowing myself to be mortal and subject to death do make this my last Will & Testament, in manner and form following: I do give & bequeath to my beloved Wife for her support during her Natural life the plantation or land I live on containing one hundred and fourteen acres which I gave and bequeath to my son John Skaggs, to him and his heirs forever living of them at our decease is to be equally divided amongst all of my children but any stock that my son John Skaggs will raise on and above what will support out of the old stock is to be my son John Skaggs own property I do give all my house hold and kitchen furniture at my Wife Elizabeths desire my Wife and desire that it should be equally divided amongst all Children viz Rhoda Phelps Abimey Skaggs Sarah Clemens Henry Skaggs, John Skaggs Elizabeth Kelly and Syddy Skaggs I do constitute and appoint my son Henry Skaggs and Jacob Smith my Executors of this my last Will and Testament revoking all other Wills or Testaments by me hereafter made and do declare this to be my last Will and Testament, given under my hand and seal this 10 day of December 1818

In the name of the Lord Amen I John Wheeler of Barren County and State of Kentucky of sound mind and memory do acknowledge this to be my last Will and Testament made this sixth day of February in the year of our Lord one thousand eight hundred and twenty one, then after my just legal and funeral expenses is paid I give unto my first Children William, Betsy, Polly, Fanny, and Mirajah one Negro a piece a best bridle and saddle and a good bed with they are to receive when they become of age or marry

get married: then if they should increase to the number of two a piece against they are to receive them they shall have two instead of one. they shall receive a boy and girl a piece Betsy, Polly and Fanny as to be learnt to read and write William, Betsy, Polly and Fanny as to be taught the best to have choice among the Negroes and so on to the youngest which is to be valued to them as they receive them, by two disinterested men and them that receive last they shall be made equal with the rest at my Wifes death. I then I give unto my Wife Betsy Wheeler five Negroes as viz John, Elletty, Jacky, Sharrety and beamer and all my land and household furniture, and all the balance of my stock her lifetime and at her death the Negroes shall be equally divided amongst my children the land and household furniture and stock shall be sold at twelve months last and the money equally divided amongst my children I then I give to my daughter I give to them their lifetime and to the offspring of their body after them. I then I give to Rebecca Kemlow one horse best one cow and calf one bed and furniture, with was my daughter Anny in her life time and is also in his possession at this time. I then I leave my Wife Betsy Wheeler as executrix and William Wheeler Executors to my estate as witnesses my hand and seal this 6th 1821.
