 by me made and do leave this and only this to be my last will
 and testament -

Item 1st I bequeath unto my beloved wife Rebecca Stephens
 during her life and hundred and sixteen acres of land it
 being more or less where I now live, and all my household
 furniture and farming utensils three head of horses, two
 black, and a bay colt, and all my hogs and sheep and
 twelve head of cattle and after the death of my wife Re-
 becca the said land to be equally divided in eight
 equal parts between my three sons Henry John and James
 Stephens, and John Stephens is to have a gray horse and
 saddle and bridle, and James Stephens is to have a gray mare
 saddle and bridle - I give my daughter Sally one collar
 I give my daughter Rachael one collar - I give to my
 daughter Leah one collar - I give to my son Thomas
 Stephens one collar - I give to my daughter Rebecca one collar
 and I leave in my son Henry's hands forty dollars to give to my
 daughter Rebecca as he pleases provided she never goes
 back to live with John Smith and if she does he Henry is to
 return the said forty dollars or remainder to my wife
 I give my daughter Mary Emily one collar at the death of
 her mother - I appoint my wife Rebecca as my executrix
 and James and John Stephens as my co-executors
