I William Sullivan of Boone County Kentucky, being weak in body though of sound mind and understanding the uncertainty of this life being desirous to direct by a last will and Testament how my estate shall be disposed of &c. In this and I as hereby make and ordain this as my last will and Testament.

In the first place I wish all my just debts to be paid. Secondly I wish my executors hereafter named if necessary in order to pay for the land. When on to sell and dispose of such parts of it as they may think advisable in order to raise money to pay it & are a debt to be obtained & made for the balance to my wife and children. And to this end my executors are empowered & authorized to sell and convey my right to any part of said land in order to raise money to pay for the whole tract and have the balance secured by and to my wife & children.

Thirdly my wish and desire is that my estate be all kept together & presently used in raising and educating my children who are not of age. & in their support & in the support and maintenance of my wife as long as she lives & until the young children are all raised and educated & then the remains of my estate to be equally divided among all my children.

Lastly I do hereby appoint my friends Richard White and Willis Graves Executors of this my last will and Testament. In witness whereof I do hereunto set my hand and seal this 10 day of August 1833.

I Thomas Hay of the County of Boone and State of Kentucky being in right and sound mind and of good memory do hereby this tenth day of July 1833 make and execute my last will and Testament. To my very beloved wife Bertha a Hay during her natural life I give and bequeath the farm whereon I now live, it with the appurtenances thereto belonging also the household and a kitchen furniture together with the live stock Horses Hogs cattle and sheep and also my two black boys Bonilla and Joe and at her death I will the same farm with all the farming utensils to my youngest son Richard Hay. I will all my perishable property upon my wife's death with all houses and money that may be left after all my just debts are paid to my two youngest daughters Sabilla Hay & Sabilla Hay to be equally divided between them. I will that my sons Edward & Mary and Joel Perry be annually provided for out of my Estate in the best way that their situation may require. I will to my daughter Bertha a Hay one horse and a saddle worth sixty dollars. I also will to my three youngest daughters Bertha a Hay, Sabilla Hay & Sabilla Hay a certain tract of land which I have lately purchased lying in the County of Russell containing eighteen hundred and odd acres it to be equally divided among them my three eldest sons Robert Hay, White Hay and Daniel Hay and my two eldest daughters Elizabeth Higgins and Harriet Rice being already provided for. I do hereby will to them five dollars each. And I do hereby constitute and appoint Harriet & Higgins and my wife Bertha a Hay executors and executrix to this my last will and Testament (not to be removed to the County).
