I, John R. Critchelow of Artel, Breckenridge County, Kentucky, being over twenty one years of age and sound and disposing mind and memory, hereby make publish and declare this my will and testament, the provisions are as follows, to wit:

I hereby give and bequeath all my estate and property real and personal and of all kinds whatsoever as follows Ida's Wilson Children Elviro, Robert and Cassya to receive \$ 250.00 each, Ida's Pierce Children Evert, Sanford E, Lennie B and Lura R to receive \$ 100.00 each to be deposited in bank until they are age 18 years in case of death of either the other Children are to receive his portion, Dora Hinton's Children, Zetta and Gordon to receive \$ 150.00 each, Esther Stilwell's boy, Albert to receive \$ 200.00 My interest in the Bruce tract of land to be equally divided between Henry and Lettie. The said seven heirs shall have two years in which to make settlement after my death. Home tract of land and personal property to be equally divided between my other seven children, Lura, Sanford, Henry, Roland, Tom, Lettie and Nick my sister America to have her support from my estate and buring expenses to be out of same.

No one of the seven heirs shall sell his interest in said estate only to one of the other heirs.
