The home to be A.B. Cart's, the furnishings of said home, not hereinafter mentioned to remain in said house.

I give to my brother E.S. Cart, \$100.00 cash, To the heirs of my half sister, Letitia Claycomb, \$100.00 cash, To the heirs of my half Brother Adam L. Cart, \$100.00 cash, to my half sister, Malissa Flannery or her heirs \$100.00 cash.

Then after all expenses and indebtedness are paid, the remainder of my bank account to be divided equally between my two nieces Eulah Hope Haynes, and Or Ethell Cart.

I name as executor of my will, my nephew, A.B. Cart without bond,
