I, Arad A Simons, of Cloverport, Breckinridge County, Kentucky, do declare this Writing to be my last Will and Testament, hereby revoking any previous Will.

FIRST. I direct that my Executor shall pay promptly any just claims against my estate.

SECOND. I charge the Executor of my estate, hereinafter designated to carry out fully the terms of the antenuptial contract entered into by my wife and myself before our marriage. And so long and the terms thereof are in force and effect, such shamm constitute a lien upon my estate to the extent that is necessary to fulfill its terms. If it should develope that there should be an excess from the income of my estate, after satisfying the annual charge upon it imposed by said marriage contract, then such excess shall be divided among the designated legatees herein, in proportion to the interest devised to each, which legatees and their respective interests are fully set forth hereinafter.

THIRD. Subject to the provisions of said marriage contract, I give, bequeath and devise to the bodily heirs of my deceased sister, Lucinda Gregory, in fee simple and absolutely, one third of my estate, real, personal and mixed.

FOURTH. Subject to the provisions of said marriage contract I give, bequeath and devise to my sister, Isabelle Behen, in fee simple and absolutely, one third of my estate, real, personal and mixed.

FIFTH. Subject to the provisions of said marriage contract, I give, bequeath and devise to the bodily heirs of my deceased niece, Nellie White, in fee simple and absolutely, one sixth of my estate real, personal and mixed.

SIXTH. Subject to the provisions of said marriage contract, I give, bequeath and devise to my niece, Minnie Simons, in fee simple and absolutely, one sixth of my estate, real, personal and mixed.

SEVENTH. Upon the termination of said marriage contract, either by the death of my wife, or her remarriage, I direct that my estate shall then be divided among the legatees as speedily as can be done without sacrifice thereof.

EIGHTH. Having been officially connected with the Bank of Cloverport,

Cloverport, Kentucky, since its incorporation in 1903, either as a director or a director and president, it would give me pleasure to express my faith in its integrity, stability and management by nominating it to be the Executor of my estate, but being advised that the said Bank is not authorized by law to act in a fiduciary capacity, I nominate Paul Lewis, its Cashier, to be the executor of my Will, and I respectfully request the Breckinridge County Court to confirm this nomination by his appointment as such, because I personally know that he is in every way qualified and is worth of the highest trust.

I further request that my executor shall not be required to file for record an inventory or appraisement of my estate.

In Witness Whereof, I have signed my name to this Writing, after having read it and I declare that I fully understand its meaning and that such is my will in the premises, and that I acknowledged said writing to be my last Will and signed same in the presence of Claude Mercer and L.V.Chapin who, in turn signed their names hereto as attesting witnesses in my presence and in the presence of each other. CODICIL #1.

CODICIL #2.

I will and bequeath to my wife absolutely the following personal property; All surgical and medical instruments and appliances, all office furniture, all household furniture, all kitchen furniture, all beds all bedding, all books, with the exception of those pertaining to my family history, my watch, my electric fan, and all my tools, I give to my wife for her to have and do as she pleases with. My gold stone stick pin I give to Isabella Behen. To my nephew, Ira D Behen, I give the old family chest, manuscript of family history with letters, papers and old books pertaining thereto, for him to have and to complete and publish. My typewriter I give to him in payment for this work. One history of Lebanon, N.H., I give to Mrs. Manima Cory of California. Both my clocks I give to my wife. All pictures, bric-a-brac, I leave to my wife.

CODICIL #3.

I will that my wife shall have the right to use and occupy for living purposes any room or rooms she may desire in the Simons building at Cloverport, Ky., so long as she desires, and such shall be enjoyed by her free of any cost and without affecting her income and heretofore provided for.

I have signed my name to these Codicils to my will in the presence of L.V.Chapin and Paul Lewis, and they have signed their names hereto as attesting witnesses in my presence and in the presence of each other on this 30 day of March, 1916.
