This day came C.F.Heyser, who wrote the last will and testament of Sanford P.Pool, and attested the same as a witness, in connection with John McClellen and William P.Pool, at the same time taking the acknowledgement of the said Sanford P.Pool to said will, as deputy county Court Clerk of Breckinridge County, Kentucky, and produced said instrument for probate, who testified that he wrote the will as dictated by Sanford P.Pool, and that said instrument was then and there acknowledged by the said Sanford P.Pool, before said Heyser, and in the presence of the other witnesses named, and that said will was signed by mark by said Pool, in the presence of the other witnesses and in the presence of said Sanford P.Pool, at his request, after which the said attesting witness, C.F.Heyser, wrote the certificate thereto attached, on said date, which was the 29th day of August, 1883, and said Heyser stating that the said Sanford P.Pool, at said time, was sound in mind and of disposing capacity; and said instrument was further proven to be the last will and testament of said Sanford P.Pool by William Le Cannon, who attested the genuineness of the signature of William P.Pool thereto, and who procured said original will from the county clerk of Breckinridge County, Kentucky, where the same had been filed, and said Cannon being interested in the lands devised, by subsequent conveyance, applied for said original instrument and caused the instrument to be offered for probate; whereupon, after hearing all the evidence and being advised, the court adjudged said written instrument offered to be the last will and testament of said testator, Sanford P.Pool, and said instrument together with the certificate thereto appended, is now ordered to be recorded in the proper will book in the Breckinridge County Court Clerk's Office. Whereupon the same together with this certificate have been duly recorded in my office.

I, Bluford Still, of the County of Breckinridge and State of Kentucky, do make this my last Will and testament- I give and devise to my beloved wife Alice Ethel Lee in lieu of her dower, that part of the farm on which we now reside and known as the Strother tract containing 127½ acres during her natural life also 181½ acres of land known as the Shumate tract to have and to hold during her natural life so long as she remains my widow- Both the 127½ acre tract and the 181½ acre tract are to be held and controlled by her during her natural life or so long as she remains my widow- The remaining 100 acres of land known as the Anderson tract I give to my four children Minnie Still, Iva Lee Still, Ida Francis Still and Adolph Still in equal shares, I further devise that my

present wife Alice Ethel Lee shall have all the live stock house-hold goods, furniture, provisions and any other personal property which I may have at the time of my decease- at the death of my said wife the real-estate aforesaid and whatever personal property may be thereon I give and bequeath to my children by my said wife Alice Ethel Lee in equal shares. I do hereby appoint my wife Alice Ethel Lee Executrix of of this my last will without bond.

I, F.H.McGehee being of sound mind and disposing memory do make & publish this my last will & testament herein revoking all others

1st It is my will & desire that all my just debts shall be paid, then I want the marriage contract between my wife Virda McGehee & myself which was written Sept 9-1895 carried out in which I agreed to give her twenty five hundred dollars in legal currency if she should survive me as my legal widow

2nd It is my will & desire that if I should die before my wife Virda McGehee that I will to her my my house in which we now live including five lots Nos 1,2,3,4 & 5 in block No.9 in the town of Irvington Breckinridge Co Ky each lot has a Forty Foot front on Walnut Street & runs back 160 feet to an alley, to have & to hold as long as she is my legal widow, but in case she should die or marry then I want it to go to my children & their bodially heirs. I also will to my wife \$1000. to be invested by my executor in some safe bonds interest on which is for my wifes benefit principal to go to my children at her death, I also give her all the household & kitchen furniture during her life that she may want

3d I want my daughter Kitty to have \$200.00 in legal currency after which I want the ballance of my estate equally divided among all of my children but if ant of my children should be dead leaving heirs such heirs shall receive their fathers or Mother's portions

4th It is my will & wish & I do direct that my executor sell at either private or public sale all of my real or personal property & he is herein given full power & authority to sell & convey any land or personal property that I may own at my death that has not been otherwise arranged

5th It is my will & wish that my executor settle up my estate inside of two years after my death & I appoint J.M.Herndon & My son R.H.McGehee as executors of my will, this Feb 16th 1915
