

I, Carrie Hambleton Lightfoot of Cleverport, Kentucky, being of sound mind and disposing memory, make and declare this to be my last will and testament, hereby revoking any and all wills by me heretofore made.

First; I desire all my just debts to be first paid.

Second; All the balance of my property of every kind and description and wherever situated I give to my brother, Jeff D. Hambleton, of Henderson, Kentucky, in trust however for the following purposes, to wit;

All the rents, income and profits from my property shall be used for the use and support of my husband, Charles F. Lightfoot, and also so much of the principal as may be necessary for the support and comfort of my husband during his life. It being my desire that my husband be looked after and cared for even if it takes my entire estate.

Third; I hereby authorize my trustee herein named to convert my property into cash if in his judgment it would be to the best interest of my estate, and to make deeds therefor. The proceeds to be reinvested and held and used as in Item Second of this will.

Fourth; If, at the death of my husband there remains any part of my estate, I wish that part which remains to be divided equally between my brothers and sisters, and the children of such as may be dead, the children of such who are dead to take the part of their deceased parent.

Fifth; I name and appoint my brother, Jeff D. Hambleton, of Henderson, Kentucky, Trustee and Executor of this my will, and direct that any bond he may be required to give, that the premiums therefor be paid out of my estate.
