As to whether she may see fit to hold the same, to sell or will it, is left to her as she is willed all this absolutely and in fee simple forever. My said wife is also to have and to hold absolutely in her own right and to her own use and benefit to do as she please and dispose at her death as she may see fit, all of my personal property of every kind and nature, let it consist of moneys, notes, accounts, choses in action, farming implements or machinery or live stock or any other kind or species of personalty of every nature and description.

I hereby appoint my wife Sarah Eliza Davis as executrix of this my last will and testament with full power to do any and all things necessary to carrying into effect and the perfecting of the intentions of this my last will and testament, with full power to collect any and all debts that may be due my estate at my death.

1st. 4th. Power and authority is hereby given to the said John Lillard and Eliza his wife and Anna English to sell and convey any of the real property mentioned in this will that they may deem advisable to do so.

5th. I hereby request that no inventory be made of my estate, either real or personal, at my death but that the same be controlled absolutely by the beneficiaries named herein.
