(4) I bequeath to my niece, Jennie Babbage, wife of Courtney Babbage, the sum of Fifty (\$50.00) Dollars.

(5) I direct my Executor to permit Miss Jennie Warfield and Edward Beard to select the two monuments referred to in my Will.

#### Will of Wm. Brumfield

I, Wm. Brumfield of Union Star, in the County of Breckinridge and the State of Kentucky, being of sound and disposing mind and memory do make, publish and declare this to be my last will and testament, hereby revoking any and all former wills by me at any time theretofore made:

1. I bequeath to my two sons, Everitt Arthur Brumfield, and William Andrew Brumfield, my farm of eighty-five and one-half acres, lying and being in the County of Breckinridge and the State of Kentucky, to have and to hold as long as they shall live, then to revert to their heirs. If either of these shall die without issue, his share shall go to the other brother, if both shall die without issue the place shall then go to my daughter Atha Anna Brumfield, if she be living and unmarried, if married to her and her sister Mrs. Mary Ellen Treutman to theirs as long as they both live, this land shall not be divided or sold but go to their legal heirs.

2. I bequeath to my daughter, Mrs. Mary Ellen Treutman, the sum of one hundred dollars, which shall be paid by my two sons from the profits and emoluments occurring from the use of the above mentioned land. The aforesaid one hundred dollars shall be paid in full four years after my death, but may be paid in annual installments of twenty-five dollars each year:

3. I bequeath to my daughter, Atha Anna Brumfield, the right to always have a home on the above mentioned land with, and share equally with her brothers, as long as she shall remain unmarried, if she shall marry she shall relinquish all rights and title to said land, and shall receive as her part, the sum of one hundred dollars, said sum to be paid by my two sons, in annual installments of twenty five dollars until paid. I also bequeath to Atha Anna Brumfield, my daughter, one cow; and one bed and bedding, also one sewing machine and one weaving loom.

4. I bequeath to my son, William Andrew Brumfield, one horse and one shot gun.

5. All the rest, residue and remainder of my estate, real personal and mixed, I give devise and bequeath to my two sons Everitt Arthur Brumfield and William Andrew Brumfield to be shared equally.

In witness thereof, I have hereunto subscribed my name and affixed my seal this 22 day of May in the year of our Lord one thousand and seventeen.
