

WILL OF CLINT DAVIS,

I, Clint Davis, of Garfield, Breckenridge County, Kentucky, knowing the uncertainty of life and having desireous of making a different disposition of my estate, other than would be made by law if I should die intestate, do make, publish and declare this to be my last Will and Testament, hereby revoking any and all wills heretofore made by me.

I, I desire as soon as practical after my death that all my debts, including funeral expenses be paid out of my estate by my Executrix hereinafter named.

II. I hereby Give, devise and bequeath to my beloved wife, Clara Davis my farm together with all live stock, growing crops, farm machinery, including automobile, and household and kitchen furniture to be hers absolutely, except that if my said wife, Clara Davis should remarry, then one-half of the farm or the value of one-half of the farm shall go to my heirs-at-law.

III. I hereby Give, devise and bequeath to my heirs-at-law all of my cash, notes and bond, that I may have at my death, after the payment of all debts mentioned in paragraph one. I have premised my niece, Mariah J. Marshall a cow, and in the event I do not settle said premise before my death I desire that she be Given a cow, or the value of a cow, before distribution is made.

IV. I hereby appoint my wife, Clara Davis executrix of this my will and request that the court permit her to qualify as such without bond. This November 20th 1926.
