

I, D.S. Richardson, of the County of Breckinridge, State of Kentucky, being of sound mind and disposing memory, and desiring to make other disposition of my property than is made by the laws of descent of the state of Kentucky, do make this my last will and testament, hereby revoking any and all other wills that may have heretofore been made by me.

First: My Executor hereinafter named, will as soon after my death as will be convenient pay all of my just debts.

Second. To my grandson Elisha A. Richardson Jr., the son of my deceased son Elisha A. Richardson, I will the sum of Five Dollars and no more.

Third. It is my will that my beloved wife Mary E. Richardson, shall so long as she remains my widow have to her use all the balance, rest and residue of my estate of every kind nature and description real, personal and mixed and shall enjoy the ~~management~~ and income from the same to the extent of guaranteeing to her a living suitable to her station in life; but said property is to remain intact and is not to be disposed of by her unless it should become necessary so to do in order to furnish her with the necessities of life, but in that event no more is to be disposed of than is necessary to supply her with such competency.

Fourth: In the event of the remarriage or death of my wife, then all of my property of every kind nature and description, real, personal and mixed is to be divided equally among my following named children to wit: R.C.Richardson, Sarah E.Richardson, Cora A. Beard, Sue L.Milner, and Mary E.Schreiber, my said named children to share and share alike.

Fifth. It is my will that after my death that my mercantile and other business be continued and carried on in like manner as it is now, believing as I do that a continuation of the business along the same lines as now conducted will redound to the interest of all parties concerned.

Sixth. My son R.C.Richardson being conversant with all my business and thoroughly understanding the same and he being possessed of my utmost faith, and confidence as to his executive ability to carry out my intentions in every particular I do hereby appoint him as my Executor of this my last will and testament and ask that he be permitted to qualify as such without having to execute any bond.

In witness whereof, I have signed, published and declared this instrument to be my last will and testament in said county and state aforesaid, this the 20th day of June 1914.

## CODICIL.

I, B.S. Richardson, of the county of Breckinridge, and State of Kentucky do hereby make and publish, and declare this Codicil to my last will and testament, which will and testament is dated the 20th day of June 1914.

I hereby revoke and annul item Second of my said will, which said item reads as follows to wit:- "To my grandson Elisha A.Richardson Jr, the son of my deceased son: Elisha A.Richardson, I will the sum of FIVE DOLLARS and no more"; and said item as quoted above is now revoked, set aside and held for naught.

In lieu of section Second of my said will revoked herein, I hereby substitute and declare that it is my will, that my grandson Elisha A. Richardson Jr. share in my estate equally with my children, R. Richardson, Sarah E. Richardson, Cera A. Beard, Sue Lehmler and Mary E. Schreiber; that is to say that my grandson Elisha A. Richardson and each of my aforesaid named children are each to receive a one sixth of my estate, share and share alike.

grandson Elisha A.Richardson Jr; to which said Trustee the Executor of my said will subject to and under its provisions will pay to said Trustee in the settlement of my estate the share of my said grandson as set forth in this Codicil; and said Trustee is directed to hold said share for the benefit of my said grandson on time deposit in the Bank of Hardinsburg & Trust Company until my said grandson shall arrive to the age of twenty five years; at which time said trustee is directed to assign and transfer said trust fund to my said grandson with its accumulations to be his absolutely forever. Provided, ~~however~~, if said Elisha A.Richardson Jr, shall die before arriving at such age of twenty five years, leaving issue, such trust fund shall pass to and vest in such issue; but if he shall die before arriving at such age of twenty five years leaving no issue, then such trust fund shall pass to and vest in my children, R.C.Richardson, Sarah E.Richardson, Cora A. Beard, Sue LeMilner and Mary E.Schreiber share and share alike.
