

In the name of God, our Merciful Father; be it known that I, Elizabeth Murphy, being of sound mind and memory, and knowing the frail tenure of this life and that it is appointed to all once to die, do make and ordain this as my last will and testament; that is to say, I give, bequeath and dispose of my estate, both real and personal, in the manner and proportion here following;

FIRST; I give and bequeath to my daughter Lora Kingsbury the sum of one dollar to be paid to her out of the proceeds of personal property or to be paid by my daughter Annie Murphy.

SECOND. I give and bequeath to my daughter, Jennie Watkins the sum of One dollar to be paid to her out of the proceeds of personal property or to be paid by my daughter Annie Murphy.

THIRD, I give and bequeath to my daughter Annie Murphy my homestead property, Lot No. 60, with the appurtenances thereon, fronting on Third Street, Cloverport, Ky., the same deeded to me by Thomas Wilkerson and Margaret Wilkerson on the 99th day of August 1854. I also give and bequeath to my said daughter, Annie Murphy all my personal estate consisting of house hold and Kitchen furniture, beds and bedding and such other property, both real and personal as I may be possessed of at the time of my death, except a sufficiency to pay my said daughters, Lora and Jennie the sums allotted to them and my Doctor's bill and funeral expenses. A proper respect to the opinions of my family impels me to give my reasons for this my will. While my natural love goes out to all my children, yet my two daughters Lora and Jennie have had better opportunities and have been better provided for than my daughter Annie, and she, being a single woman, and a most leivable and dutiful child and having materially assisted me many times out of her personal earnings, in my dire necessity, I feel the Justice of this my act in giving her the bulk of my property as herein provided. I appoint my said daughter Annie Murphy executrix of this my will and no bond shall be required of her.
