

Will of Elizabeth Spradlin.

I, Elizabeth Spradlin, being of sound mind and disposing memory, and realizing the uncertainty of death, and desiring to make disposition of my property at my death do hereby make and publish this my last will and testament, hereby revoking all other wills made by me.

1st, It is my will that all my Just debts and funeral expenses be paid by my Executor

2nd, It is my will and I hereby direct that my executor place at my Grave a monument as near like the one I have placed at the Grave of my husband, D. T. Spradlin, as he can,

3rd I hereby will and Bequeath to Cecil Spradlin Chapin the sum one Dollar.

4th, It is my will that the house and lot that I now live, in which is the third house south of the L.H. & St. L.R.R. and on the West side of the Hardinsburg and Brandenburg road, be and is hereby Bequeathed to the Irvington, Kentucky, Baptist Church to be used by them for a parsonage, and I hereby Give the trustees of the said church the power to sell and trade for any property that might be more convenient to the Church for a parsonage, and in case at any time the church has no pastor, the house to be rented by the trustees, and the income from the rent be used for the upkeep of the house, and if any remains from the rent, the trustees can use in any way they may see fit for the General expense of the church.

5th I hereby direct that the remainder of my estate consisting of any personal property or real estate that I may die possessed of be sold by my executor, and it is my will and I do hereby Bequeath the same to the Kentucky Baptist Orphans Home at Glendale, Hardin County, Kentucky, and put in trust for them, and invested in Good securities by the trustees of said home, and the income therefrom be used for the Benefit of the said home in any way the trustees may think best, I direct my executor not to sell my clothing but send to the said home to be used by them in any way the trustees of said home may see fit.
