

KNOW ALL MEN BY THESE PRESENTS:

That I, Elmore Hunts Mercer, Being in sound mind and memory do hereby make publish and declare this to be my last Will and Testament, hereby revoking all previous wills that may have been made heretofore by me,

1. After my death I desire that all my just debts and funeral expenses be paid in full,

2. I hereby devise to my beloved wife, Nora E. Mercer all my real estate for the term of her life, provided she remains my widow,

3. At the death of my said wife Nora E. Mercer I desire and I hereby devise all of my aforesaid real estate to Eva Sadler, Kate Tanner, Eliza Tucker, Rena Mercer, Thelma Mercer and Lovell Mercer, share and share alike,

4. I desire that the court at the probate of this will should appoint an administrator with the will annexed and that such administrator be given the power to sell all my real estate owned by me at my death, after the provisions of section 2 have been fulfilled. Such administrator will then divide the proceeds of such sale among the parties equally set out in section 3

5 I bequeath to my beloved wife aforesaid all of my personal property for her life provided that she remains my widow, with power to dispose of same provided she is in need of same for her support,

6. At the death of my aforesaid wife, I desire and I hereby bequeath all of aforesaid personal property to Eva Sadler, Kate Tanner, Eliza Tucker Rena Mercer, Thelma Mercer and Lovell Mercer,

7. I desire that the court at the probate of this will should appoint an administrator with the will annexed, who may be the same person referred to in section 4, and that such administrator be given the power to sell all of my personal property owned by me at my death, after the provisions of sections 5 have been fulfilled,
