

I, Ermin Shellman of Hardinsburg, Kentucky, declare this Instrument of Writing to be my last Will and Testament.

(1) I direct my executor, hereinafter named, to pay all just debts which I may owe.

(2) I bequeath to Horace Scott Beard and Francis Beard, children of Edward Beard and Stella Scott Beard, the sum of Two Hundred (\$200.00) Dollars to each of them. This money shall be held by The Bank of Hardinsburg & Trust Company, as Trustee and invested by it, and as each of the said children becomes of age said sum of Two Hundred (\$200.00) Dollars and accumulations shall be paid to him. I further bequeath to said two children just named the large portrait of their deceased mother, Stella Scott Beard.

(3) I direct that my executor hereinafter named shall erect a granite monument not exceeding \$150.00 in cost to the memory of my father, mother and brothers whose bodies were lately transferred to the cemetery at Hardinsburg. One monument shall be erected to the memory of all and the word "Hambleton" shall be inscribed in bold letters on said monument and beneath that the names of said decedents inscribed together with the dates of their respective births and deaths. These the executor can ascertain from the old tombstones.

(4) I hereby direct my said Executor to purchase a suitable monument and place it at the grave of my deceased sister, Margaret Hambleton Beard, not to cost to exceed Fifty (\$50.00) Dollars.

(5) I hereby will and bequeath to the Methodist Episcopal Church South, of Hardinsburg, Kentucky, a sufficient sum of money to discharge the debt the said church owes in the construction of the Parsonage. This debt approximates Four Hundred and Fifty (\$450.00) Dollars, and I direct that my Executor shall forthwith liquidate said indebtedness. I further give to said Methodist Episcopal Church South my Kitchen cabinet and sideboard to be used in the Parsonage. I further direct my Executor to pay my Church dues to the end of the Conference year succeeding my death. I further will to Anna & Margaret Scott, children of Horace Scott, the sum of \$50.00 each.

(6) I bequeath to Miss Jennie Warfield the sum of One Hundred (\$100.00) Dollars and to Mrs. Jennie Kingston the sum of One Hundred and Fifty (\$150.00) Dollars, and to Arthur Scott the sum of One Hundred and Fifty (\$150.00) Dollars, and to Maggie Scott the sum of One Hundred (\$100.00) Dollars.

(7) The residue of my estate, I will, devise and bequeath to the children of my late husband, Richard Shellman; said estate to be divided equally among said children. I do this because I feel that his children should have the estate that he left me and for that reason I wish the residue of my estate to be so divided because in this way they will get back practically all of the estate that I derived from their father.

(8) I nominate The Bank of Hardinsburg and Trust Company to be Executor of my estate and I hereby clothe it with full authority to sell any property that I die possessed of at such prices and upon such terms of credit or otherwise, and in such manner, as my Executor shall deem best, and direct that it shall, as soon as practicable, after my death, convert the same into money in order to settle up my estate and make distribution thereof as herein directed, provided that no public sale thereof shall be made of any of said property.

IN TESTIMONY WHEREOF, I have signed my name to this Will after having read it carefully and I acknowledge it to be in accordance with my wishes and I have signed my name hereto in the presence of A.M.Kincheloe & Claude Mercer who witnessed my signature and the said witnesses signed their names hereto as witnesses in my presence and in the presence of each other.

I, Ermin A. Shellman, of Hardinsburg, Kentucky, declare this Writing to be a Codicil to my Will of date, January 22d, 1917.

(1) I bequeath to Arthur Scott, my nephew, One Hundred (\$100.00) Dollars in lieu of One Hundred and Fifty (\$150.00) Dollars, as bequeathed in my Will.

(2) I bequeath to L.E.Shellman the balance due me on his promissory note to me. In other words, said note is now cancelled as to the balance due thereon.

(3) My silverware, bed clothing, books, pictures and wearing apparel are not to be sold by my Executor, but ~~shall~~ such shall be divided among the members of my family, as they shall agree upon.

(4) I bequeath to my niece, Jennie Babbage, wife of Courtney Babbage, the sum of FIFTY (\$50.00) Dollars.

(5) I direct my Executor to permit Miss Johnnie Warfield and Edward Board to select the two monuments referred to in my Will.

IN TESTIMONY WHEREOF, I declare this codicil to be supplementary to my Will of January 22, 1917, and is a part thereof, which I have carefully read and fully comprehend, and I have subscribed my name hereto in the presence of Dr. A.
