

WILL.

I, George M. Barkley, of Stephensport, County of Breckenridge and State of Kentucky, being of full age and sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made.

FIRST. I desire that all my Just debts and funeral expenses be paid out of my estate as soon as can conveniently be done after the time of my decease.

SECOND. I bequeath unto my daughter, Murry Blain, wife of Percy Blain, the sum of Fifty (\$50.00) Dollars,

THIRD. I bequeath the sum of Fifty (\$50.00) Dollars for the fund known as the Minister's Aid of the Baptist Church,

FOURTH. I bequeath to the Baptist Church at Stephensport, Kentucky, the sum of Fifty (\$50.00) Dollars.

FIFTH. I will and bequeath to my wife, Bettie Barkley, half of all my personal property, remaining after my debts are paid, as hereinbefore directed, and a third interest during her natural life in any land that I may own.

The other half of my personal property I desire to be divided equally between my two children, namely, my daughter, Murray Blain, and my son, La Rue Barkley,

I devise two-thirds of all the land that I own at the time of my death to my son, La Rue Barkley, and the other one-third, which I have left to my wife, at her death is to go to him.

The farm on which I now live was purchased by me in 1886, and through error was deeded to my second wife, but was paid for by me with money which I inherited from my mother, therefore I consider that the Girl having acquired this through her mother, is the beneficiary of the value of this farm from my estate, therefore in order to make my children equal, as nearly as possible, I Give the tract of land, the title to which is in me, to my son, La Rue Barkley, however one-third to go to my wife during her life, as heretofore stated.

SIXTH. I, Make, nominate and appoint L. D. Fox of Hardinsburg, to be the executor of this my last will and testament, and I further request that no bond be required of him as such.
