I, Isaac Norton, being of sound mind and disposing memory, do hereby make and publish my last Will and Testament, to-wit:

(1) I direct that all my just debts be paid out of my estate.

(2) I give, devise and bequeath to my beloved wife, Bettie Norton the farm consisting of three tracts of land and containing about 125 acres of land, and the same now occupied by me as a homestead, during her life, with permission to cultivate and use same as she sees fit, but no timber is to be cut or removed from said farm, except what is necessary for fuel and to keep the buildings and fences on place in repair.

(3) I have heretofore made advances to my wife, Bettie Norton and to my five children, William Norton, Clint B. Norton, Mrs. Willie W. Allen, Mrs. Allie M. Ames, and Mrs. Carolina Triplett, making them all equal, I now give devise and bequeath all my remaining estate of whatever kind, character or description to be divided as follows: To my beloved wife, Bettie Norton a one-sixth (1/6), to my son William Norton a one-sixth (1/6), to my son, Clint B. Norton, a one-sixth (1/6), to my daughter Mrs. Willie W. Allen, a one-sixth (1/6), To my daughter, Mrs. Allie M. Ames, a one-sixth (1/6), and to my daughter Mrs. Carolina Triplett, a one-sixth (1/6), making my wife Bettie Norton and my five children all equal in the remainder of my estate, after paying any debts I may owe, as directed to be paid in paragraph one, and after giving my wife the farm, as set out in paragraph two.

(4) I hereby appoint my wife, Bettie Norton, and my son Clint B. Norton Executors of my estate, and request that they be not required to execute bond by the court, as such executors. In the event one of them should not desire to act, as such executor then the other may act alone.

In witness whereof, I have this day signed, published and declared this instrument as my last will and testament, in said county and state aforesaid, this the 2nd day of May, 1912.
