I have a house and lot in Hardinsburg, the lot containing two acres more or less-it is the place where I now reside and is my home. It is my desire that my husband Elijah Miller be given a home during his life, and I hereby bequeath him a home in my property during his life.

All of my property of all kinds whatsoever I give, will, and bequeath to my daughter, Gertrude Dean and her heirs, absolutely and in fee simple.

My daughter is to have control of my property after my death, but, it is my desire, as above stated, that my husband Elijah Miller shall be given a home in my house while he may live.

If my daughter Gertrude should die before my husband Elijah Miller, then I give, devise and bequeath all my property of all kinds whatsoever to her heirs, absolutely, share and share alike.

As to the household furniture I give and bequeath it to my daughter Gertrude: but my husband Elijah Miller is to have one feather bed with sheets and quilts to use during his life and at his death it shall go to my daughter Gertrude - it being my intention that he shall have the use of this bed only so long as he may live.

All other personal property of all kinds I give to my daughter, Gertrude, whom I nominate as my Executrix, and request that she qualify without bond.
