After the payment of my just debts, I give and bequeath all my estate, real, personal and mixed, unto my wife, to be held by her during her life, or so long as she shall remain my widow, with full power of disposition of real estate.

I constitute my said wife; Sarah E.Hunt, Executor of this my last will and testament, and direct that she shall be excused from giving bonds.

The first commission heretofore issued herein to take the deposition of H.S.Hunt (now Hattie S.Hunt Tumy) one of the subscribing witnesses to the codicil annexed to the last will and testament of James G.Hunt, deceased, late of this county, was on the 13th day of July, 1914, returned, duly executed and the same was filed herein.

And it also appearing to the court that E.G.Leonard one of the subscribing witnesses to said will has departed this life, thereupon on the 25th, day of July, 1914, came into open court Levi C.Goodale and Louis G.Ballauf and were duly sworn and examined in relation to the genuineness of the signature of said E.G.Leonard, now deceased, attached to said will and their testimony was reduced to writing and filed.

And it also appearing to the court that John H.Chatten the other subscribing witness to said will whose residence is now unknown, thereupon on the 25th day of July, 1914, came into open court David A.Chatten and Beatrice Chatten and were also duly sworn and examined in relation to the genuineness of the signature of said John H.Chatten now unknown, attached to said will and their testimony was also reduced to writing and filed.

And also on the 25th day of July, 1914, appeared in open court C.B.Matthews and E.P.Bradstreet and were also duly sworn and examined in relation to the mental capacity of said decedent at the time of the execution of said will and codicil thereto and their testimony was also reduced to writing and filed.

And it appearing to the court from the testimony so taken that said will and codicil thereto were duly executed and attested and that at the time of executing same the testator was of legal age sound mind and memory and not under any restraint the court now admits the said will and codicil thereto of James G.Hunt, deceased, to probate and orders the same together with the testimony so taken to be recorded according to law.

On application the court grants unto Sarah E.Hunt and Charles Judson Hunt letters testamentary under said will and codicil thereto they being named executors therein. Whereupon the said Sarah E.Hunt and Charles Judson Hunt in open court accepted said appointment and filed an estimate of the whole estate of said decedent.
