

LAST WILL AND TESTAMENT OF JAMES SHOEMATE Sr.,
I, James Shoemate, Sr., of Garfield, Breckinridge County, Kentucky, do make
publish and declare this my last will and testament.

1st. I give devise and bequeath to my wife Sarah E. Shoemate (100) hundred
acres of land lying in the County of Breckinridge and state of Kentucky, said land is
hereby described as follows: (vs) Beginning at the extreme North-west corner of my
home tract of land; thence running in southern direction or course with my line so
as to include all the buildings, dwelling, barns &c. Said land must be cut off of the
north end of said farm or my home tract for her, division line must cross said farm
or land at a point or place so as to leave this one hundred acres upon the north end
of my home tract of land. This is a portion of my home tract of land of which I now
reside and was conveyed to me by deed from Daniel Shoemate and said deed is recorded in
Deed Book R, page 8 at Hardinsburg, Ky., when said land is surveyed or run off it may
include a portion of a certain tract or survey purchased of Daniel J. and James G.
Stephens, said line is hereby ordered to be run if it does include a portion of the
Stevens survey, the deed from Stevens to me can be found in book No. Y page 233 at
Hardinsburg, Ky, said land to be and remain my wifes (Sarah E. Shoemate) land so long
as she lives or remains my widow at her death or marriage again then to revert to
my legal heirs.

SECOND. I hereby give to my wife Sarah E. Shoemate all the crop of any kind growing
upon any portion of the land I own at my death.

3rd. Also give to my wife Sarah E. Shoemate all of my personal estate consisting
of the cattle horses, hogs, sheep or any kind of stock on farming implements tools,
house-hold and kitchen furniture, all the notes. if any cash &c to include every thing
belonging to my personal estate.

4th. The remaining No. of acres of land belonging to my estate after the one
hundred acres is cut off for my wife as above directed I hereby give to my legal heirs
(equally) said land to be surveyed and the heirs of Peyton Shoemate, deceased, are to
have one third, the heirs of Mike Shoemate are to have one third of same and Mrs. Eliza
Stearman one-third of same.

I do give devise and bequeath all the rest and residue of my estate both real and
personal if any to my wife. Sarah E. Shoemate.

I hereby appoint my wife Sarah E. Shoemate my executor of this my last will and
testament and I desire that she shall not be required to give bond for the performance
of the duties of that office.
