Henninger and Robert Norton and twelve hundred and fifty dollars in land notes, also one horse, five head of cattle eight head of hogs, farming utensils house hold and kitchen furniture so long as she remains my widow (in the event that I should die first) further more be ---- known that at my wife's death I will that she be decently burried and that one hundred dollars be given to my Grand Daughter Anna Mattingly, and one hundred dollars give to my Daughter Mary. Then after all my heirs have been made equal with my son Thomas A.Mattingly he having received \$300.00 my daughter Hilda A.Henning having received \$475.00 my son Ambrose M. Mattingly having received \$120.00 my son Jessel S.Mattingly having received \$115.00 my son Marcus W.Mattingly having received \$100.00 my son John B.Mattingly having received \$100.00 my son Charles E.Mattingly having received \$100.00 my son Nathaniel N.Mattingly having received \$100.00 now in the event that the within named estate should fall short in valuation to bring up the proportionate share of each heir with Thomas A. Mattingly and Hilda A.Henning then they shall refund back to the estate in proportion to the amount that it will take to bring them all up with an equal share. This being my last will and testament revoking all former wills, I hereby appoint my wife Emma Mattingly my executrix without bond believing she will without defalcation carry out this my will to the letters
