Item 2nd. All the property, real and personal of every kind and description, where- ever situate, which I may own or have the right to dispose of at the time of my decease, I give and bequeath to my wife Nancy B.Henry the remainder of her natural life, and at her decease to be divided equally among my heirs, share and share alike, as ~~if~~ all of my heirs have been made equal to date.

Item 3rd. If at any time it becomes necessary and to the best interest of my estate, to sell any part of my estate, I hereby give the right and power to my wife Nancy B.Henry to sell and convey, by making a ~~warante~~ deed to same, and to use the proceeds as she may desire to meet her needs.
