I, John C. Jarboe, of Cloverport, Breckenridge County, Kentucky, being of full age, sound mind and disposing memory, do hereby make, publish and declare this my last will and testament in the manner following, hereby revoking any and all wills by me heretofore made.

Item first: - I direct my Executors and Trustees hereafter appointed to pay out of my estate, as soon as may be after my decease, all my just debts and my burial and testamentary expenses.

Item Second: - I give and bequeath to my beloved wife, Ardelia Jarboe all my household and kitchen furniture, wheresoever found.

Item Third: - I give, devise and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, wheresoever situated, whereof I may be seized or possessed, or to which I may be in any manner entitled, or in which I may be interested at the time of my death, unto my Executors and Trustees hereinafter named, and to their successors and assigns forever, to be held by them in trust for the use and benefit of my said wife, during such time as she remains my widow, the whole income therefrom, after paying taxes and other legal assessments and premiums on fire, lightning, or tornado insurance policies, to be paid to her during said time for her sole use and benefit.

Item Fourth: - At the death or marriage of my said wife ( which ever event shall first happen ) my whole estate shall be held in trust by my Executors and Trustees for the use and benefit of my children and the heirs of those dead, until my youngest child then living shall have reached the age of twenty-five years, the whole income therefrom to be paid to them during said time for their sole use and benefit.

Item Fifth: - At the death or marriage of my said wife ( which ever event shall first happen ) and when my youngest child then living shall have reached the age of twenty-five years, my whole estate shall be equally divided between, conveyed, distributed and paid over to, my children, or the issue of a deceased child, who shall take by representation its parents share, provided, however, that none of my real estate shall be sold during such time as my said wife remains my widow, nor after her death or remarriage.

until my youngest child then living shall have reached the age of twenty - five years .

Item Sixth :- If my real estate cannot be divided without injury to it , as a whole , when the estate shall be sold by my Executors and Trustees at a private or public sale as they think best , the real estate first being appraised by three disinterested land owners of the county , and no part of it to be sold for less than the appraised value , and in the event of said sale of real estate , I hereby authorize my Executors and Trustees to convey the same by good title , which shall be binding on my heirs and no report to be made to the courts .

Item Seven :- I have , from time to time , advanced certain sums of money to each of two sons , John Felix Jarboe , and Lander Sterett Jarboe , no part of which has been paid back to me , as will appear from an account book now kept by me , which book was formerly used in keeping the accounts of my store at Skillman , Kentucky .

It is my wish that one of my children be charged with interest on any sums of money heretofore or hereafter advanced by me to them , or to any of them ; and , in the distribution of my estate , as directed in item Fifth of my will , each of my children to whom I have advanced money or other property shall be made to account to my estate for whatever balance may be due by such child , as appears from said book at the time of my death .

Item eighth :- Having absolute confidence in the integrity and capacity of my son , John Felix Jarboe , and of my Daughter Irene Jefferson Jarboe , both of Cloverport , Breckenridge County , Kentucky , I hereby nominate and appoint them , or the survivor of them , as the Executors and Trustees , or Executor and Trustee , of this my last will and testament and request them to carry out its provisions .

I hereby request that said John Felix Jarboe and Irene Jefferson Jarboe shall be allowed to qualify and serve as Executors and Trustees of and under this , my last will , without giving any bonds or security whatsoever and that no appraisement or settlement of my estate be at any time or required .

If , by refusal to accept said trusts , by resignation , death removal , or incapacity to act , the number of Executors and Trustees shall at any time reduce to one , it is my will that one or more Trustees shall be appointed to fill such vacancies and I authorize my wife , if living and still my widow , in conjunction with those of my children who are twenty - one years of age , to appoint and nominate such new Executors and Trustees , or Executor and Trustees and in case of their neglect or refusal so to do , I refer the appointment to the Judge of the Circuit Court of Breckenridge County , Kentucky ; and such new Executors and Trustees , or Executors and Trustees , shall have and possess all and the like interest , power and discretion in and over the trust estate , as if he or they had been originally appointed and named in and by this will , except the exemption from giving bonds for the due execution of said trust .
