June 15, 1917 :

I, B.C. Dowell, of Breckenridge County of Breckenridge, State of Ky do make this my last will and testament, as follows :

FIRST, I direct that all my just debts and funeral expenses be paid, SECOND after the payment of my debts and funeral expenses, I devise and bequeath all the remainder of my property both real and personal and wherever situated to my wife, Artemisia Carter Dowell, and assigns forever - Vis ; One house and lot in the town of Bowleyville upon which we now reside, also four land notes signed by E.P. LeGrand for \$ 500 the first note of \$ 100 due and payable on Jan'y 2nd 1918, the 2nd note of \$ 100. due and payable 2nd day of Jan'y 1919, the 3rd note of \$ 150 due and payable Jan'y 2, 1920, the 4th and last note of \$ 150 due and payable Jan'y 2nd 1921 .

I further desire and do hereby appoint my said wife executrix of my estate and direct that no inventory or appraisement be had of my estate and further - more request that she be allowed to qualify without other security than her own bond .
