

## WILL OF JOHN M. FISHER

I, John M. Fisher, of Falls of Rough, Kentucky, do hereby make, substitute Publ<sup>1</sup> sh and declare this to be my last will and Testament, hereby revoking all former wills by me made.

FIRST, I Direct that no just debts, the expenses of my last illness and my funeral be paid and first out of my estate as soon as conveniently may be.

SECOND, I give, devise and bequeath all of my real estate to my brother Robert D. Fisher, of Glen Dean, Kentucky.

THIRD, I give and bequeath to Dallas Van Tress of Falls of Rough, Ky, and to my sister Elizabeth Smith of Perdesville, Kentucky, and to my sister Nancy Rodgers of Perdesville, Kentucky, and to my sister Nell Fisher Hayden of Irvington, Kentucky, each the sum of One Thousand Dollars (\$1,000.00).

FOURTH, I give devise and bequeath the rest, residue and remainder of my estate to my said brother Robert D. Fisher.

FIFTH, I hereby nominate and appoint my said brother Robert D. Fisher to be executor of this my last will and testament, and I hereby authorize him and he is given power to, if, and whenever in the settlement of my estate he may deem it advisable in his discretion, to sell the whole or any part of my property real or personal, at public or private sale and on such terms as he may deem advisable, and to make execute and deliver all deeds, instruments and other writings necessary to pass the absolute title thereto to the purchaser thereof.
