

3. If my heirs desire to continue in business may profit realized out of the business above a living is to be shared equally between Pauline and Melvin Leslie and Edith Conway, each to have one-third.

4. I desire that my body be interred in the cemetery at Mockport, Indiana, by the side of my first wife, Ada Leslie, provided that weather conditions and road conditions be such that I can reasonably be taken to Mockport. If not then I desire that I be buried in the New Cemetery in Hardinsburg, Ky. And be given an economical Christian burial.
