

EAST WILL AND TESTAMENT OF JOSEPH FLAGET CARTER.

I Joseph Flaget Carter, of Cleverport, Kentucky, being of sound mind and disposing memory, herein declare my last will and testament, hereby revoking all wills previously made by me.

I will and bequeath to my beloved wife, Isabel Catharine Carter, for the purposes hereinafter stated, all my estate both real and personal, whether now in my name or in future to fall to me.

I appoint said Isabel Catharine Carter to be the executor of this my last will and testament, requiring of her no bond nor administration through the Courts, but charging her to dispose of said belongings as follows.

After paying all my just debts, I direct that six percent (6%) of my entire estate both real and personal be paid to Rev. C. Brey, Pastor of St. Rose Church, Cleverport, Ky., or his successors in office, to be used for a catholic school in Cleverport, Ky.

The remainder of my estate I will to my wife, Isabel Catharine Carter, in trust for my children, charging her to use said estate to the best interest of herself and my children, and in the final settlement of my estate, to divide equally among my children, Barney Worland Carter, Edmund Francis Carter, Margaret Mary Carter, Bernard Celestine Carter, Thomas Anicetus Carter, Clara Modesta Carter, and Richard Floyd Carter, after charging my son Barney Worland Carter with two hundred and fifty dollars (\$250.00) and my son Edmund Francis Carter with one hundred and fifty dollars (\$150.00), which amounts these my sons have received over and above what I have given to my other children, and after paying to each of my following children, Thomas Anicetus Carter, Clara Modesta Carter and Richard Floyd Carter, a horse and saddle or the equivalent thereto, which the rest of my children have received, and which these last mentioned have not.

3rd, I hereby designate and appoint my said husband as the Executor of this my last Will and Testament without bond.
