KNOW ALL MEN BY THESE PRESENTS: That I, Sallie M. Beard, widow of Morris E. Beard, deceased, do hereby renounce the provisions of the Will of my said husband, Morris E. Beard, who died a resident of and domiciled in Hardinsburg, Kentucky, but whose death occurred in the City of Louisville, Kentucky, on the 24th day of October, 1913, and which Will was on the 27th day of October, 1913, admitted to probate by the Breckinridge County Court, and established as the last Will and Testament of said Morris E. Beard (Will recorded in Will Book No. 2 at page 222, in the Breckinridge County Court Clerk's Office); and I hereby relinquish the provisions of said Will for my benefit, and elect to take my dower and distributable share of my said husband's estate, as if no will had been made, to-wit: One-half of the personal estate and one-third of the real estate, the former absolutely, the latter for life.
