

WILL OF M.M. CUNDIFF.

I, M.M. Cundiff, of West View, County of Breckenridge, State of Kentucky being of full age and of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made.

ITEM I. I direct that all my Just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease.

ITEM II. I Give, devise and bequeath to Walter Arms, the sum of one (\$1.00) dollar, and to Albert Arms the sum of one (\$1.00) dollar, to be paid to them as soon as practicable after my decease.

ITEM III. I Give, devise and bequeath to Nettie Cundiff Smith the sum of five (\$5.00) dollars, to be paid as soon as practicable after the time of my decease.

ITEM IV. All the rest, residue and remainder of my property, of every kind and description, wheresoever situated, which I may own or have the right to dispose of at the time of my decease, I Give, bequeath and devise to my wife, Sylvia Cundiff, and to my three children, Bertha Cundiff, Sarah Eunice Cundiff and Anna Jo Cundiff, to be jointly owned by them, share and share alike.

It is my purpose in so leaving my property, that my personal estate be divided among my wife and three children one-fourth to each to be used by them for their care and support, as long as it shall last. It is my further purpose that my real estate be jointly owned by my wife and three children, and that the proceeds from same shall be used for their care and support, and it is my wish that they do not sell said real estate until the youngest child shall reach its maturity. In the event, however, that my wife, Sylvia Cundiff, should die, it is my will that the title to all the property which I have herein bequeathed to her shall be vested in my three children, Bertha Cundiff, Sarah Eunice Cundiff and Anna Jo Cundiff, to be shared by them equally.

ITEM V. I make, nominate and appoint The Bank of Hardinsburg & Trust Company to be the executor of this, my last Will and Testament.
