

I, S. S. Galloway, of Roff, Breckinridge County, Kentucky, being of full age, and sound mind and memory, but being seriously and perhaps fatally injured, do make, publish and declare this to be my last will and testament.

FIRST: I direct that all my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease.

SECOND: All the property, real and personal of every kind and description wheresoever situate, which I may own or have the right to dispose of at the time of my decease, I give, bequeath and devise to my wife, Sallie E. Galloway, absolutely and in fee simple.

Third: I direct that out of my estate thus devised to my wife, that she use sufficient funds to educate our two daughters, Golda and Velma, and to ~~much~~ enable her to accomplish this I direct that she sell a part of my land known as the north side, running a line from a beech on Twell's creek to corners of Mrs. Milt Whitworth and Mrs. M. O. Frank in my line and she is given power to sell any and all of my real estate whenever she deems it advisable and to convey the same by deed.

FOURTH: I make, nominate and appoint my wife to be executrix of this my last will and testament, and request that no bond be required of her as such, I further request that no inventory of my estate be made in so far as the same may be lawfully omitted.

I, William H. Dowell, whose post office is Union Star, Breckinridge County, Kentucky, being of sound mind and disposing memory, do make this my last will and testament, hereby revoking any and all wills by me heretofore made.

Item No. 1. I direct my executor hereinafter named, that within a reasonable time after my death, to pay all of my just debts, including my burial expenses and the cost of a modest tombstone to be erected at my grave.

Item No. 2. I will, devise and bequeath to my beloved wife, Mary E. Dowell, My home farm, the farm on which I now live and reside, said farm containing two hundred and fourteen and one-fourth (214 $\frac{1}{4}$ ) Acres, same farm bought by me from P. D. Hawkins about the year of 1909, to her, during her natural life, to use, occupy and enjoy during her lifetime, with the request that said farm be kept in reasonable good repairs, and at her death that same be sold by my executor hereinafter named and the proceeds of sale hereof be equally divided among all of my six children, and after the death of my said wife, I give to my said executor hereinafter named, power to sell and convey said property and pass a perfect title thereto.

Item No. 3. I give, devise and bequeath to my six children, share and share alike, all of my personal property of every kind and description, whersoever located, including money, notes, stock, farming implements and tools and every species of personal property, and I direct my executor hereinafter named, that within a reasonable time after my death, to convert all of my personal property into cash or money, and to divide it equally among my six children.

Item No. 4. I hereby appoint my son, Otis W. Dowell, Executor of this my last Will and testament and request the County Court of Breckinridge County to permit him to qualify without executing any bond, having faith in his honesty and integrity.
