

In the name of God, amen, I, S. W. Kasey, of Vine Grove, Hardin County, Ky., being of lawful age, sound mind and disposing memory, do make and declare this to be my last will and testament, hereby revoking all wills h. retofore made by me.

Item First. I apoint the Fidelity Trust and Safety Vault Company, of Louisville Kentucky, Executor of this my last will and testament.

Item second. I direct my Executor above named to pay all of my just debts and funeral expenses as soon after my death as it is convenient.

Item third. I direct my Executor above named within three months after my death to deliver to the President of the American Bible Society, Astor Place, New York City, a sealed package which will be found in my box in the Safety Vault, and marked President of the American Bible Society, New York City, said package to be delivered sealed as it is, into the hands of the President of said Society, contents not to be used in paying the debt of said Society. But for the distribution of King James translation of the Holy Bible, to the destitute.

Item fourth. I desire the land purchased by myself and Brother A. M. Kasey, of S. L. Moreman and Lucy, his wife, lying East and bordering on the N. N. & N. V. Railroad, and joining Mike Bennetts farm at the Southwest corner, containing eleven acres one rood, and five pearch and deeded to us on the 26th day of November 1880, by said S. L. Moreman and Lucy, his wife, also the land purchased by myself and my Brother A. M. Kasey of Dr. J. T. Selby and wife also adjoining said Mike Bennetts farm, containing sixteen acres three roods and thirty six poles and deeded to us by said Dr. J. T. Selby and wife, on the 27th day of July 1883. Also the land purchased by myself and Brother A. M. Kasey of Wm R. Smith and wife, lying on the Elizabethtown dirt road joining Henry Bewley's farm containing ninety two acres and twenty four poles and deeded to us by said Wm R. Smith and wife, on the 19th day of September 1889, less three and $\frac{1}{2}$ acres which I quit claim deeded to Early Stovall December 20th 1894 in a compromise all the land with appurtenances thereto belonging I devise to Robert Kasey (colored) and his wife, Jane during their lives with remainder in fee to their children to belong to them for their own use and benefit. No timber to be sold off of the said lands, nor lands pastured with other persons stock of any kind nor land leased nor rented to other persons nor none of the above lands to be sold deeded or willed by the said Robert Kasey nor Jane his wife, but to be divided equally among their children, Annie Jones oldest child being included, and direct my Executor if I should fail to build during my life, to build a cottage framed house on the above named lands devised to Robert Kasey and Jane his wife, at any place they may choose to cost three hundred and fifty dollars, and also a stable or barn to cost one hundred and fifty dollars, to be paid out of the income of my estate. Also I will to the said Robert Kasey (colored) all of the mules, cattle sheep hogs fowls, corn, hay, oats, wheat farming utincils, wagons, plows, hoes, reapers, rakes etc.

Item. Fifth. I direct my executor as soon as convenient after my death to sell to the highest bidder half cash the other half in six months secured by note and lien the store house known as Woods' store in Vine Grove together with the shop now occupied by George Hicks. Also a lot of lands fronting on the Elizabethtown Road Adjoining Dent Frenches lot on the East if not sold by me before my death the proceeds of same to be paid when collected half to Sparrel Alexander Kasey, and one half to Annie Dent his twin sister, Children of A. B. Kasey.

Item Sixth. I direct my Executor within six months after my death to deliver to Miss Julia B. Tandy a unsealed package containing three one thousand dollar bonds which will be found in my box in the Fidelity Safety Vault Company, Julia B. Tandy and if the said Julia B. Tandy shall die before my death the above item for her benefit is null and void.

Item Seventh. I give and devise to my neice Emma F. Kasey my home place at Vine Grove, Ky, together with all of the lands not sold on the East side of the Newport News and Mississippi Valley Railroad purchased from John H. Smith by myself and Brother A. M. Kasey with two acres fronting on the E'town and Brandenburg Road purchased from Marion Smith by myself and A. M. Kasey on which my servants house and barn stands together with six acres and one half purchased by myself from Marion Smith for a home or summer residence for herself and her mother Mary E. Raitt, during their life at their death said home and lands to be sold to the highest bidder by my Executor half cash balance in six and twelve months secured by note and lien with two good securities. The proceeds when collected at the end of twelve months to be added to my estate.

Item Eight. I Direct my Executor above named to pay to Forrest Moorman, daughter of Jenny Moorman, deceased, the interest from five one thousand dollar Louisville City or United States Government four per cent Bonds, yearly until the death of Emma F. Kasey. On the Meath of Emma F. Kasey, I direct my Executor at once to turn into the hands of said Forrest Moorman said five one thousand dollars bonds named above to be used by her as she may deed best, but should said Forrest Moorman die before the said Emma F. Kasey leaving no lawful issue said bonds are to be still remain in my estate.

Item Ninth. All the rest and residue of my estate including my United States and City of Louisville and other bonds, I bequeath and devise to the Fidelity Trust and Safety Vault Company of Louisville, Ky., in Trust for my neice Emma F. Kasey for life and her children after her death should she have any. The said Trustee shall pay all the taxes and repairs on the real and personal estate not including the farm devised to Robert Kasey (col'd) during the life time of the life tenant and shall cut of the income from the estate pay to the said Emma F. Kasey one hundred dollars \$100.00 pr month for the support of herself and children should she have any, and also the support of her mother Mary E. Raitt, and should the said Emma F. Kasey die before her mother, my Executor above named is directed to pay to Mary E. Raitt fifty dollars \$50.00 pr month from the death of Emma F. Kasey until her death, and the said Emma F. Kasey shall have the right to use and occupy as a home for herself and family the house and lot and cottage in Cloverport, Kentucky purchased by my Brother A. M. Kasey and myself of Owen Raitt and wife subject to their life estate during their lives.

Item Tenth. After the payment of said taxes and expenses and one hundred (\$100) dollars pr month to Emma F. Kasey, or if the said Emma F. Kasey should die before her mother fifty dollars pr month to Mary E. Raitt until her death, all of the income the remains from my estate shall be invested in United States or Louisville City Bonds and Added to the principal of my estate But in case their should be any extra expense on the property at Colverport caused by fire, storm wear or other casualty such loss shall be made good out of the surplus income of my estate.

Item Eleventh: If my said neice Emma F. Kasey should die leaving no children or lawful issue surviving her, or if such child or children should die leaving no lawful issue surviving the Fidelity Trust and Safety Vault Company, Louisville, Ky, for the said Emma F. Kasey and her heirs to the Fidelity Trust and Safety Vault Company, Louisville, Ky. (my executor) to be held by them as an Endowment after the annual expenses, & managing and attending to said fund by my executor have been paid, at once to be paid to the said Bible Society summa annually or annually as it may become due. Said interest to be used by the said Bible Society not in paying the debt of said Society made heretofore, but in distributing the Bible or Word of God to the destitute of the Earth and in case said Bible Society should fail or become bankrupt or cease to work then in such a case all of the above endowment shall revert back to my legal heirs. As a codicil to the foregoing Will. I, will and bequeath to A. R. Morris of Big Spring, Breckinridge County, a lot of land in the town of Big Spring conveyed to my Brother A. M. Kasey by Santford Leslie and wife and bounded as follows:

Beginning at a stone near the sink of the spring, thence N. 10 E. two poles 8 links to a stone on the side of the road, thence W. two poles 18 links to a stone on the street; thence S. 19 W two poles and five feet to a stone; thence to the beginning.

This land lies in the County aforesaid and is recorded in the clerks office in Hardinsburg, Ky., this the 3rd day of March 1894.
