I, Thomas Holmes of Breckinridge County Kentucky, being of sound mind and memory do make and declare this to be my last will and testament, to-wit;

First. I will all the property that I may own at my death to my two boy Courtland Holmes and Walden Holmes one half to each.

Second. I appoint W.S.Holmes executor of this will and hereby empower him to sell any or all of my property both real or personal, either at private or public sale. He is hereby empowered to convey by deed any real estate I may own, at the time of my death if in his judgment it should be necessary for the good of the beneficiaries of this will.

Third. I direct that he, my executor shall use the money or property for the good of my children and direct that they be educated and trained into good and useful citizens.

Fourth. I hereby appoint W.S.Holmes of Butler County as guardian to my two boys named in the first section of this will and direct that he shall qualify and act as executor and guardian as set out herein without being required to execute bond for said trust.

Fifth. I direct that he shall make an inventory of all property that may come to his hands and report it to the County Court of the County of my residence or the County of his residence whichever should be most convenient.
