KNOW ALL MEN BY THESE PRESENTS: that I, Thomas J. Jolly, being of sound mind and disposing memory, do hereby make my last will and testament, revoking all others which may have been heretofore made by me, after all my just debts have been paid.

1st. I bequeath to my beloved wife Amanda L. Jolly the entire use and control of my home place and all my personal property, during her natural life.

2nd Whereas, I have already given to my children, Sallie J. Cain, Rob. M. Jolly, and W. C. Jolly, the sum of Two Thousand (\$2000.00) Dollars each, now, I make my daughter Blanche Jolly equal with them, I bequeath to her the like sum of Two Thousand (\$2000.00) Dollars, and for devoted care and love for myself and wife, I bequeath an additional sum of Five Hundred (\$500.00) Dollars to be paid to her out of the proceeds of the land that I may leave at my death or the death of my wife Amanda L. Jolly or in lieu of this if my daughter Blanche, so desires, I will and bequeath to her that part of my farm, which would lie East of a line running North and South from Chas Blanford's line to the line of W. C. Jolly, said line to run so that the West end of my old dwelling house will be in said line.

I also bequeath to my daughter, Blanche, My Piano.

3rd. I will and bequeath to my grandson Thomas J. Jolly, a certain tract of land beginning at a double oak in W. C. Jolly's line 30 yards West of his barn; thence South 60 poles to a pile of rock's at the East edge of the saw mill pond; thence west 25 poles to the Guston road; thence North with said road to W. C. Jolly's line; thence with said line East to the beginning, containing eight acres, more or less.

4th. I hereby appoint and empower Walter J. Piggott, as Executor of my estate, at the death of my wife, Amanda L. Jolly, or at my death if I shall survive her, who is to have full power to sell and pass title to all the real estate I may die possessed of, with the exceptions of the land I have bequeathed to my daughter Blanche, should she choose land, and I further will that he is to have full power to sell and convey at any time with the consent of my wife and daughter Blanche, and that the proceeds of the sale of the rest of my property be equally divided between my lawful heirs, but before this is done, I authorize my executor to place memorial stones at the head of the graves of my wife, Amanda L. Jolly, and myself.

C O D I C I L.
