

Will of William H. Bowmer

I, William H. Bowmer, of Cloverport, Kentucky, being of sound mind and disposing memory make this my last will and testament:

1st. I desire all my just debts and Funeral Expenses paid.

2nd. I give to each of my Six Children, Namely; Nellie Burks, Catherine Sherman, Wm S. Bowmer, Margarette Minary, Elizabeth Atkinson, and Marion Moorman, the sum of Eight Thousand Dollars \$8000.00 each to be paid them as soon after my death as my Executrix can conveniently do so - I recommend the above amounts be paid them as far as is convenient in securities at the Market value at the time of settlement.

3rd. It is my wish and desire that the amounts received by my Five Daughters namely; Nellie Burks, Catherine Sherman, Margarette Minary, Elizabeth Atkinson and Marion Moorman be held and controlled by themselves, and kept invested in good and sound interest bearing securities, unless they wish to invest a portion of it in a home.

4th. I give to my grand son Wm Bowmer Burks, my watch and Chain

5th. All the remainder of my Estate, both real and Personal and mixed, I devise and bequeath to my beloved wife Margarette Sterett Bowmer in fee for her use and benefit during her natural life.

6th. I nominate and appoint my beloved wife Margarette Sterett Bowmer Executrix of my Estate and Request that she be allowed to qualify as such without Bond, and not be required to file a schedule of assets of my estate or make any future settlements with the court whatever. I also empower her to sell and convey any real estate that I may own or have an interest in.

7th I request that my son Wm S. Bowmer, assist his mother - my beloved wife - in the General Management of my estate, and for her to make her a reasonable allowance for his services.
