eventually return the money spent on it and if my heirs can possess their souls in patience and my Executor will hold it for a few years- paying the taxes- at least until they are satisfied there is nothing in it- I shall be only too glad to have them do so- If it should pay out (\$3500.00) keep as long as it is profitable and divide the proceeds equally between the families of my (5) five deceased brothers and Bertha H. McDonald.

If Appalonia is not surviving at the division, her part reverts to the estate and given to the other heirs.

If this does not meet the approval of my heirs, dispose of it as best you can and divide the proceeds amongst all.
