I, Emma F. Mattingly, of Breckinridge County, Kentucky, being of sound mind and disposing memory, do hereby make, publish, and declare this writing to be my last Will and Testament, and I hereby revoke all other wills, codicils and papers of a testamentary character heretofore made by me.

ITEM I. Mattingly, of Fayette County, Kentucky, in fee simple absolute; during the life of my husband, I hereby give him the express power and authority to use, sell, convey, assign, lease, dispose, encumber or mortgage so much thereof, even to the extent of exhausting the whole of said estate, as he shall in his sole discretion, without the advice or consent of any person or tribunal, deem necessary for his maintenance, comfort, happiness and support, and without liability upon any vendee, grantee, assignee, transferee, mortgagee, lessee or other person to look to the application of the proceeds; but, provided, however that if my said husband predeceases me or if he and I die as

the result of the same accident or other casualty, under circumstances from which it would be impossible to determine which one survived the other, then, and in any of these events, I give, devise and bequeath the whole of my said net estate to my son, Jack F. Mattingly, of Fayette County, Kentucky, in fee simple absolute.

ITEM III. I hereby nominate and appoint my husband, Alfred R. Mattingly, of Breckinridge County, Kentucky, Executor of this my last Will and Testament, and I request and direct that he be permitted to qualify as such without surety upon his bond. If my husband predeceases me or is unable or unwilling to serve as the Executor of estate, then and in any of these events, I nominate and appoint my son, Jack F. Mattingly, Executor hereunder, and I request and direct that he be permitted to qualify as such without surety upon his bond.

For the purpose of aiding my Executor in the administration and settlement of my estate, I hereby give and grant to him the unqualified power and authority to sell, convey, assign, transfer, mortgage, encumber and lease my properties, or any part or portion thereof, at such time or times and manner and upon such terms and conditions as he may deem to be for the best interest of my estate and the beneficiaries thereof, without the authorization, consent or approval of any other person or tribunal, and without liability upon any vendee, grantee, assignee, transferee, mortgagee, lessee, or other person to look to the application of the proceeds.
