I

FIRST PARTY having arrived at an advanced age and being in need of someone to whom she can look for care, aid, assistance and support, hereby enters into the AGREEMENT OF SUPPORT with SECOND PARTY, and hereby executes the following LAST WILL AND TESTAMENT in recognition of the fact that SECOND PARTY has heretofore, and for a great many years prior to this time, been of marked assistance to FIRST PARTY in providing her material aid, comfort and support during this the latter period in her life.

II

FIRST PARTY hereby revokes all former wills by her made, and appoints SECOND PARTY executor of her last will and testament, to serve without bond.

III

FIRST PARTY directs that all of her just debts be paid as soon after her death as conveniently may be.

IV

FIRST PARTY directs that her funeral and burial arrangements be made by and through the Max H. Churchill Funeral Home of Murray, Kentucky, and that she be buried in Calloway County, Kentucky, in the Friendship Church Cemetery.

V

FIRST PARTY next directs that SECOND PARTY be paid the sum of One Thousand Seven Hundred Ninety-two Dollars and eighty cents (\$1,792.80) as reimbursement for and in consideration of SECOND PARTY'S payment of One Thousand Three Hundred Ninety-two Dollars and eighty cents (\$1,392.80) to the Bank of Murray, Murray, Kentucky on November 5, 1969, in full satisfaction of a promissory note executed by FIRST PARTY in favor of said bank in the original sum of Two Thousand Dollars and no cents (\$2,000.00), and SECOND PARTY'S deposit in said bank of Four Hundred Dollars and no cents (\$400.00) in behalf of FIRST PARTY to cover various and miscellaneous expenses and bills incurred by said FIRST PARTY.

VI

FIRST PARTY next directs that SECOND PARTY receive and be given an amount equal to the amount expended by said SECOND PARTY in providing support, care and maintenance for FIRST PARTY: this devise being made in consideration of and as reimbursement for these expenditures.

VII

FIRST PARTY next directs that the remainder of her estate, both real and personal, is hereby devised and bequeathed to SECOND PARTY; all said property shall be in return for the following consideration, covenants and things to be done by said SECOND PARTY, SECOND PARTY in consideration of this bequest and devise hereby agrees to care for, maintain and support FIRST PARTY during the balance of her life, to do everything within his power to provide for her present and future comfort, and to see that she is not only provided with a proper home during her lifetime, but that at her decease she also be given a proper burial and interment in accordance with her wishes as stated above.

VIII
