Miles, Lee, Johnson, Ed. and Eliza Lee after they are out for what they have received out of the estate. It is my desire that my wife Elizabeth and my son Wm. Lee shall be left my Executors in this my last will and testament: as witness hereunto set my hand and affixed my seal this twenty-first day of March eighteen hundred and twenty-eight.
