In the name of God amen Nathan Miley Son of Rutledge County and State of Kentucky, King of a sound & differing mind and memory do make and ordain this in my last Will and Testament, Testing all & my last intention made by me in the first place it is my will and desire that my Executors hereafter to be named do sell for the best price that can be had at Publict Sale all my personal property (excepting my Negro) containing cattle sheep &c. and out of the proceeds thereof to pay all my last debts -

Item I give and devise to my son Matt Miley a Negro boy named Nace being the same boy that was given to Sam William (who is now dead) and who died without issue) to him and his heirs forever -

Item It is also my will and desire that my Executors shall furnish to my said son Matt and his heirs all the cattle and furniture which I give to him his heirs forever -

Item I give and devise to my daughter Polly Miley Twenty five dollars to buy her a saddle the same money to be paid out of the money arising from the sale of my personal estate -

Item I give and devise to my daughter Sally Summery Rose and her children viz my daughter Benjamin Chandler and the further increase of said Rose and the said girl viz to her her heirs forever in full of her part of my Estate - and where I have given to my daughter Polly Miley a Negro man named Nace of the price of one hundred and twenty five pounds to my daughter Elizabeth Summery a Negro boy named Jory at the price of twenty five pounds - to my son Richard Miley boy named Nance

at the price of forty pounds. To my daughter Polly Miley a Negro boy named Nace at the price of fifty pounds. I therefore direct my Executors to sell to my daughter Elizabeth Summery a Negro or Negroes of the value thereof added to the twenty five pounds shall be just to the value of the Negro given to my daughter (Polly) Miley. To my son Richard Miley a Negro or Negroes so that the value thereof added to the forty pounds shall be equal to the said sum of One Hundred and twenty pounds. And to my daughter Sally Miley a Negro or Negroes so that the value thereof added to the fifty pounds shall be equal to the said sum of One Hundred and twenty pounds which I give to them and their heirs forever. And be it also known that my Executors shall sell to my sons Nathan and Walter who have each received Negroes at the price of fifty five pounds a Negro or Negroes of the value thereof shall be equal to One Hundred and twenty pounds. Having heretofore given to my son Moses One Hundred acres of land and two small Negroes Maudie and Daniel it is my will and desire that the same shall be in full of any claim which he may have on my Estate as far as is hereafter mentioned

Having also given to Joseph Brooks who married my daughter Rebecca two Negroes David Henry and Reuben at the price of one hundred and twenty pounds it is my will and desire that said Brooks shall pay to the heirs equally whatever sum he may receive or have received above his Equal Share -

Item It is my will and desire that my son Matt shall have a cow to be taken by him out of my stock of cattle -

It is also my will and desire that my Negroes Ben & David shall be sold but shall have the liberty of choosing their masters within my own family connections

Item It is my will and desire that after the allotment made of the Negroes to be made by my Executors as mentioned in this Will that the balance of the Negroes and money arising from the sale of my personal property & Negroes as herein mentioned shall be divided between my children Elizabeth Summery wife of William Summery Polly Miley Richard Miley Sally Miley Nathan Miley Rebecca Brooks & Matt Miley pay my son Moses five dollars only of said money and to my daughter Sally Summery five dollars which I give to them and their heirs forever and to my son Richard Miley and my daughter Elizabeth of this my last Will and Testament In testimony
